### **STATEMENT OF THE CASES**

In **Case No. 24823** Applicant requests a one-year extension of time, until October 20, 2025, to commence drilling the well authorized by Order No. R-22927. The Division issued Order No. R-22927 in Case No. 23759 on October 20, 2023, which: approved a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 S/2 of Sections 35 and 36, Township 19 South, Range 29 East, Eddy County, New Mexico; pooled all uncommitted interests within the Third Bone Spring interval of the Bone Spring Formation underlying the unit; dedicated the unit to the **Silver Bar 35-36 Fed State Com 133H** well; and designated Applicant as operator of the unit.

In **Case No. 24824**, Applicant requests a one-year extension of time, until October 20, 2025, to commence drilling the well authorized by Order No. R-22928. The Division issued Order No. R-22928 in Case No. 23760 on October 20, 2023, which: approved a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2 S/2 of Sections 35 and 36, Township 19 South, Range 29 East, Eddy County, New Mexico; pooled all uncommitted interests within the Third Bone Spring interval of the Bone Spring Formation underlying the unit; dedicated the unit to the **Silver Bar 35-36 Fed State Com 134H** well; and designated Applicant as operator of the unit.

In **Case No. 24825**, Applicant requests a one-year extension of time, until January 10, 2026, to commence drilling the well authorized by Order No. R-23000. The Division issued Order No. R-23000 in Case No. 23925 on January, 10 2024, which: approved a 640-acre, more or less, standard horizontal spacing unit comprised of the S/2 of Sections 35 and 36, Township 19 South, Range 29 East, Eddy County, New Mexico; pooled all uncommitted interests within the Wolfcamp

Formation underlying the unit; dedicated the unit to the **Silver Bar 35-36 Fed State Com 202H** well; and designated Applicant as operator of the unit.

Good cause exists for the requested one-year extension because Applicant's ability to commence drilling the wells has been impacted by changes in its development plan and the need to co-develop this unit with offset acreage to prevent waste. Co-development reduces the risk of parent-child effects and also reduces drilling and completion costs by avoiding the need to dispatch multiple teams at different times.
