**PERMIAN RESOURCES OPERATING, LLC'S  
UNOPPOSED MOTION TO VACATE ORDER NO. R-22997**

Permian Resources Operating, LLC ("Permian Resources"), by and through undersigned counsel, requests that the Oil Conservation Division ("Division") vacate Order No. R-22997. As grounds therefore, Permian Resources states the following.

1. On October 3, 2023, Permian Resources filed its application to pool uncommitted interests in the Wolfcamp formation underlying a 640-acre, more or less, horizontal spacing unit, comprised of the N/2 of Sections 35 and 36, Township 19 South, Range 29 East, Eddy County, New Mexico ("Unit").
2. Permian Resources requested that the Unit be dedicated to the Ironhorse 35-36 Fed State #200H and Ironhorse 35-36 Fed State #201H wells ("Wells").
3. A hearing was held on November 2, 2023, and after considering the testimony, evidence, and recommendation of the Hearing Examiner, the Division entered Order No. R-22997 on January 10, 2024, which designated Permian Resources as operator of the Wells and the Unit.
4. Due to changes in Permian Resource's development plan, Permian Resources no longer seeks to pool uncommitted interests pursuant to Order No. R-22997. Instead, Permian Resources will develop this acreage using two 320-acre units, as provided in Permian Resources' pending Case Nos. 24818 and 24819.

5. Permian Resources therefore requests that the Division vacate Order No. R-22997.

6. Counsel for Northern Oil & Gas and BCP Resources, LLC were contacted and do not oppose this motion.

WHEREFORE, Permian Resources requests that the Division enter an order vacating Order No. R-22997.
