The Unit will be dedicated to the **Taipan 21 Fed Com 131H** well,

which will be drilled from a surface hole location in the SE/4 NE/4 (Unit H) of Section 20 to a bottom hole location in the NE/4 NE/4 (Unit A) of Section 22.

In **Case No. 25061**, Permian Resources applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2 N/2 of Sections 21 and 22, Township 20 South, Range 28 East, Eddy County, New Mexico.
