Permian Resources seeks to dedicate the unit to the **Anaconda Federal Com 111H** well, which will produce from a first take point in the NW/4 NW/4 (Unit D) of Section 11 to a last take point in the SW/4 SW/4 (Unit M) of Section 14. Due to a depth severance in the unit, Applicant seeks to pool uncommitted interests from the top of the First Bone Spring interval to the base of the First Bone Spring interval at a stratigraphic equivalent of approximately 9,675' TVD as shown on the Mahaffey Arc Federal #001 (API # 30-025-01735) well log.

In **Case No. 24934**, Permian Resources applies for an order pooling all uncommitted interests in the First Bone Spring interval of the Bone Spring formation underlying a 320-acre, more or less, standard, horizontal spacing unit comprised of the E/2 W/2 of Sections 11 and 14, Township 20 South, Range 33 East, Lea County, New Mexico. In **Case No. 24937**, Permian Resources applies for an order pooling all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the W/2 W/2 of Sections 11 and 14, Township 20 South, Range 33 East, Lea County, New Mexico. Permian Resources seeks to dedicate the unit to the **Anaconda Federal Com 201H** well, which will produce from a first take point in the NW/4 NW/4 (Unit D) of Section 11 to a last take point in the SW/4 SW/4 (Unit M) of Section 14.

In **Case No. 24938**, Permian Resources applies for an order pooling all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the E/2 W/2 of Sections 11 and 14, Township 20 South, Range 33 East, Lea County, New Mexico. Permian Resources seeks to dedicate the unit to the **Anaconda Federal Com 202H** well, which will produce from a first take point in the NE/4 NW/4 (Unit C) of Section 11 to a last take point in the SE/4 SW/4 (Unit N) of Section 14.

The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Applicant as operator of the units and wells, and a 200% charge for the risk involved in drilling and completing the wells.
