**APPLICANT'S STATEMENT OF THE CASE**

In Case No. 25135, Devon seeks to amend Order No. R-23075 in order to allow a one-year extension of the well commencement deadline. In order to show good cause for this request, Devon states the following: (1) Devon is in good standing under the state-wide rules and regulations with respect to Order No. R-23075; (2) Devon has made progress toward the development of the unit

since issuance of the Order by working to schedule a drilling rig, among other efforts; and (3) while facing the approaching one-year deadline, Devon has experienced unanticipated delays in securing a rig for the commencement of drilling. As a result, Devon is respectfully requesting that an extension of time for the drilling commencement date be granted to ensure that rig can be secured without the unnecessary rush to meet the impending deadline.

Under the original Order, Devon would be required to commence drilling by February 28, 2025; and therefore, Devon is asking for the deadline to commence drilling to be extended for a year, to February 28, 2026, thereby affording Devon the opportunity to continue its development of the unit without interruption.
