APPLICANT’S STATEMENT OF THE CASE

In Case No. 25152, WPX seeks an order pooling all uncommitted mineral interests in the Bone Spring formation, designated as an oil pool, underlying a standard 769.91-acre, more or less, spacing unit comprised of the E/2 of Sections 23, 26 and 35, Township 26 South, Range 30 East, NMPM, Eddy County, New Mexico.

WPX proposes and dedicates to the HSU the **Ross Draw 35-26-23 Fed Com 324H Well**, **Ross Draw 35-26-23 Fed Com 325H Well**, **Ross Draw 35-26-23 Fed Com 335H Well**, and the **Ross Draw 35-26-23 Fed Com 336H Well**, as the initial wells, to be drilled to a sufficient depth to test the Bone Spring formation.

The **Ross Draw 35-26-23 Fed Com 324H Well**, an oil well, will be horizontally drilled from a surface location in Lot 1 of Section 35 to a bottom hole location in the NW/4 NE/4 (Unit B) of Section 23.

The **Ross Draw 35-26-23 Fed Com 325H Well**, an oil well, will be horizontally drilled from a surface location in Lot 1 of Section 35 to a bottom hole location in the NE/4 NE/4 (Unit A) of Section 23. The **Ross Draw 35-26-23 Fed Com 325H Well** is a proximity well, positioned so the unit can include proximity tracts, thereby incorporating the W/2 E/2 of Section 23, 26, and 35.

The **Ross Draw 35-26-23 Fed Com 335H Well**, an oil well, will be horizontally drilled from a surface location in Lot 1 of Section 35 to a bottom hole location in the NE/4 NE/4 (Unit A) of Section 23.

The **Ross Draw 35-26-23 Fed Com 336H Well**, an oil well, will be horizontally drilled from a surface location in Lot 1 of Section 35 to a bottom hole location in the NE/4 NE/4 (Unit A) of Section 23.

All the proposed wells herein are orthodox in location, and their take points and completed intervals comply with setback requirements under statewide rules.
