## **APPLICANT:**

In Case No. 25216, Texas Standard seeks an order from the Division pooling all uncommitted mineral interests within a 320-acre, more or less, Pennsylvanian Shale horizontal spacing unit comprised of the W/2SE/4 of Section 34, Township 16 South, Range 36 East, and the W/2E/2 of Section 3 and the W/2NE/4 of Section 10, Township 17 South, Range 36 East, N.M.P.M., Lea County, New Mexico. This spacing unit will be dedicated to the **Bulldog State** #1H well, to be horizontally drilled with a proposed first take point in the SW/4SE/4 (Unit G) of Section 10, Township 17 South, Range 36 East, to a bottom hole location in the NW/4SE/4 (Unit J) of Section 34, Township 16 South, Range 36 East. The producing area for the well is expected to be orthodox. Also to be considered will be the cost of drilling and completing said well, the allocation of these costs as well as the actual operating costs and charges for supervision. designation of Texas Standard Operating NM LLC as operator of the well, and a 200% charge for risk involved in drilling said well.
