APPLICANT'S STATEMENT OF THE CASE

Under **Case No. 25229**, Permian seeks an order pooling all uncommitted interests in the Bone Spring formation (Quail Ridge; Bone Spring South [50461]) underlying a standard 320-acre,

more or less, horizontal well spacing unit comprised of the W/2 of Section 10, Township 20 South, Range 34 East, NMPM, Lea County, New Mexico, and initially dedicate the unit to the proposed **Riddler 10 Fed Com #131H** “U-Turn” (API No. 30-025-53819) well, to be horizontally drilled from a surface location in the NW/4 NW/4 (Unit D) of Section 10, a first take point in the NW/4 NW/4 (Unit D) of Section 10 and a last take point in the NE/4 NW/4 (Unit C) of Section 10.

Under **Case No. 25232**, Permian seeks an order pooling all uncommitted interests in the Wolfcamp formation (WC-025 G-09 S203402O; Wolfcamp [98276]) underlying a standard 320-acre, more or less, horizontal well spacing unit comprised of the W/2 of Section 10, Township 20 South, Range 34 East, NMPM, Lea County, New Mexico, and initially dedicate the unit to the proposed **Riddler 10 Fed Com #201H** “U-Turn” well, to be horizontally drilled from a surface location in the NW/4 NW/4 (Unit D) of Section 10, a first take point in the NW/4 NW/4 (Unit D) of Section 10 and a last take point in the NE/4 NW/4 (Unit C) of Section 10.

The completed interval for these wells will comply with statewide setbacks. Applicant has sought and been unable to obtain voluntary agreement for the development of these lands from all interest owners in the subject spacing unit.
