APPLICANT'S STATEMENT OF THE CASE

Under **Case No. 25288**, Mewbourne seeks an order pooling all uncommitted interests in a non-standard 1,920-acre, more or less, horizontal well spacing unit in the Bone Spring formation (PEARL; Bone Spring, EAST [49690]) underlying All of Sections 8, 17, and 20, Township 19 South, Range 36 East, NMPM, Lea County, New Mexico. Mewbourne seeks to initially dedicate the unit to the proposed **High Sea 8/20 Fed Com #522H** well, with a surface location in the SW/4 SE/4 (Unit O) of Section 5 and a bottom hole location in the SW/4 SW/4 (Unit M) of Section 20; **High Sea 8/20 Fed Com #524H** well, with a surface location in the SW/4 SE/4 (Unit O) of Section 20;

5 and a bottom hole location in the SE/4 SW/4 (Unit N) of Section 20; **High Sea 8/20 Fed Com #526H** well, with a surface location in the SW/4 SE/4 (Unit O) of Section 5 and a bottom hole location in the SW/4 SE/4 (Unit O) of Section 20; and **High Sea 8/20 Fed Com #528H** well, with a surface location in the SW/4 SE/4 (Unit O) of Section 5 and a bottom hole location in the SE/4 SE/4 (Unit P) of Section 20.

Under Case No. 25289, Mewbourne seeks an order pooling all uncommitted interests in a non-standard 1,921.96-acre, more or less, horizontal well spacing unit in the Bone Spring formation (WC-025 G-07 S193513B; Bone Spring [97926]) underlying Lots 1-4, the S/2 N/2 and S/2 (All equivalent) of irregular Section 5, Township 19 South, Range 36 East, and All of Sections 29 and 32, Township 18 South, Range 36 East, NMPM, Lea County, New Mexico. Mewbourne seeks to initially dedicate the unit to the proposed Worlds End 5/29 State Com #522H well, with a surface location in the SW/4 SE/4 (Unit O) of irregular Section 5, T19S-R36E, and a bottom hole location in the NW/4 NW/4 (Unit D) of Section 29, T18S-R36E; Worlds End 5/29 State Com #524H well, with a surface location in the SW/4 SE/4 (Unit O) of irregular Section 5, T19S-R36E, and a bottom hole location in the NE/4 NW/4 (Unit C) of Section 29, T18S-R36E; Worlds End 5/29 State Com #526H well, with a surface location in the SW/4 SE/4 (Unit O) of irregular Section 5, T19S-R36E, and a bottom hole location in the NW/4 NE/4 (Unit B) of Section 29, T18S-R36E; and Worlds End 5/29 State Com #528H well, with a surface location in the SW/4 SE/4 (Unit O) of irregular Section 5, T19SR36E, and a bottom hole location in the NE/4 NE/4 (Unit A) of Section 29, T18S-R36E.

The completed interval for each well will comply with statewide setbacks for oil wells. Mewbourne will file separately for administrative approval of the non-standard horizontal spacing unit. Mewbourne has sought but been unable to obtain voluntary agreement for the development of these lands from all mineral interest owners in the subject acreage.
