**UNOPPOSED MOTION TO AMEND PRE-HEARING ORDER**

MRC Permian Company ("MRC") moves to amend the Pre-Hearing Order, setting certain of the above captioned cases for a contested hearing on April 29, 2025, to drop certain cases that MRC dismissed and add recently filed cases by MRC to the Pre-Hearing Order. In support, MRC states:

1. On April 2, 2025, MRC filed a notice of dismissal of Case Nos. 25170, 25171, 25174 and 25175, and replaced these applications by filing Case Nos. 25304 and 25305.
2. Thus, to avoid separate contested hearings for the same Subject Acreage, the January 23, 2025 Pre-Hearing Order should be amended to dismiss MRC's Case Nos. 25170, 25171, 25174 and 25175 and add Case Nos. 25304 and 25305 to the Pre-Hearing Order.
3. No party opposes this motion.
