As grounds for dismissal, Permian Resources states that it has reached an agreement with MRC Permian Company ("MRC") to resolve their competing cases, and that MRC is simultaneously dismissing Case Nos. 25169, 25172, 25173, 25176-25180, and 25304-25305.

These matters are set for a contested hearing on April 29, 2025. With the dismissal of the competing applications, no hearing is necessary.
