STATEMENT OF THE CASE

In Case No. 25308, Applicant applies for an order pooling all uncommitted interests in the Second Bone Spring interval of the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the W/2 W/2 of Sections 27 and 22, Township 22 South, Range 35 East, Lea County, New Mexico. The Unit will be dedicated to the Bridge State Unit 27 501H well, which will be drilled from a surface hole location in the SE/4 SW/4 (Unit N) of Section 27 to a bottom hole location in the NW/4 NW/4 (Unit D) of Section 22.

In Case No. 25309, Applicant applies for an order pooling all uncommitted interests in the Second Bone Spring interval of the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the E/2 W/2 of Sections 27 and 22, Township 22 South, Range 35 East, Lea County, New Mexico. The Unit will be dedicated to the **Bridge State** Unit 27 502H well, which will be drilled from a surface hole location in the SE/4 SW/4 (Unit N) of Section 27 to a bottom hole location in the NE/4 NW/4 (Unit C) of Section 22.

In Case No. 25310, Applicant applies for an order pooling all uncommitted interests in the Second Bone Spring interval of the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the W/2 E/2 of Sections 27 and 22, Township 22 South, Range 35 East, Lea County, New Mexico. The Unit will be dedicated to the **Bridge State** Unit 27 503H well, which will be drilled from a surface hole location in the SE/4 SE/4 (Unit P) of Section 27 to a bottom hole location in the NW/4 NE/4 (Unit B) of Section 22.

In Case No. 25311, Applicant applies for an order pooling all uncommitted interests in the Second Bone Spring interval of the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the E/2 E/2 of Sections 27 and 22, Township 22 South, Range 35 East, Lea County, New Mexico. The Unit will be dedicated to the **Bridge State** Unit 27 504H well, which will be drilled from a surface hole location in the SE/4 SE/4 (Unit P) of Section 27 to a bottom hole location in the NE/4 NE/4 (Unit A) of Section 22.

The completed intervals of the wells will be orthodox. A depth severance exists in the Bone Spring formation within the units. Accordingly, Applicant seeks to pool uncommitted interests from the base of the First Bone Spring interval, at a stratigraphic equivalent of approximately 10,122' TVD, to the base of the Second Bone Spring interval, at a stratigraphic equivalent of

approximately 10,509' TVD, as observed on the Northern AKQ State #001 well log (API No. 30-025-25443).

Also to be considered will be the cost of drilling and completing the wells, the allocation of the costs, the designation of Applicant as operator of the units and the wells, and a 200% charge for the risk involved in drilling and completing the wells.
