APPLICANT'S STATEMENT OF CASE

Under Case No. 25365, Mewbourne seeks an order pooling all uncommitted interests in a standard 640-acre, more or less, horizontal well spacing unit in the Bone Spring formation (Vacuum; Bone Spring, South [61900]) underlying the E/2 of Sections 15 and 22, Township 18 South, Range 35 East, NMPM, Lea County, New Mexico. Mewbourne seeks to initially dedicate the unit to the proposed **Seafood Tower 22/15 State Com #527H** well to be drilled from a surface hole location in the SW/4 SW/4 (Unit M) of Section 23 to a bottom hole location in the NE/4 NE/4 (Unit A) of Section 15. The completed interval of the well is expected to remain within 330 feet of the adjoining quarter-quarter section (or equivalent) tracts to allow inclusion of these proximity tracts within the proposed spacing unit under 19.15.16.15.B(1)(b) NMAC. Mewbourne has sought but been unable to obtain voluntary agreement for the development of these lands from all interest owners in the subject acreage.
