**STATEMENT OF THE CASE**

In **Case No. 25384**, Applicant seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the W/2 W/2 of Sections 27 and 34, Township 23 South, Range 28 East, Eddy County, New Mexico. The Unit will be dedicated to the **Yardbirds 27/34 Fee #522H** well, which will be drilled from a surface hole location in the NW/4 NW/4 (Unit D) of Section 27 to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 34.

In **Case No. 25385**, Applicant seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the E/2 W/2 of Sections 27 and 34, Township 23 South, Range 28 East, Eddy County, New Mexico. The Unit will be dedicated to the **Yardbirds 27/34 Fee #524H** well, which will be drilled from a surface hole location in the NW/4 NW/4 (Unit D) of Section 27 to a bottom hole location in the SE/4 SW/4 (Unit N) of Section 34.

In **Case No. 25386**, Applicant seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the W/2 E/2 of Sections 27 and 34, Township 23 South, Range 28 East, Eddy County, New Mexico. The Unit will be dedicated to the **Yardbirds 27/34 Fee #526H** well, which will be drilled from a surface hole location in the SW/4 SW/4 (Unit M) of Section 23, to a bottom hole location in the SW/4 SE/4 (Unit O) of Section 34.

In **Case No. 25387**, Applicant seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 640-acre, more or less, standard horizontal spacing unit comprised of the E/2 of Sections 27 and 34, Township 23 South, Range 28 East, Eddy County, New Mexico. The Unit will be dedicated to the **Yardbirds 27/34 Fee #567H** well, which will be drilled from a surface hole location in the SW/4 SW/4 (Unit M) of Section 23 to a bottom hole location in the SE/4 SE/4 (Unit P) of Section 34. The completed interval of the Well will be located within 330' of the quarter-quarter section line separating the E/2 E/2 and W/2 E/2 of Sections 27 and 34 to allow for the creation of a 640-acre, more or less, standard horizontal spacing unit.

The completed intervals of the Wells will be orthodox. Also to be considered will be the cost of drilling and completing the Wells, the allocation of the costs, the designation of Applicant

as operator of the Units and the Wells, and a 200% charge for the risk involved in drilling and completing the Wells.
