#### **APPLICANT'S STATEMENT OF THE CASE**

In Case No. 25468, WPX seeks to pool additional uncommitted interests under the terms of Division Order No. R-23781. On April 23, 2025, the Division entered Order No. R-23781 in Case No. 25153, which pooled all uncommitted interests in the Wolfcamp formation underlying a standard 769.91-acre, more or less, spacing unit comprised of the E/2 of Sections 23, 26 and 35, Township 26 South, Range 30 East, NMPM, Eddy County, New Mexico. The Order further dedicated to the unit the Ross Draw 35-26-23 Fed Com 410H Well, Ross Draw 35-26-23 Fed Com 414H Well, Ross Draw 35-26-23 Fed Com 415H Well, Ross Draw 35-26-23 Fed Com 424H Well, Ross Draw 35-26-23 Fed Com 425H Well, Ross Draw 35-26-23 Fed Com 443H Well, Ross Draw 35-26-23 Fed Com 444H Well, Ross Draw 35-26-23 Fed Com 454H Well, Ross Draw 35-26-23 Fed Com 454H Well and designated WPX as operator of the unit and wells.

Since the Order was entered, WPX has identified additional uncommitted interests in the unit that have not been pooled under the terms of the Order. WPX has sought in good faith, but has been unable to obtain, voluntary agreement from the additional interest owners to participate in the drilling of the wells or in the commitment of their interests to the wells for their development within the unit. In order to provide for its just and fair share of the oil and gas underlying the subject lands, WPX requests that the additional uncommitted interests in this unit be pooled into the unit pursuant to the terms of Order No. R-23781.
