STATEMENT OF THE CASE

Permian Resources applies for an order pooling all uncommitted interests in the Wolfcamp formation underlying a 645.91-acre, more or less, standard horizontal spacing unit comprised of the S/2 of Sections 31 and 32, Township 19 South, Range 28 East, Eddy County, New Mexico ("Unit"). The Unit will be dedicated to the following wells ("Wells"): Dakota 32 Fed Com 203H, which will be drilled from a surface hole location in the SE/4 SE/4 (Unit P) of Section 32 to a bottom hole location in the NW/4 SW/4 (Unit L) of Section 31; and the Dakota 32 Fed Com 204H,

which will be drilled from a surface hole location in the SE/4 SE/4 (Unit P) of Section 32 to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 31.

The completed intervals of the Wells will be orthodox. The completed interval of the Dakota 32 Fed Com 204H well will be located within 330' of the quarter-quarter section line separating the N/2 S/2 and S/2 S/2 of Sections 31 and 32 to allow for the creation of a 645.91-acre standard, horizontal spacing unit.

Also to be considered will be the cost of drilling and completing the Wells and the allocation of the costs, the designation of Permian Resources as the operator of the Wells, and a 200% charge for the risk involved in drilling and completing the Wells.
