MOTION TO AMEND PRE-HEARING ORDER

Coterra Energy Operating Co. ("Coterra") respectfully moves to amend the Pre-Hearing Order setting the above captioned Rockwood Energy, LP ("Rockwood") cases for a contested hearing on August 12, 2025, to add recently filed cases to the Pre-Hearing Order. In support, Coterra states:

1. Rockwood Case Nos. 25241-25246 are currently set for a contested hearing on August 12, 2025 pursuant to a pre-hearing order issued by the Division on May 22, 2025.

2. On July 24, 2025, Coterra filed applications that compete with Rockwood's cases, which were cases were assigned Case Nos. 25520-25525.

3. At the July 24, 2025 Examiner Hearing in these competing matters, the Hearing Examiner stated that the Coterra competing cases would be set for contested hearing on August 13, 2025, while the Rockwood cases would continue to be heard on August 12, 2025.

4. This Division issued a Special Notice of Hearing stating that the Coterra Cases (Case Nos. 25520-25525) will be heard on August 13, 2025.

5. The Pre-Hearing Order setting Case Nos. 25241-25246 for a contested hearing on August 12, 2025 should thus be amended to add Coterra Case Nos. 25520-25525, to be heard on August 13, 2025.

6. Counsel for Rockwood was contacted and does not object to the motion.

WHEREFORE, Coterra respectfully requests that the Division amend the Pre-Hearing Order as outlined herein. A proposed word version of an order granting this motion will be sent to the Division via email.
