**APPLICATION**

In accordance with NMSA 1978, § 70-2-17 and NMAC 19.15.16.15(B)(5), COG Operating LLC (“COG” or “Applicant”), through its undersigned attorneys, files this application with the Oil Conservation Division (“Division”) seeking an order pooling all uncommitted interests in the Wolfcamp formation underlying a 640-acre, more or less, standard horizontal spacing unit comprised of E/2 Sections 6 and 7, Township 26 South, Range 29 East, Eddy County, New Mexico (“Unit”). In support of this application, COG states the following.

1. Applicant (OGRID No. 229137) is a working interest owner in the Unit and has the right to drill thereon.
2. Applicant seeks to dedicate the Unit to the following proposed wells (“Wells”):
  - a. **Pudge Federal Com 701H & 702H** wells, which will be drilled from surface hole locations in the SE/4SW/4 (Unit N) Section 31, Township 25 South, Range 29 East, to bottom hole locations in the SE/4SE/4 (Unit P) Section 7, Township 26 South, Range 29 East, and produce from a first take point in the NE/4NE/4 (Unit A) Section 6, to a last take point in the SE/4SE/4 (Unit P) of Section 7, with the Pudge Federal Com 702H to the defining well;
  - b. **Pudge Federal Com 703H** well, which will be drilled from a surface hole location in the SE/4SW/4 (Unit N) Section 31, Township 25 South, Range 29 East, to a bottom hole location in the SW/4SE/4 (Unit O) Section 7, Township 26 South,

- Range 29 East, and produce from a first take point in the NW/4NE/4 (Unit B) Section 6, to a last take point in the SW/4SE/4 (Unit O) of Section 7;
- c. **Pudge Federal Com 901H & 902H** wells, which will be drilled from surface hole locations in the SE/4SW/4 (Unit N) Section 31, Township 25 South, Range 29 East, to bottom hole locations in the SE/4SE/4 (Unit P) Section 7, Township 26 South, Range 29 East, and produce from first take points in the NE/4NE/4 (Unit A) Section 6, to last take points in the SE/4SE/4 (Unit P) of Section 7; and
- d. **Pudge Federal Com 903H & 904H** wells, which will be drilled from a surface hole location in the SE/4SW/4 (Unit N) Section 31, Township 25 South, Range 29 East, to a bottom hole location in the SW/4SE/4 (Unit O) Section 7, Township 26 South, Range 29 East, and produce from first take points in the NW/4NE/4 (Unit B) Section 6, to last take points in the SW/4SE/4 (Unit O) of Section 7.
3. There is not a depth severance in the Wolfcamp formation within the Unit. Accordingly, COG seeks to pool interests for the Wolfcamp formation, from the Purple Sage; Wolfcamp, Gas Pool [Pool Code 98220].
4. The completed intervals of the Wells will be orthodox.
5. Applicant has sought and been unable to obtain voluntary agreement for the development of these lands from certain overriding royalty interest owners and record title owners in the Unit.
6. The pooling of interests will avoid the drilling of unnecessary wells, prevent waste, and protect correlative rights.

**EXHIBIT A-1**

7. In order to permit Applicant to obtain its just and fair share of the oil and gas underlying the subject lands, all uncommitted interests in the Unit should be pooled and Applicant should be designated the operator of the proposed horizontal wells and the Unit.

WHEREFORE, Applicant requests that this application be set for hearing before an Examiner of the Oil Conservation Division on August 7, 2025, and, after notice and hearing as required by law, the Division enter an order:

- A. Pooling all uncommitted interests in the Unit;
- B. Approving the initial wells in the Unit; and
- C. Designating Applicant as the operator of the Unit and the horizontal wells to be drilled thereon.

**SELF-AFFIRMED STATEMENT OF**  
**JEFFREY S. STOUT, CPL**

1. I am a Land Negotiator for ConocoPhillips, parent company of COG Operating LLC (“COG”). I am over 18 years of age, have personal knowledge of the matters addressed herein, and am competent to provide this Self-Affirmed Statement. I have previously testified before the New Mexico Oil Conservation Division (“Division”) and my credentials as an expert in petroleum land matters as a Certified Professional Landman were accepted and made a matter of record.

2. I am familiar with the land matters involved in the above-referenced case. Copies of COG’s application and proposed hearing notice are attached as **Exhibit A-1**.

3. None of the parties proposed to be pooled in this case indicated opposition to this matter proceeding by affidavit, therefore I do not expect any opposition at hearing.

4. COG seeks an order: 1) establishing a 640-acre, more or less, standard horizontal spacing unit comprised of the E/2 Sections 6 and 7, Township 26 South, Range 29 East, Eddy County, New Mexico (“Unit”); and (2) pooling all uncommitted interests in the Wolfcamp A and C formations underlying the Unit.

5. The Unit will be dedicated to the following wells (“Wells”):

- **Pudge Federal Com 701H & 702H** wells, which will be drilled from surface hole locations in the SE/4SW/4 (Unit N) Section 31, Township 25 South, Range

29 East, to bottom hole locations in the SE/4SE/4 (Unit P) Section 7, Township 26 South, Range 29 East, and produce from a first take point in the NE/4NE/4 (Unit A) Section 6, to a last take point in the SE/4SE/4 (Unit P) of Section 7;

- **Pudge Federal Com 901H & 902H** wells, which will be drilled from surface hole locations in the SE/4SW/4 (Unit N) Section 31, Township 25 South, Range 29 East, to bottom hole locations in the SE/4SE/4 (Unit P) Section 7, Township 26 South, Range 29 East, and produce from first take points in the NE/4NE/4 (Unit A) Section 6, to last take points in the SE/4SE/4 (Unit P) of Section 7; and

6. The completed intervals of the Wells will be orthodox.

8. **Exhibit A-4** contains a plat identifying ownership by tract in the Unit and also includes any applicable lease numbers.
9. **Exhibit A-5 (Revised)** is the Unit recapitulation, and shows the interests COG seeks to pool highlighted in yellow.
10. COG has conducted a diligent search of all county public records, including phone directories, computer databases, and internet searches, to locate the overriding royalty and record title interest owners it seeks to pool.


13. The attached exhibits were either prepared by me or under my supervision or were compiled from company business records.

1. I am a geologist for ConocoPhillips, parent company of COG Operating LLC ("COG"). I am over 18 years of age, have personal knowledge of the matters addressed herein, and am competent to provide this Self-Affirmed Statement. I have previously qualified and testified before the New Mexico Oil Conservation Division ("Division") as an expert in geological matters.

2. I am familiar with the geological matters that pertain to the above-referenced case.

3. **Exhibit B-1** consists of location maps for the proposed Wolfcamp A and Wolfcamp C horizontal spacing units ("Unit"), comprised of the E/2 of Section 6 and 7, Township 26 South, Range 29 East, N.M.P.M., being 640 acres more or less. The approximate wellbore paths for the proposed **Pudge Federal Com 701H, 702H, and 901H-904H Wells** ("Pudge Wells") wells are represented by dashed lines. Existing producing wells in the targeted intervals are represented by solid lines.

4. **Exhibit B-2** consists of subsea structure maps for the Wolfcamp A and Wolfcamp C formation that are representative of the targeted intervals for the proposed Pudge Wells. The

data points are indicated by green crosses. The approximate wellbore paths of the Pudge Wells are depicted by red or brown dashed lines. The maps demonstrate that both formations are dipping to the east in this area. I do not observe any faulting, pinch-outs, or geologic impediments to developing the targeted intervals with horizontal wells.

5. **Exhibit B-3** consists of cross section maps that identify wells penetrating the targeted intervals used to construct a structural cross-section from A to A'. I used these well logs because they penetrate the targeted intervals, are of good quality, and are representative of the geology in the area.

6. **Exhibit B-4** consists of stratigraphic cross-sections using the representative wells identified on Exhibit B-3. It contains gamma ray, resistivity and porosity logs. The proposed landing zones for the Pudge Wells are labeled on the exhibit. This cross-section demonstrates the targeted intervals are continuous across the Unit.

7. In my opinion, the standup orientation for the proposed Pudge Wells and existing wells is appropriate due to the geologic stress and consistent with existing development in this area.

8. Based on my geologic study of the area, the targeted intervals underlying the Unit is suitable for development by horizontal wells and the tracts comprising the Unit will contribute more or less equally to the production of the Pudge Wells.

9. In my opinion, the granting of COG's application will serve the interests of conservation, the protection of correlative rights, and the prevention of waste.

10. The attached exhibits were either prepared by me or under my supervision or were compiled from company business records.

## Location Map

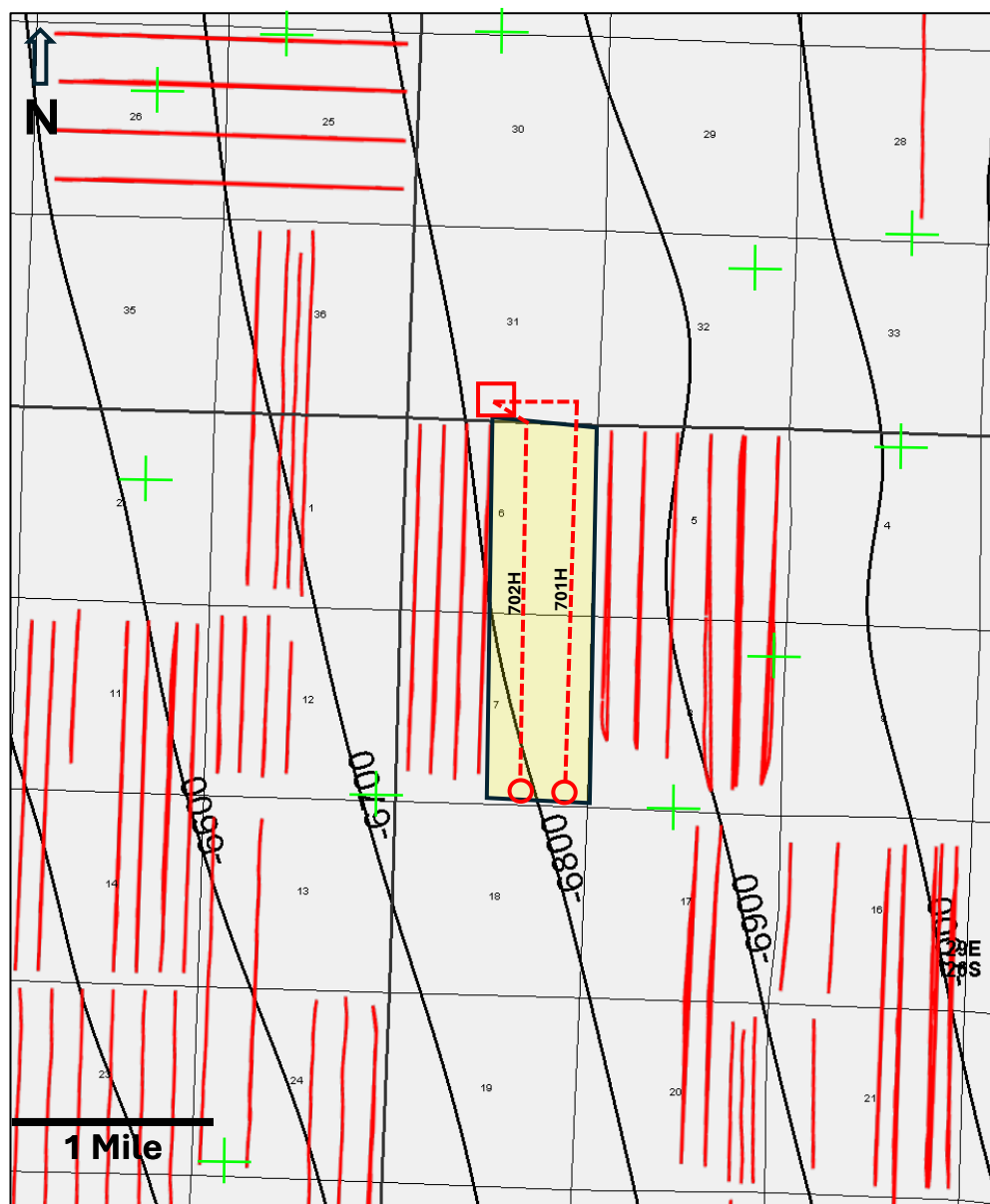

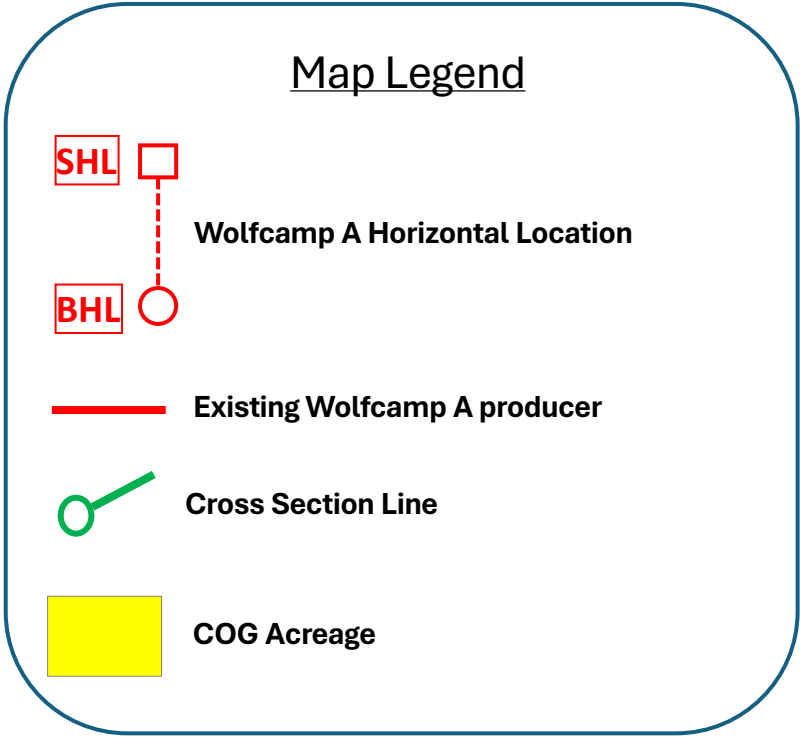
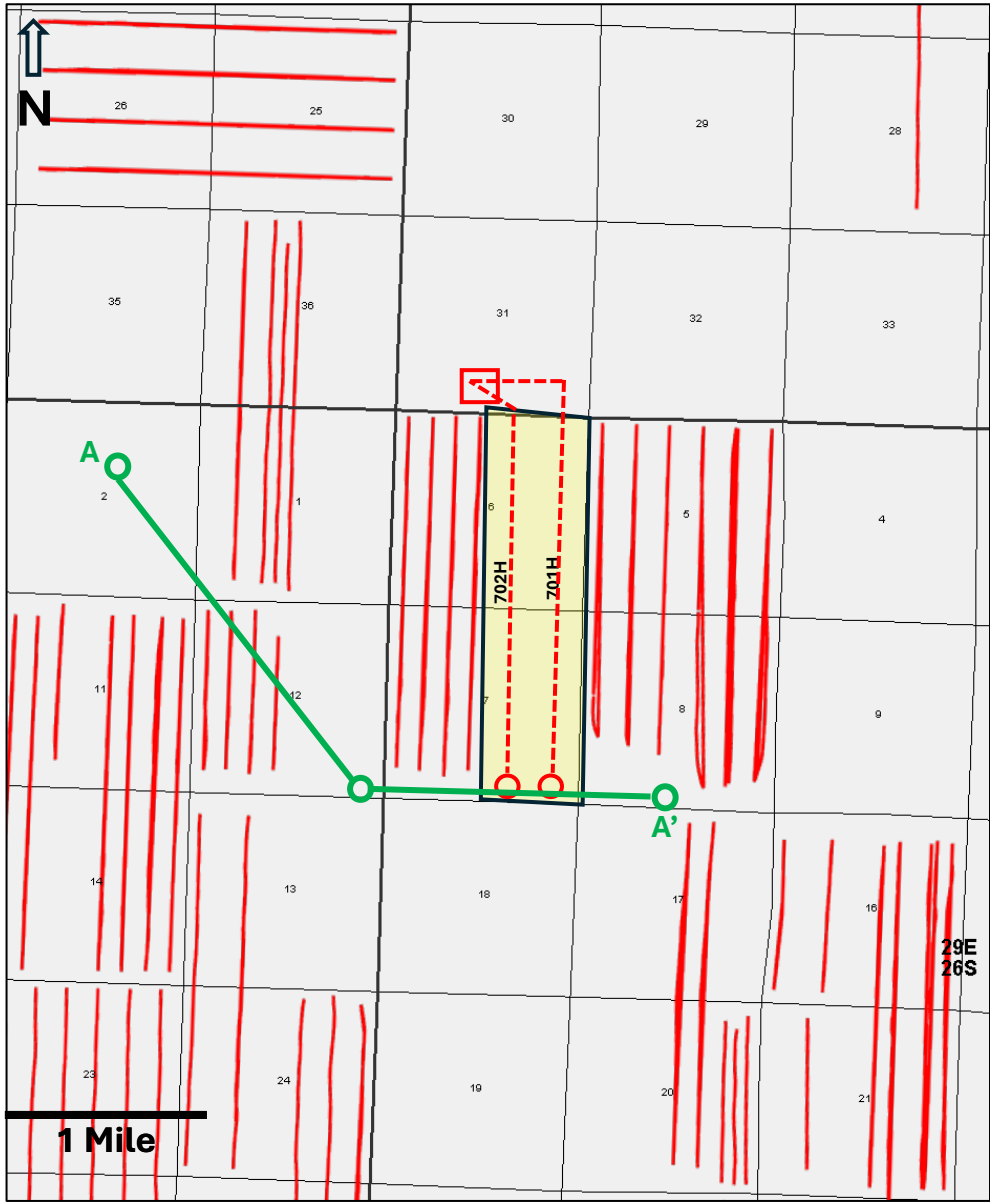

Pudge 901H-904H: Top of Wolfcamp C



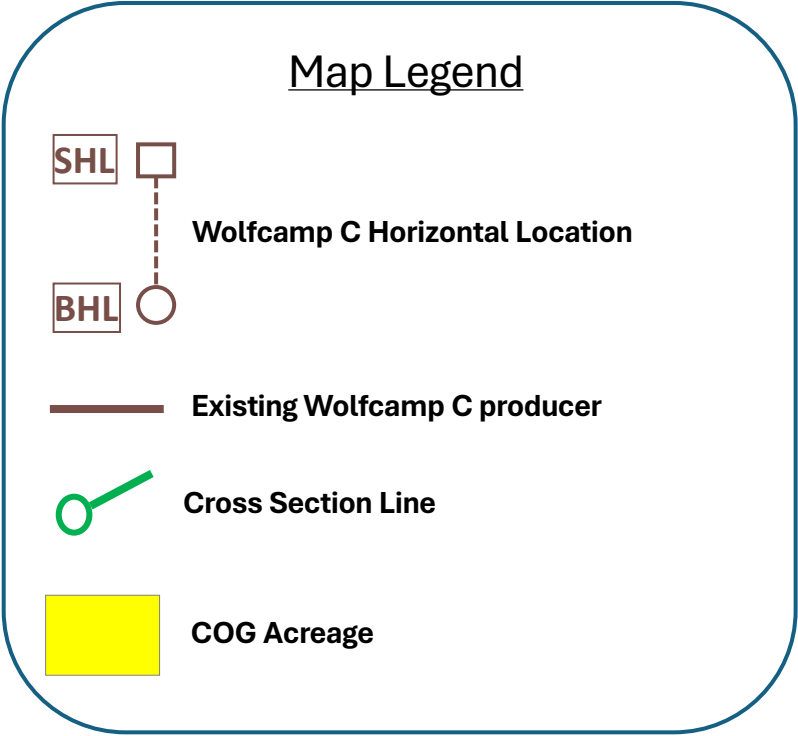
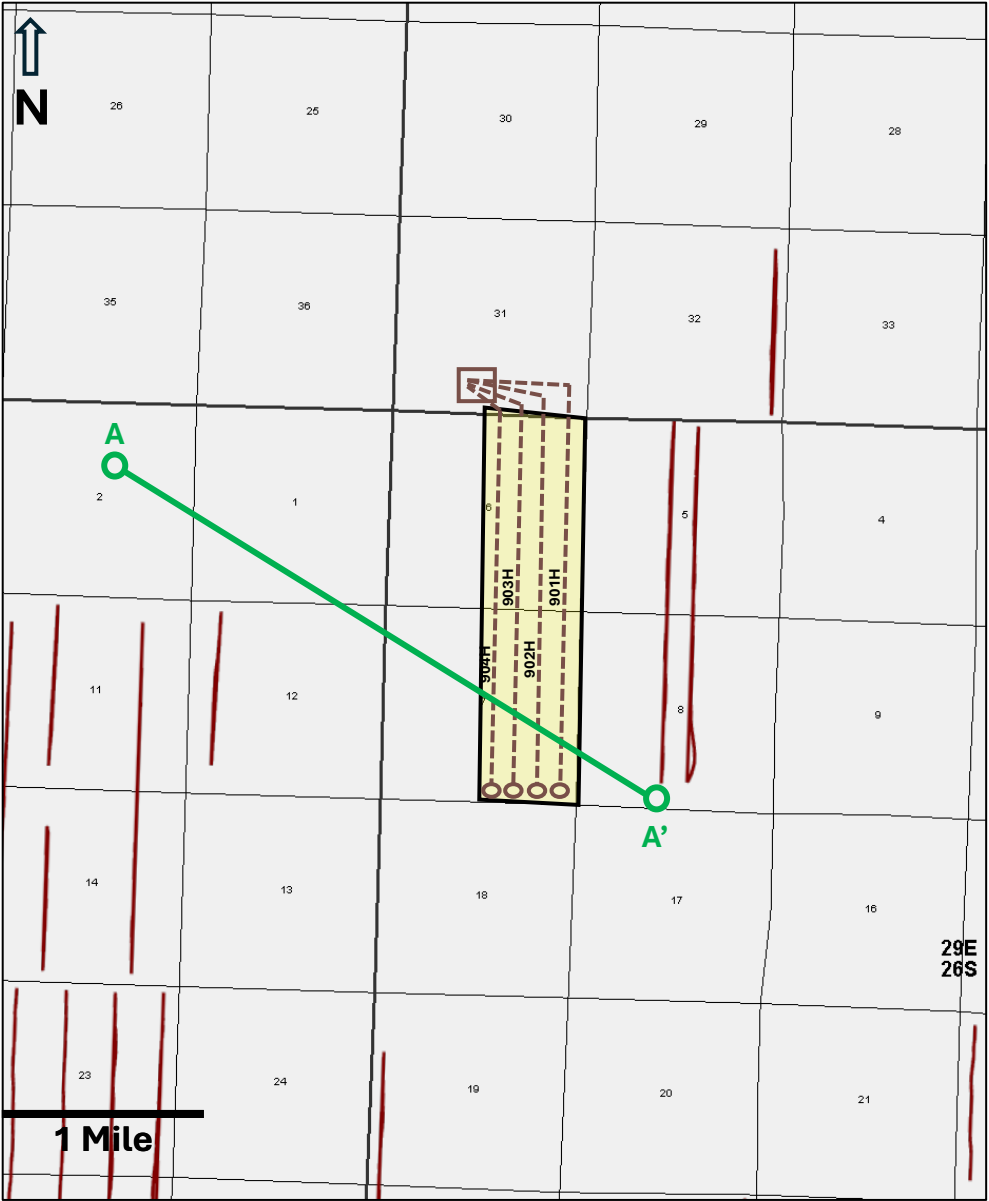

Pudge 701H and 702H



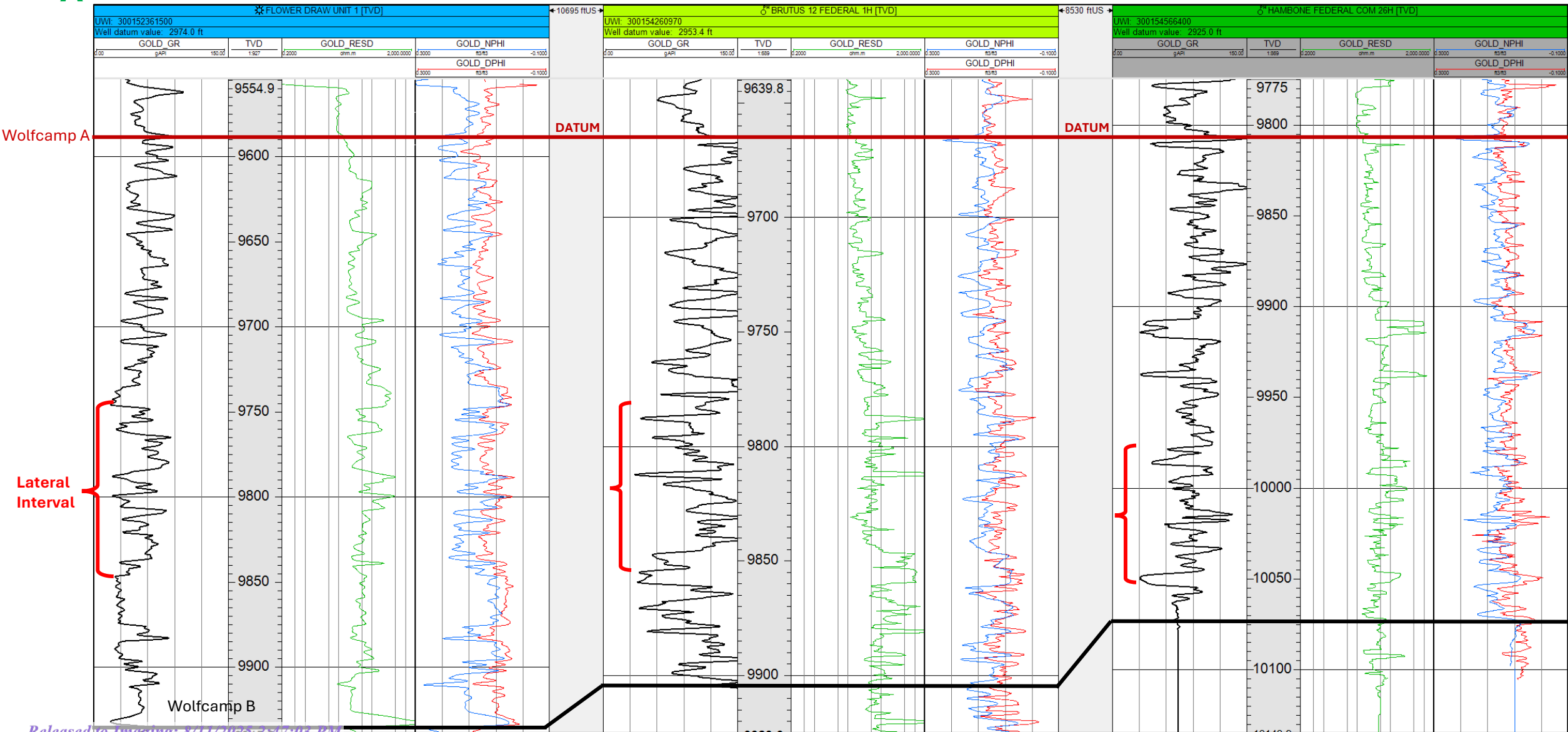

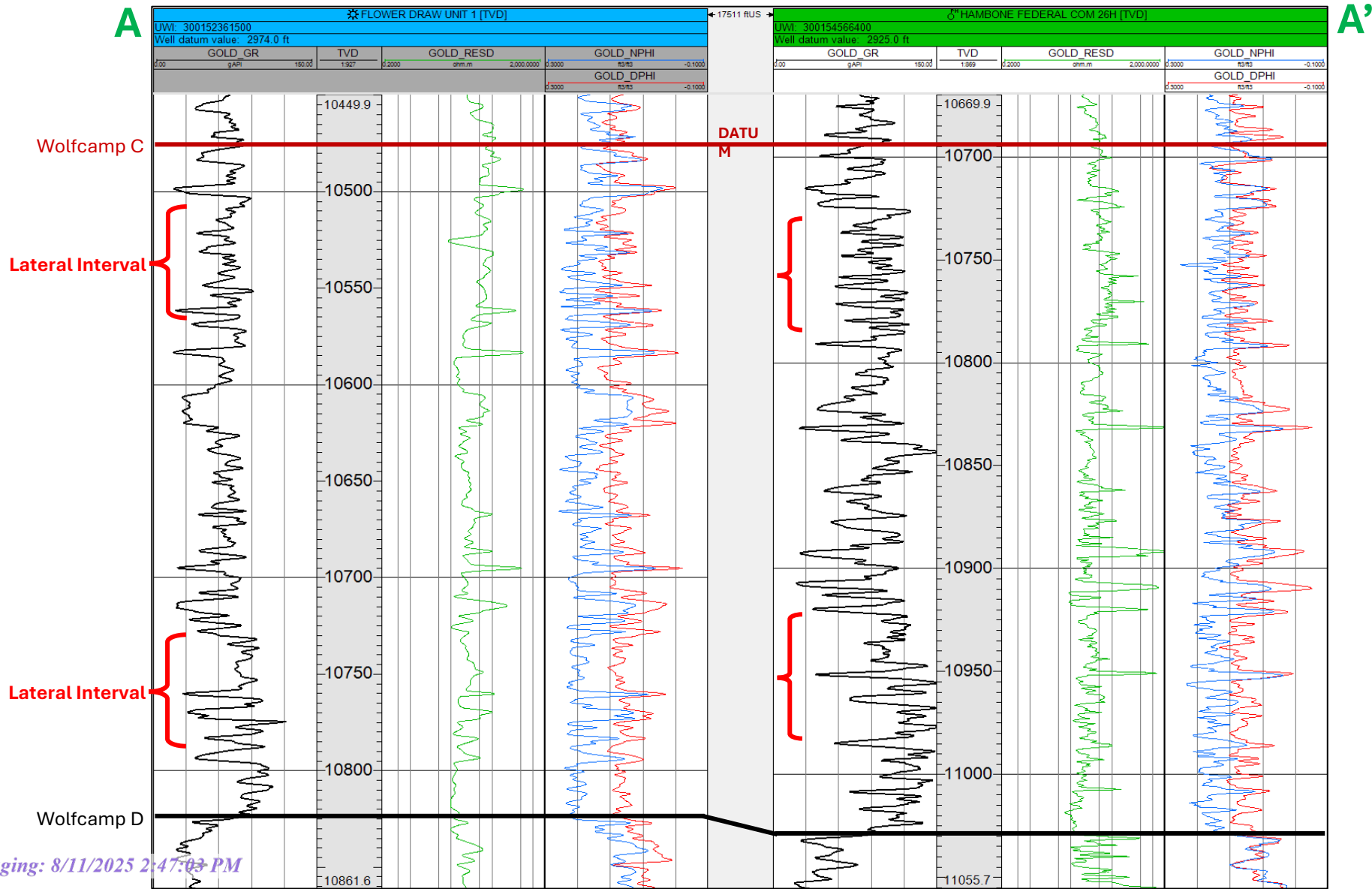
