APPLICANT'S STATEMENT OF THE CASE

In Case No. 25527, Devon an order pooling all uncommitted mineral interests in the Bone Spring formation, designated as an oil pool, underlying a standard 640-acre, more or less, spacing unit comprised of the S/2 of Sections 15 and 16, all in Township 21 South, Range 27 East, NMPM, Eddy County, New Mexico.

- 1. Devon is a working interest owner in the proposed horizontal spacing unit ("HSU") and has a right to drill a well thereon.
- 2. Devon proposes and dedicates to the HSU the Cedar Hills 15-16 State Com 335H Well, as the initial well, to be drilled to a sufficient depth to test the Bone Spring formation.
 - Under <u>Case No. 25527</u>, Devon seeks to dedicate the <u>Cedar Hills 15-16 State Com 335H</u> Well, an oil well, to be horizontally drilled from a surface location in the SW/4 SW/4 (Unit M) of Section 14 to a bottom hole location in the NW/4 SW/4 (Unit L) of Section 16. The <u>Cedar Hills 15-16 State Com 335H Well</u>, is the proximity well, positioned so the unit can include proximity tracts, thereby incorporating the S/2 S/2 of Sections 15 and 16.
- 3. The well proposed herein is orthodox in its location; the take points and completed intervals will comply with setback requirements under statewide rules.
