APPLICANT'S STATEMENT OF THE CASE

In Case No. 25530, Cimarex an order pooling all uncommitted mineral interests in the Bone Spring formation, designated as an oil pool, underlying a standard 320-acre, more or less, spacing unit comprised of the E/2 of Section 14, Township 25 South, Range 28 East, NMPM, Eddy County, New Mexico.

- 1. Cimarex is a working interest owner in the proposed horizontal spacing unit ("HSU") and has a right to drill a well thereon.
- 2. Cimarex proposes and dedicates to the HSU the Riverbend 14 Federal Com 1H Well, the Riverbend 14 Federal Com 3H Well, and the Riverbend 14 Federal Com 8H Well, as initial wells, to be drilled as U-lateral wells, to a sufficient depth to test the Bone Spring formation.
 - Under <u>Case No. 25530</u>, Cimarex seeks to dedicate the **Riverbend 14 Federal Com 1H** Well, an oil well, with the surface location in or near the SE/4 SW/4 (Unit N) of Section 11 to a bottom hole location in or near the NE/4 NE/4 (Unit A) of Section 14.
 - Under <u>Case No. 25530</u>, Cimarex seeks to dedicate the **Riverbend 14 Federal Com 3H**Well, an oil well, to be horizontally drilled from a surface location in or near the SE/4
 SW/4 (Unit N) of Section 11 to a bottom hole location in or near the NE/4 NE/4 (Unit A) of Section 14.
 - Under <u>Case No. 25530</u>, Cimarex proposes the Riverbend 14 Federal Com 8H Well, an oil well, to be horizontally drilled from a surface location in or near the SE/4 SW/4 (Unit N) of Section 11 to a bottom hole location in the NE/4 NE/4 (Unit A) of Section 14.
- 3. The wells proposed herein are orthodox in their locations; the take points and completed intervals will comply with setback requirements under statewide rules.
