STATEMENT OF THE CASE

In **Case No. 25544**, Applicant seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 953.95-acre, more or less, standard, horizontal spacing unit comprised of the S/2 of irregular Sections 31 and 32, Township 21 South, Range 27 East, and the S/2 of Section 36, Township 21 South, Range 26 East, Eddy County, New Mexico. The Unit will be dedicated to the **Fred State Com 133H** well, which will produce from a first take point located in the NE/4 SE/4 (Unit I) of Section 32, Township 21 South, Range 27 East, to a last take point located in the NW/4 SW/4 (Unit L) of Section 36, Township 21 South, Range 26 East. The

completed interval of the **Fred State Com 133H** well will be located within 330' of the quarter-quarter section line separating the N/2 S/2 and S/2 S/2 of Sections 31, 32, and 36 to allow for the creation of a 953.95-acre standard, horizontal spacing unit.

In **Case No. 25565**, Applicant seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 477.09-acre, more or less, standard, horizontal spacing unit comprised of the S/2 N/2 of irregular Sections 31 and 32, Township 21 South, Range 27 East, and the S/2 N/2 of Section 36, Township 21 South, Range 26 East, Eddy County, New Mexico. The Unit will be dedicated to the **Fred State Com 132H** well ("Well"), which will produce from a first take point located in the SE/4 NE/4 (Unit H) of Section 32, Township 21 South, Range 27 East, to a last take point located in the SW/4 NW/4 (Unit E) of Section 36, Township 21 South, Range 26 East.

In **Case No. 25566**, Applicant seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 477.16-acre, more or less, standard, horizontal spacing unit comprised of the N/2 N/2 of irregular Sections 31 and 32, Township 21 South, Range 27 East, and the N/2 N/2 of Section 36, Township 21 South, Range 26 East, Eddy County, New Mexico. The Unit will be dedicated to the **Fred State Com 131H** well ("Well"), which will produce from a first take point located in the NE/4 NE/4 (Unit A) of Section 32, Township 21 South, Range 27 East, to a last take point located in the NW/4 NW/4 (Unit D) of Section 36, Township 21 South, Range 26 East.

The completed intervals of the Wells will be orthodox. Also to be considered will be the cost of drilling and completing the Wells, the allocation of the costs, the designation of Applicant as operator of the Units and the Wells, and a 200% charge for the risk involved in drilling and completing the Wells.
