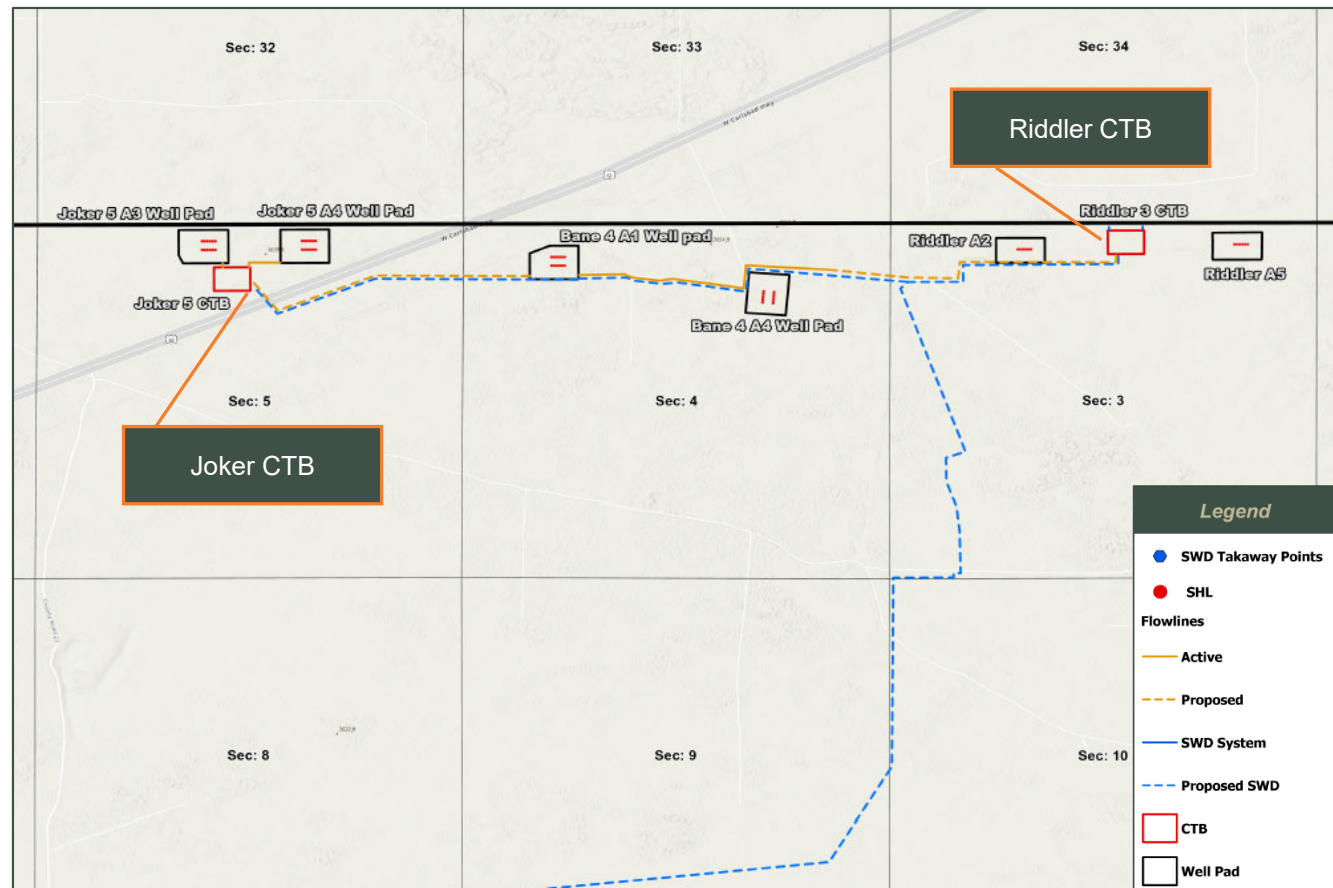

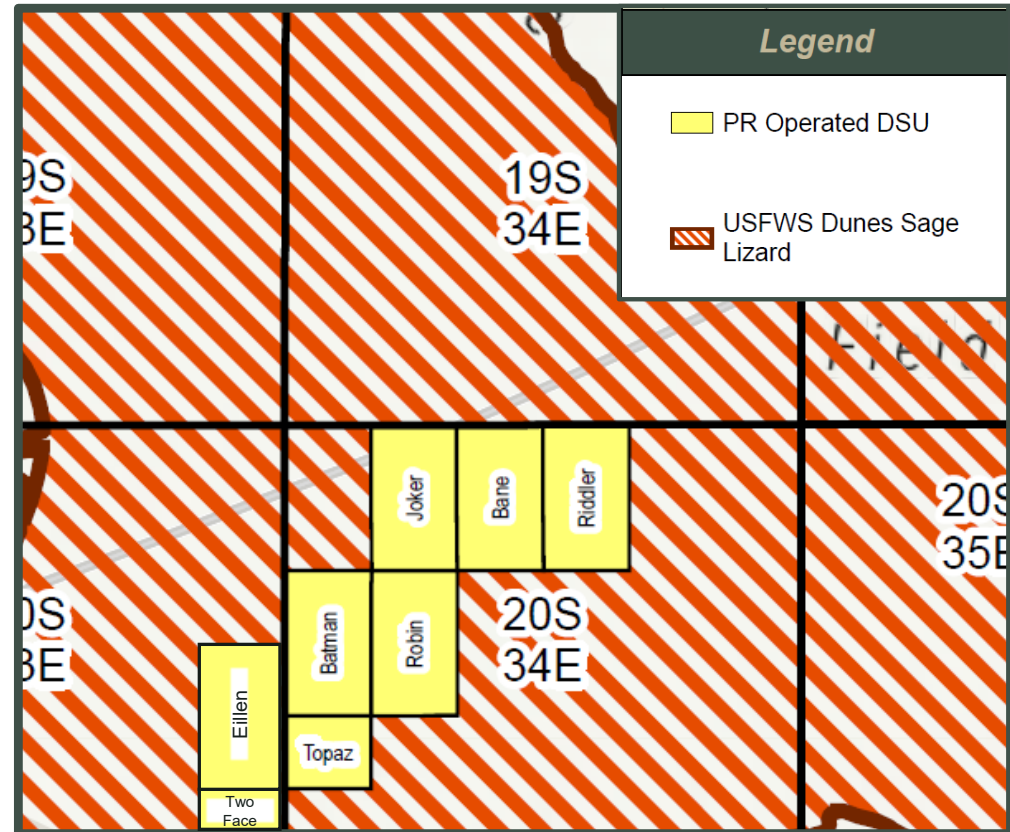

### Ongoing Conservation Effort:

- The U.S. Fish and Wildlife Service announced that effective June 20, 2024, that the Dunes Sagebrush Lizard (DSL) is listed as endangered under the Endangered Species Act
- DSL is a species of spiny lizard found exclusively in the shinnery oak dunelands and shrublands of the Mescalero and Monahan's Sandhills in southeastern New Mexico and west Texas.

### Permian Resources Proactivity:

- Permian has entered into Candidate Conservation Agreements and has enrolled its acreage within the DSL habitat.
- As part of such Candidate Conservation Agreements, Permian Resources is currently taking all precautions to ensure that DSL habitat is not disturbed in connection with our drilling, completion, and production operations.

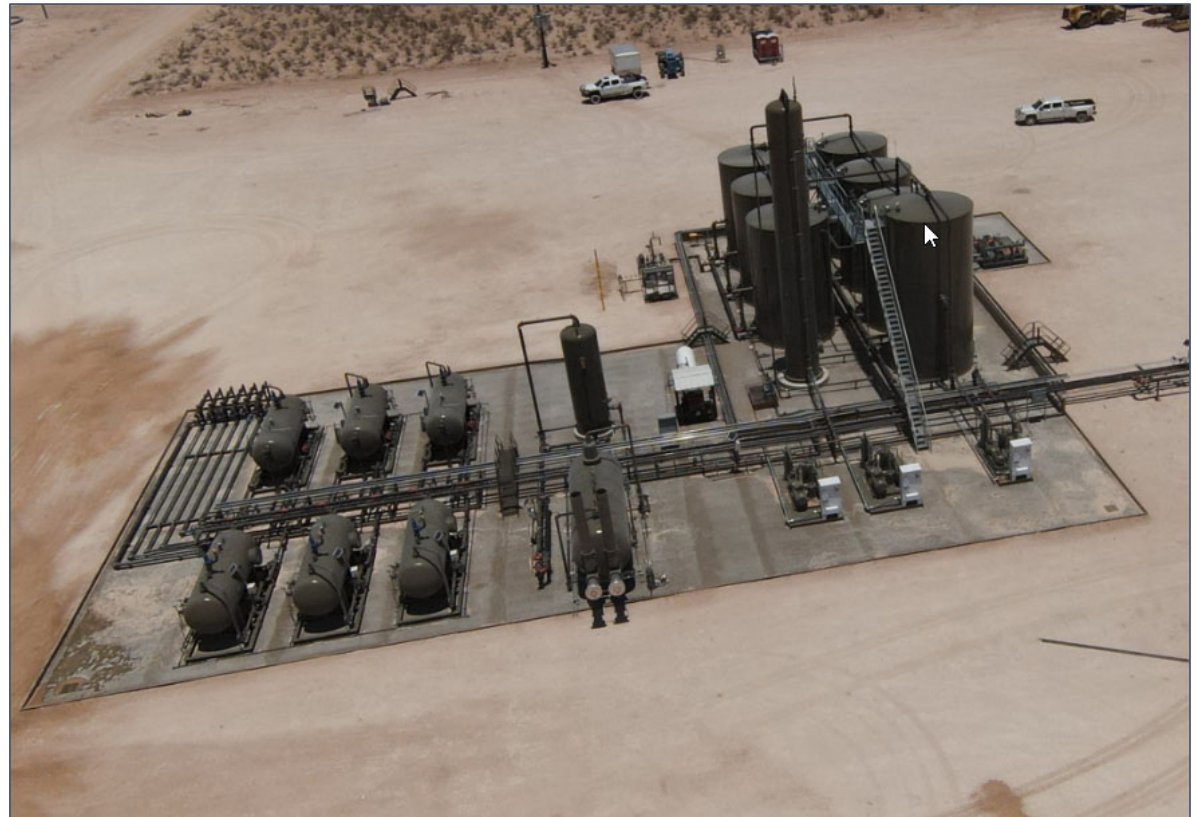

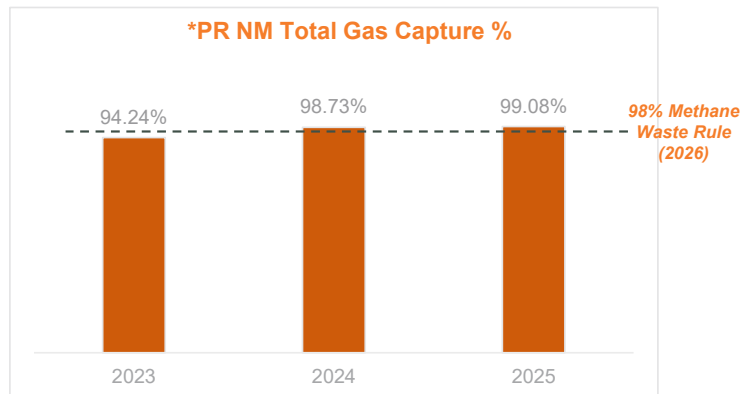

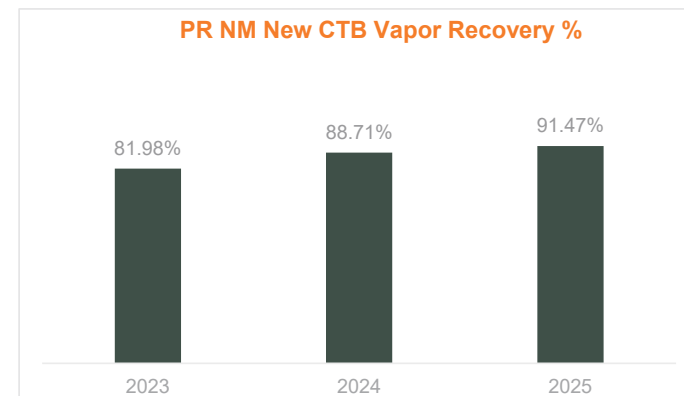
## Gas Capture

- Permian Resources, from the executive team to field pumpers, are committed to meeting gas capture goals and has evidence to support commitment.
- 99.0% of all gas produced in NM was captured, well ahead of New Mexico's methane waste management rule of 98% by December 31, 2026
- Aggressive shut-in strategy and advanced technology, including automated shut-in valves on the wellheads, ensure flared gas volumes are minimized when midstream upsets occur
- All flared volume events are reported via C-129 and C-115B forms



## Vapor Recovery

- Vapor recovery from gas flashed in production storage tanks and vapor recovery towers (VRT) is a primary focus for PR
- In-house vapor recovery team, including foreman and techs, ensure VRU maintenance requirements and run-time KPIs are met
- Continuous emissions monitoring systems are installed on sites that account for 80% of PR's oil production
  - Monitoring system will alarm operators of fugitive emissions events

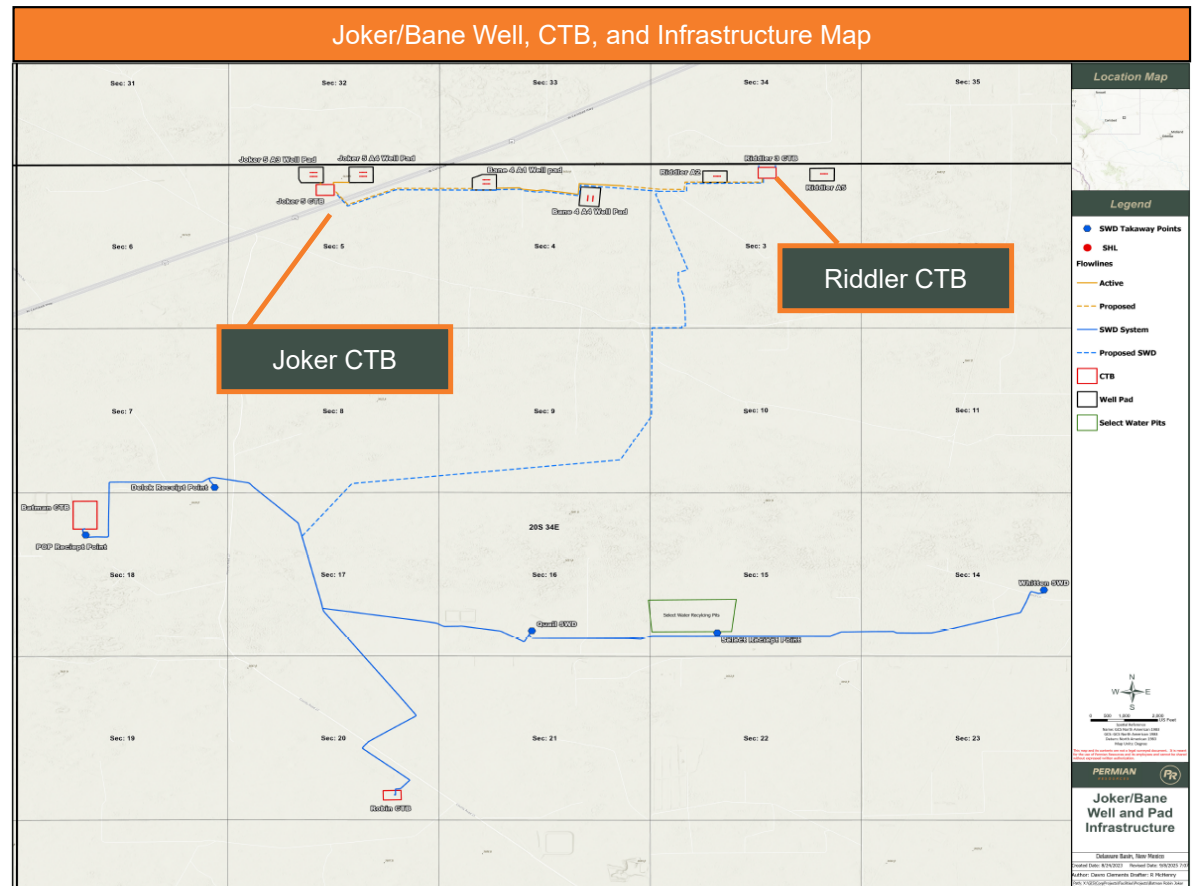
- >6 miles of 12" gathering line currently in-service

- PR is currently installing 4-miles of 20" water gathering pipeline to connect to Riddler CTB to existing infrastructure
- The Joker CTB will also be connected to this PR-owned water gathering system

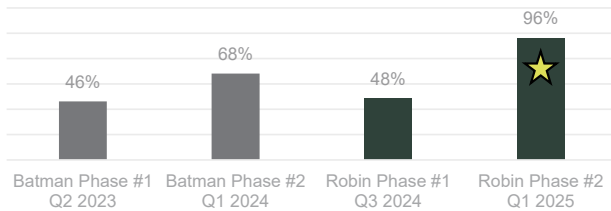

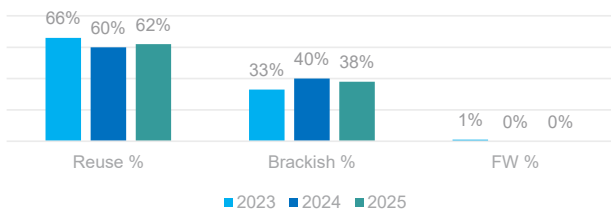
## Historical Water Recycle Usage

- 62% YTD recycled water utilization in NM
  - Development has been focused on new areas near Carlsbad, lacking infrastructure until Q1 2026
- 44% YTD recycled water utilization across all PR assets
- <1% YTD freshwater utilization across all PR assets, the rest coming from recycled water and brackish water
- Jewett (Batman/Robin/Joker/Bane/Riddler) has seen a step-change in recycling % since Select's water recycling pit was commissioned in Q1 2025

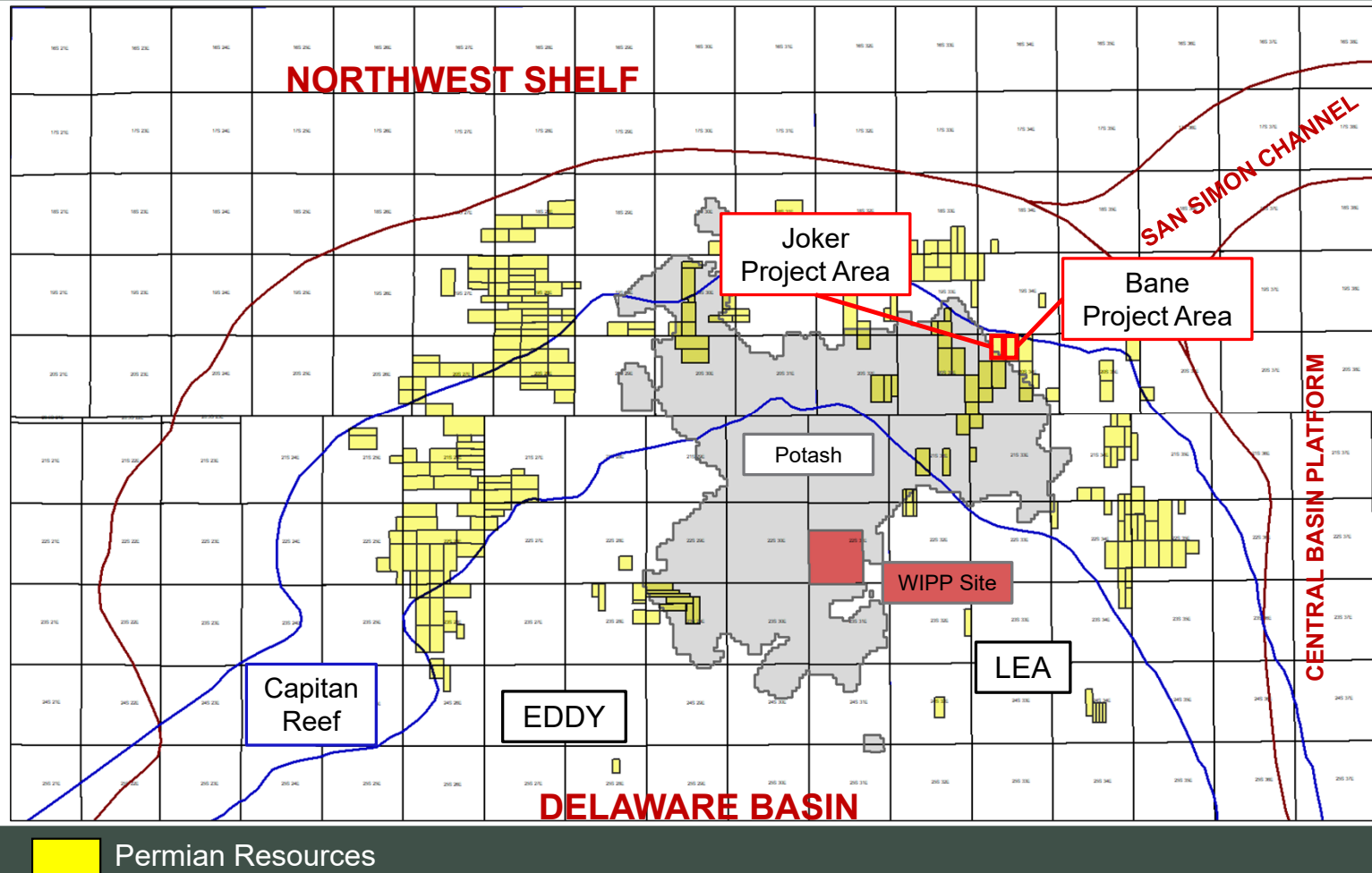

Joker 5-8 Fed Com, Bane 4-9 Fed Com

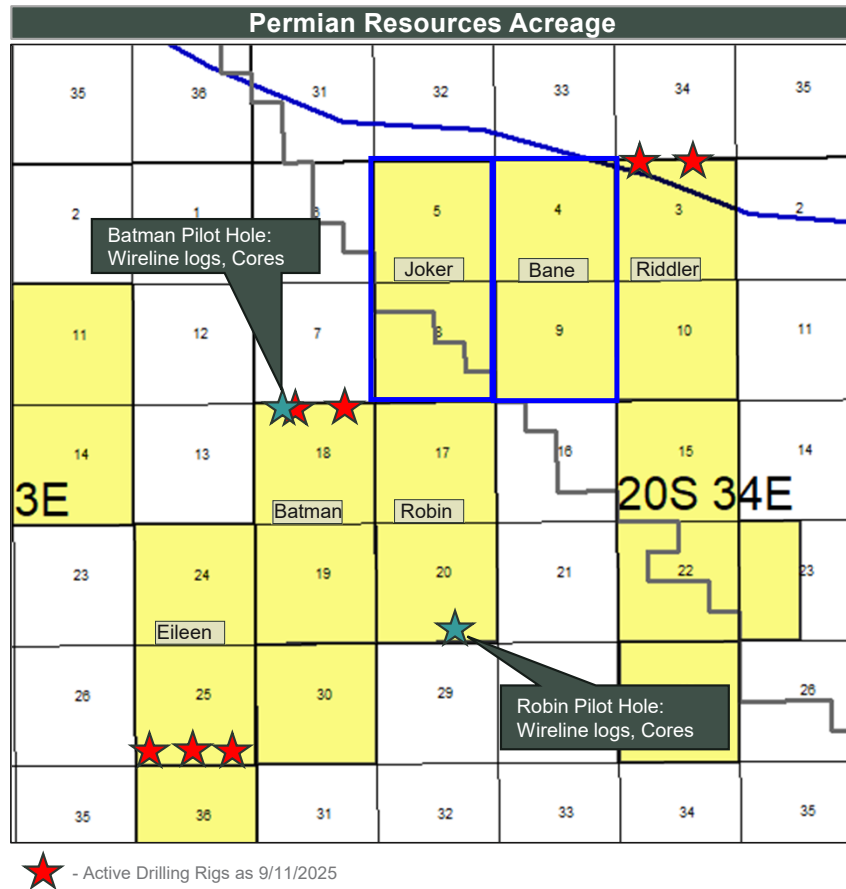

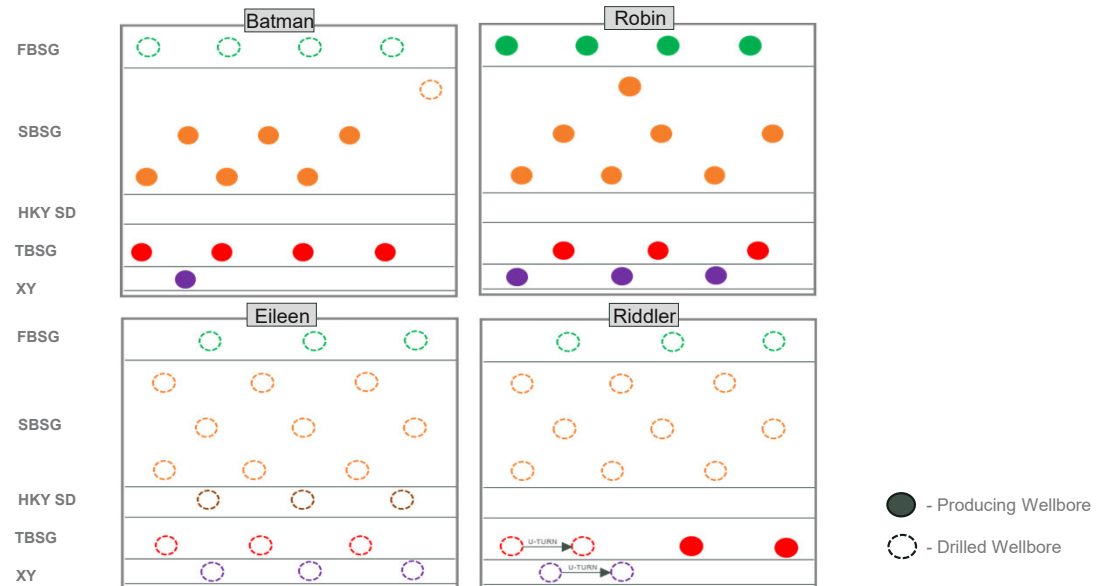

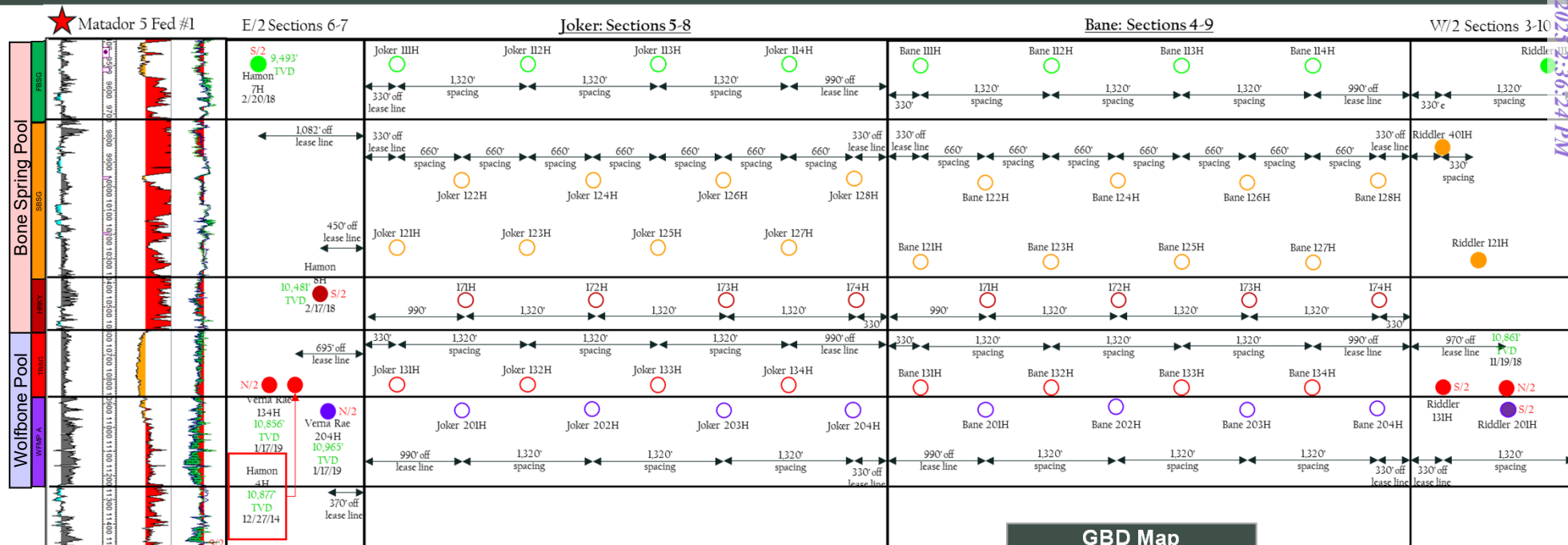
Permian Resources continues to be one of the most active operators in this AOI

- PR will have drilled 68 horizontal wellbores in the Bone Spring and Wolfcamp formations in DSU's directly offset the Joker/Bane by the end of 2025.
- PR's Proposals on Joker/Bane are not simply posturing, but represent the development plan PR intends to drill, as seen in the offsets.
- PR has also invested in multiple pilot hole and core studies to better understand the resource distribution and reservoir properties in this area.



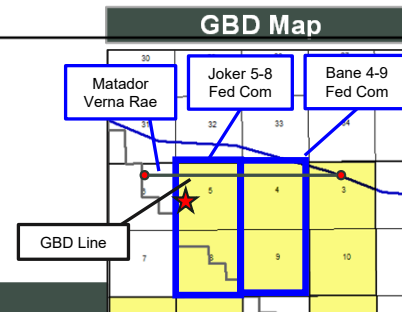
# Full Scale Development Plan Joker, Bane, Riddler

- Development plan expands upon the learnings from Batman and Robin DSU's of TBSC and WFMP A co-development, which are geologically analogous to the Joker and Bane units



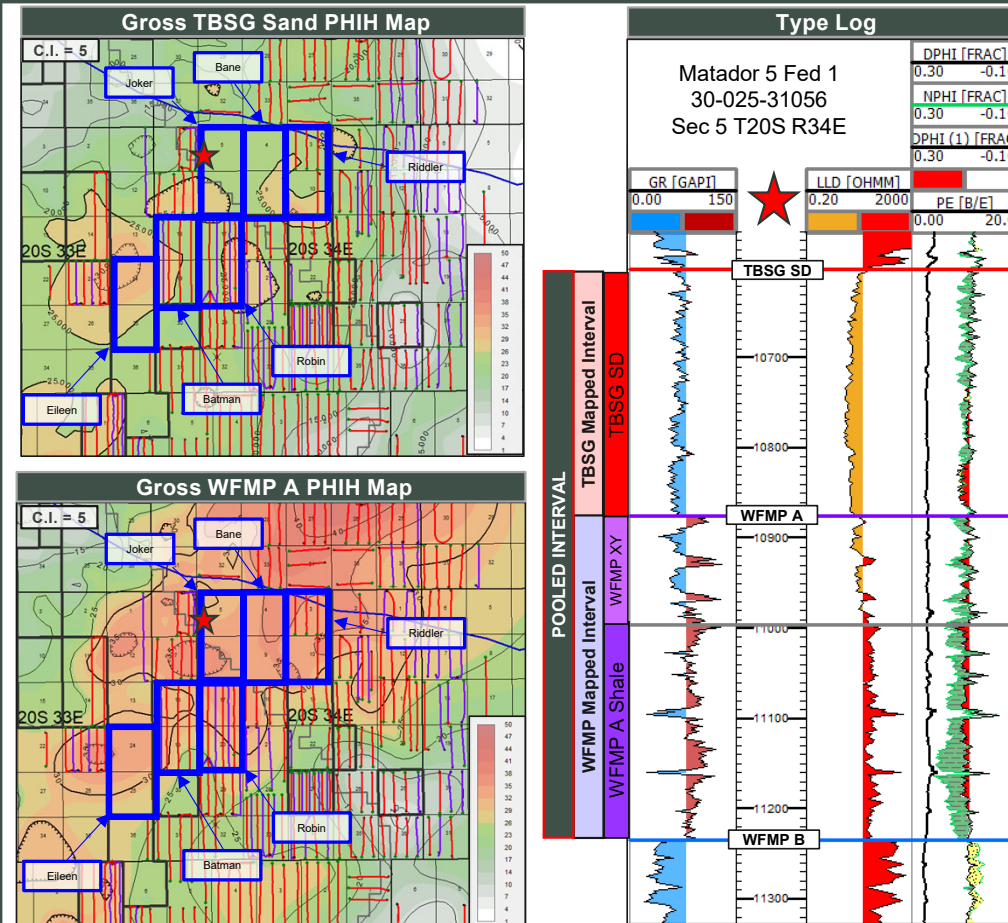

TBSG and WFMP A PHH Map Cutoff: DPHI > 4%

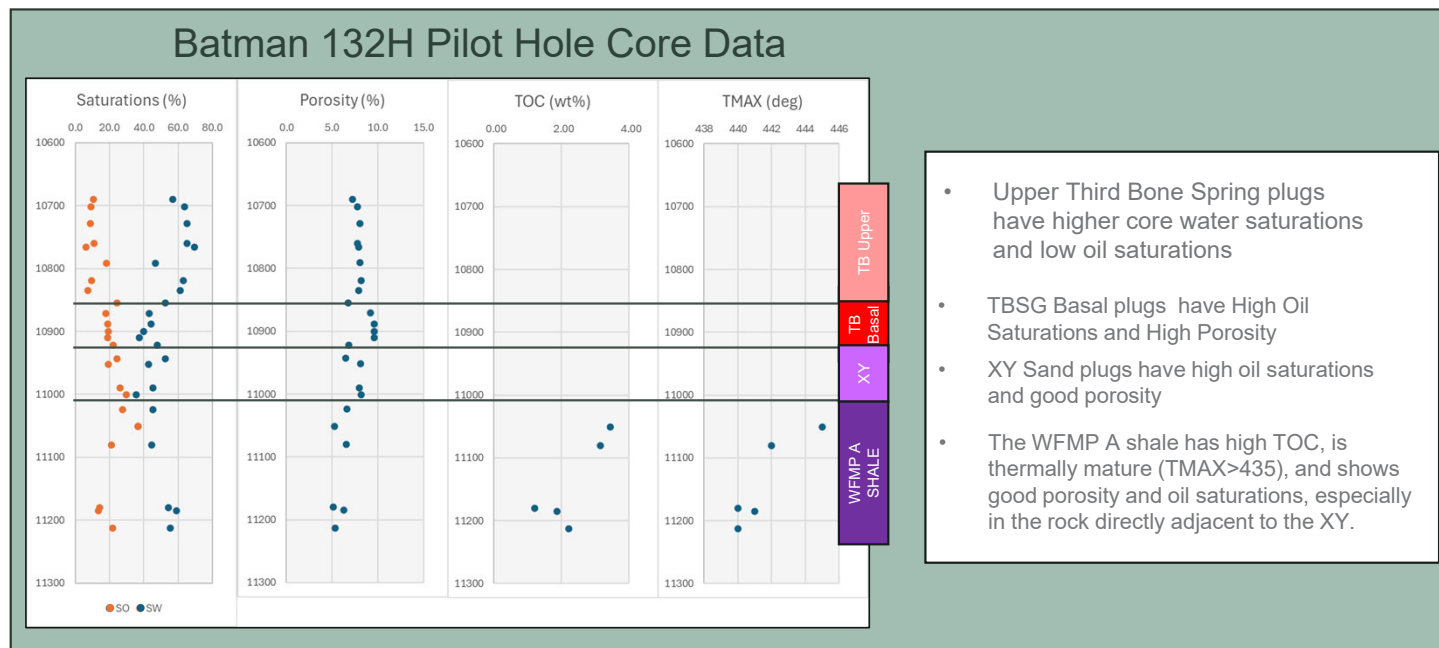
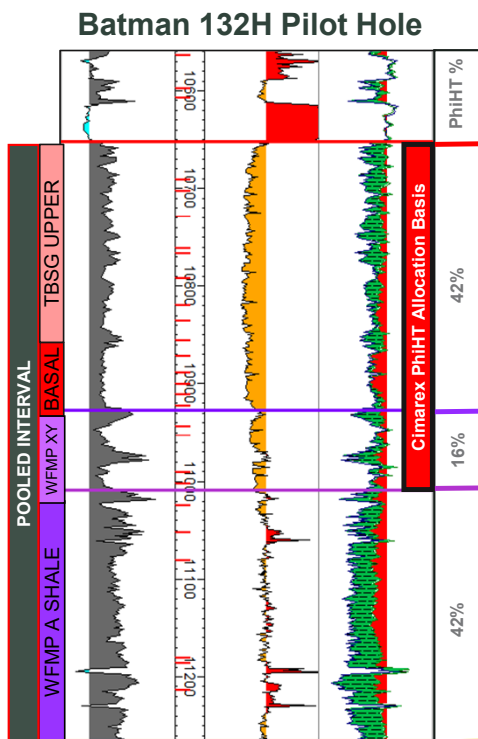

## Key Points

- The Wolfbone pooled interval encompasses 3 hydrocarbon bearing intervals that contribute reserves to wells drilled in the Pool: The Third Bone Spring Sand, The Wolfcamp XY Sand and the Wolfcamp A Shale
  - PR plans to target the Basal TBSG Lobe and Y Sand, which PR believes are the primary hydrocarbon bearing units in this Pool.
  - The WFMP A Shale and Upper TBSG contribute hydrocarbons to these wellbores to a lesser extent.
  - Due to a lack of baffles in the different reservoir units, it is impossible to accurately allocate out where the oil is being produced from in this Pool, so PR believes the only equitable way to honor depth-severed interests is to drill wells on both sides of the severance and allocate on a surface acreage basis.
- TBSG PHH Map
  - Calculated from the Top of Third Bone Spring Sand to the Top of Wolfcamp A using a greater than 4% Density Porosity Cutoff
  - Mapping shows that the TBSG in the Joker and Bane Unit's is analogous to recently co-developed PR Batman wells offset to the SW
- WFMP A PHH Map
  - Calculated from the Top of Wolfcamp A to the Top of Wolfcamp B using a greater than 4% Density Porosity Cutoff
  - Mapping shows that the WFMP A in the Joker and Bane Unit's is analogous to recently co-developed PR Batman wells offset to the SW

# Cimarex's Allocation formula ignores hydrocarbon bearing rocks in the WFMP A Shale

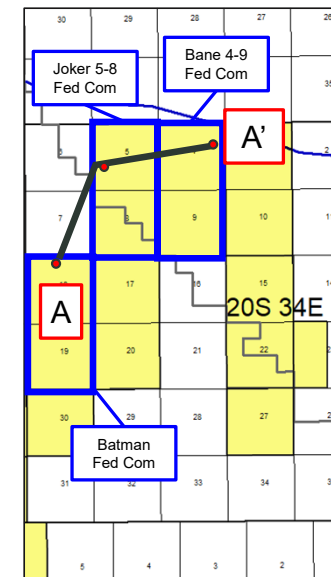
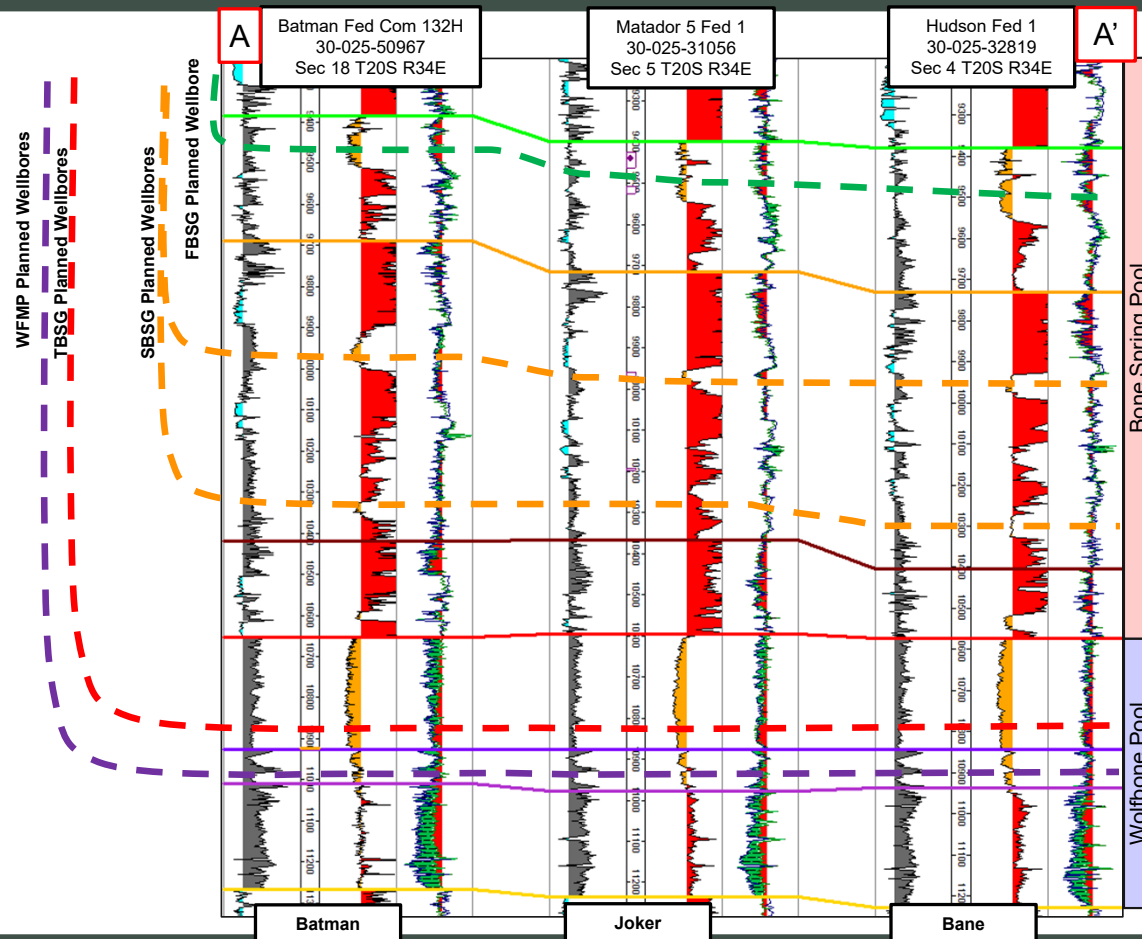


Cimarex's allocation formula completely ignores hydrocarbons contained in the Wolfcamp A shale, which is part of the Wolfbone pool. Core data indicates that the Wolfcamp A shale is a Porous, organic-rich, thermally mature, hydrocarbon rich shale, and offset wellbores targeting this interval in the Black and Tan and Little Bear projects prove that it is a productive hydrocarbon reservoir.

PR maintains the stance the PHIT is not sufficient to account for where the oil is being drained from in this pool since it does not account for differences in oil saturations or rock type.

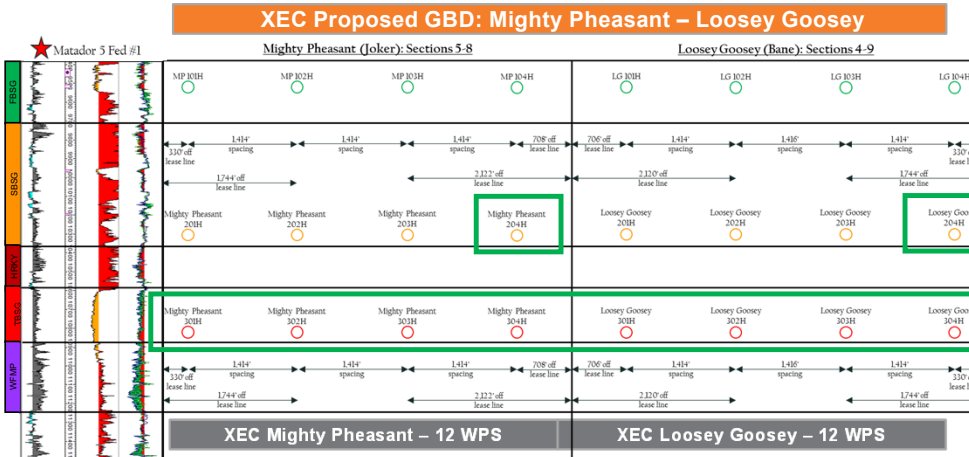
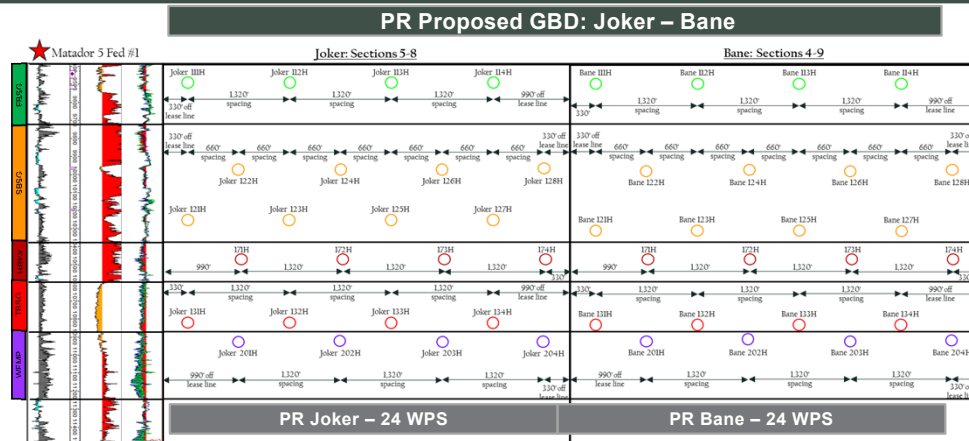
# Analogous Geology Across PR Development Plan Batman – Joker – Bane Units

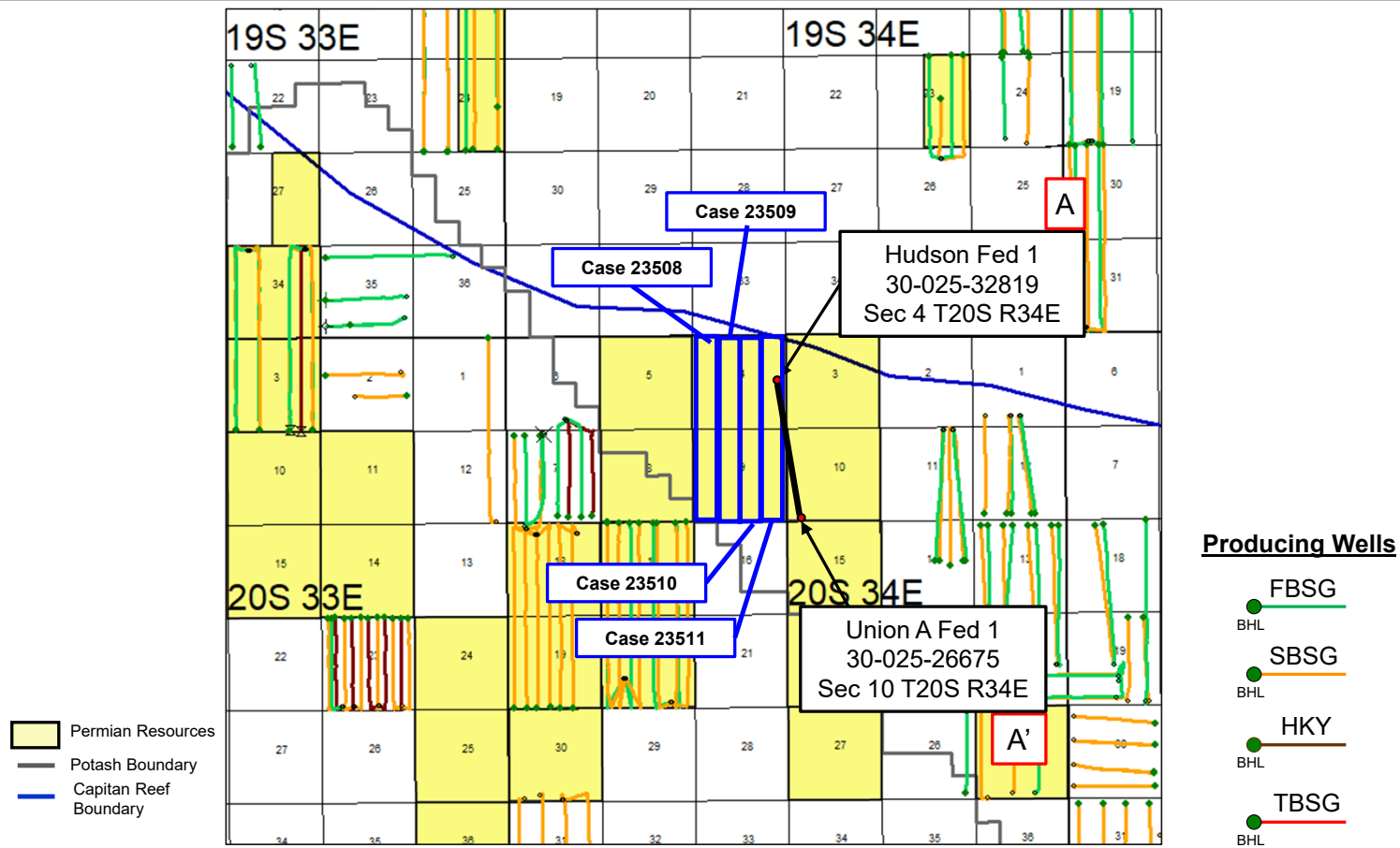

# Cross-Section Locator Map Bane 4-9 Fed Com Bone Spring

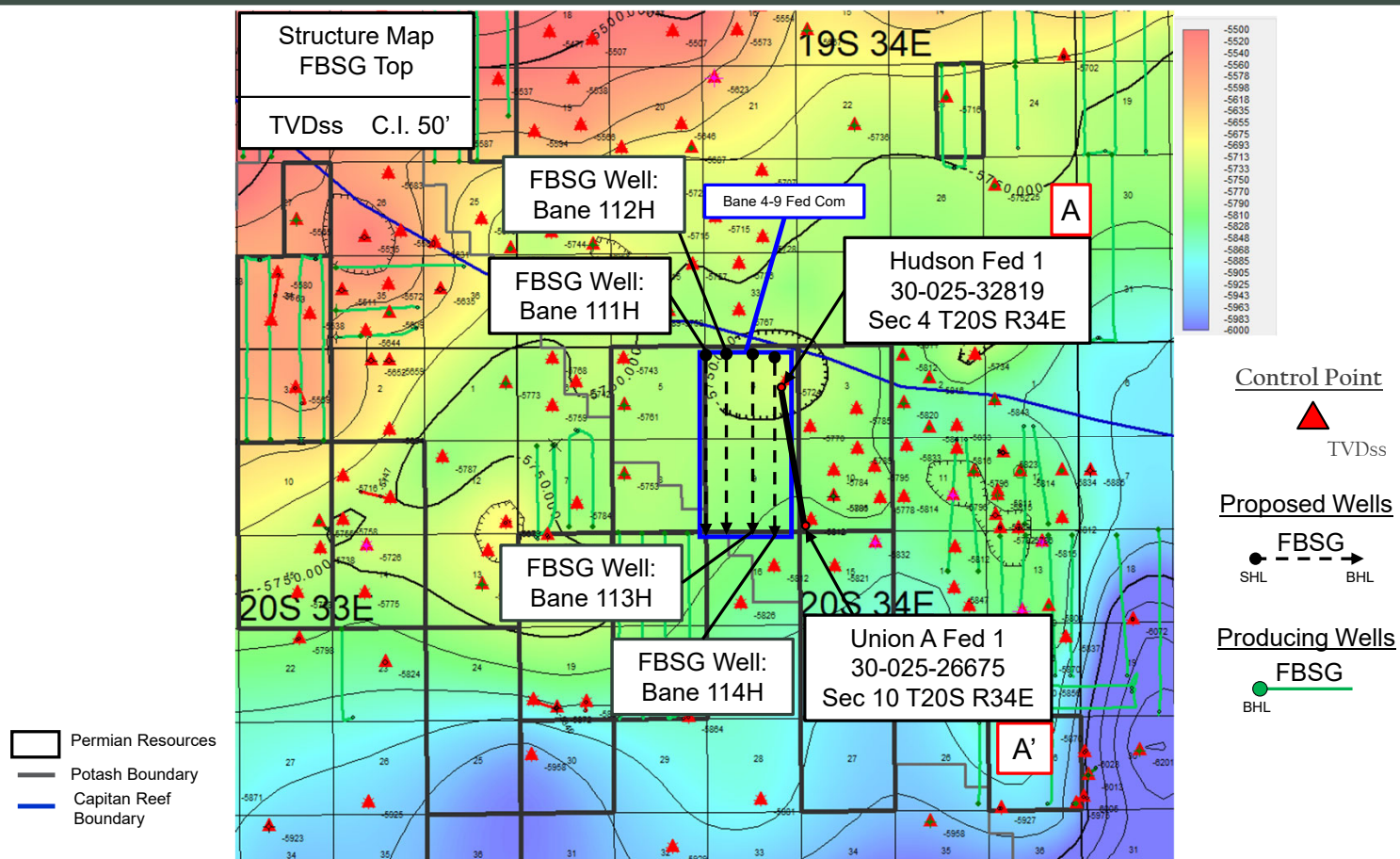

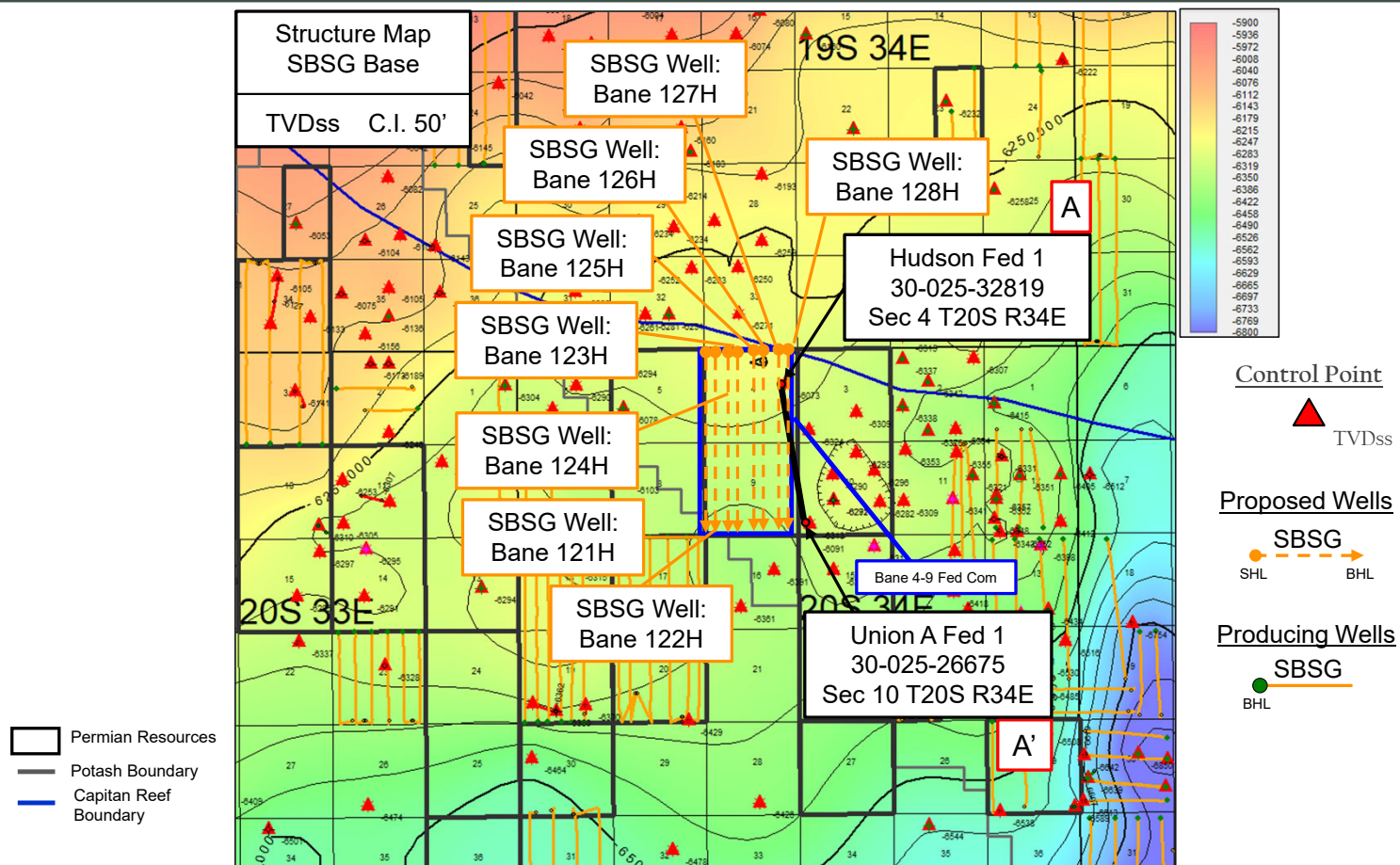




# Second Bone Spring – Structure Map

Bane 4-9 Fed Com 121H, 122H, 123H, 124H, 125H, 126H, 127H & 128H

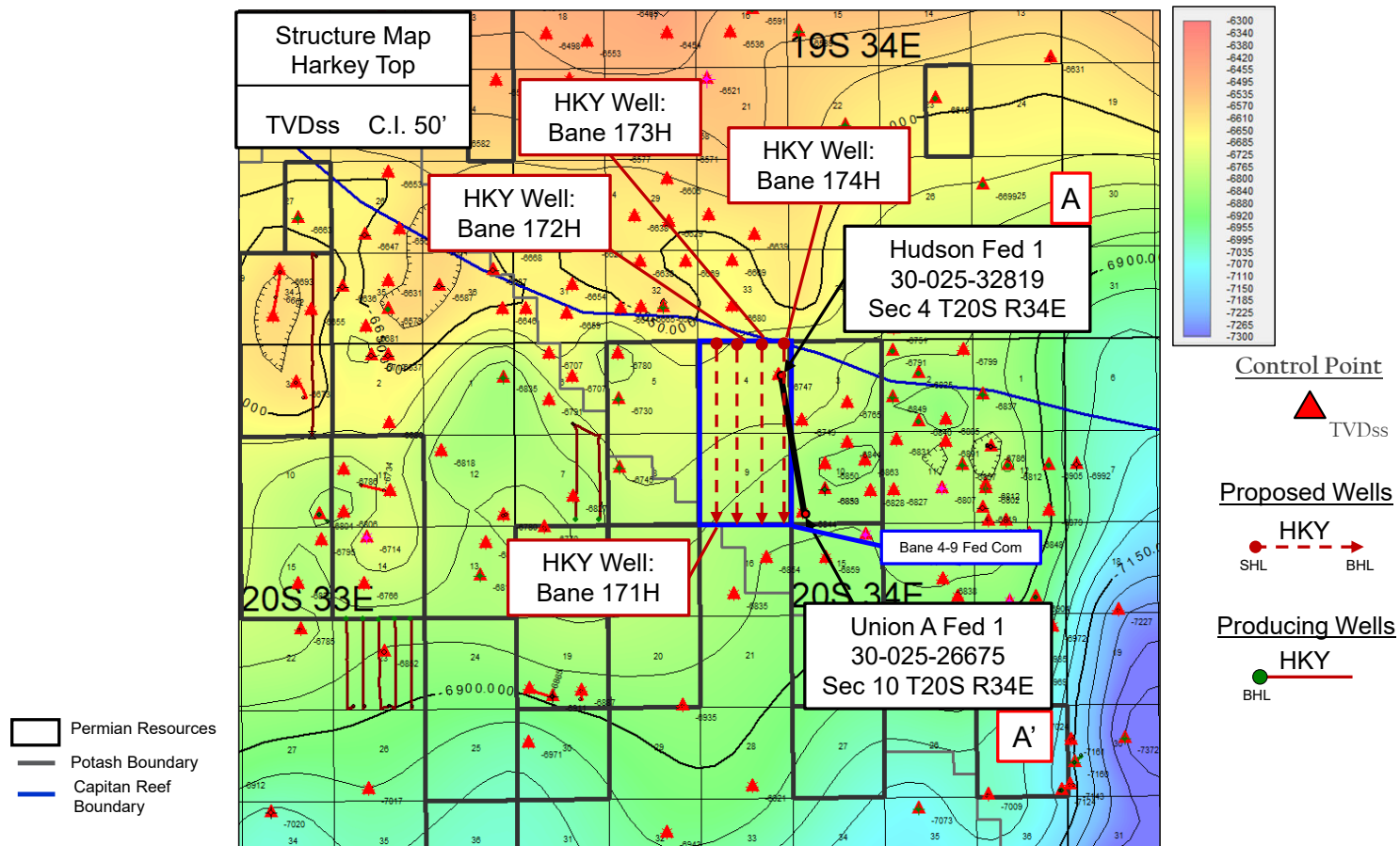

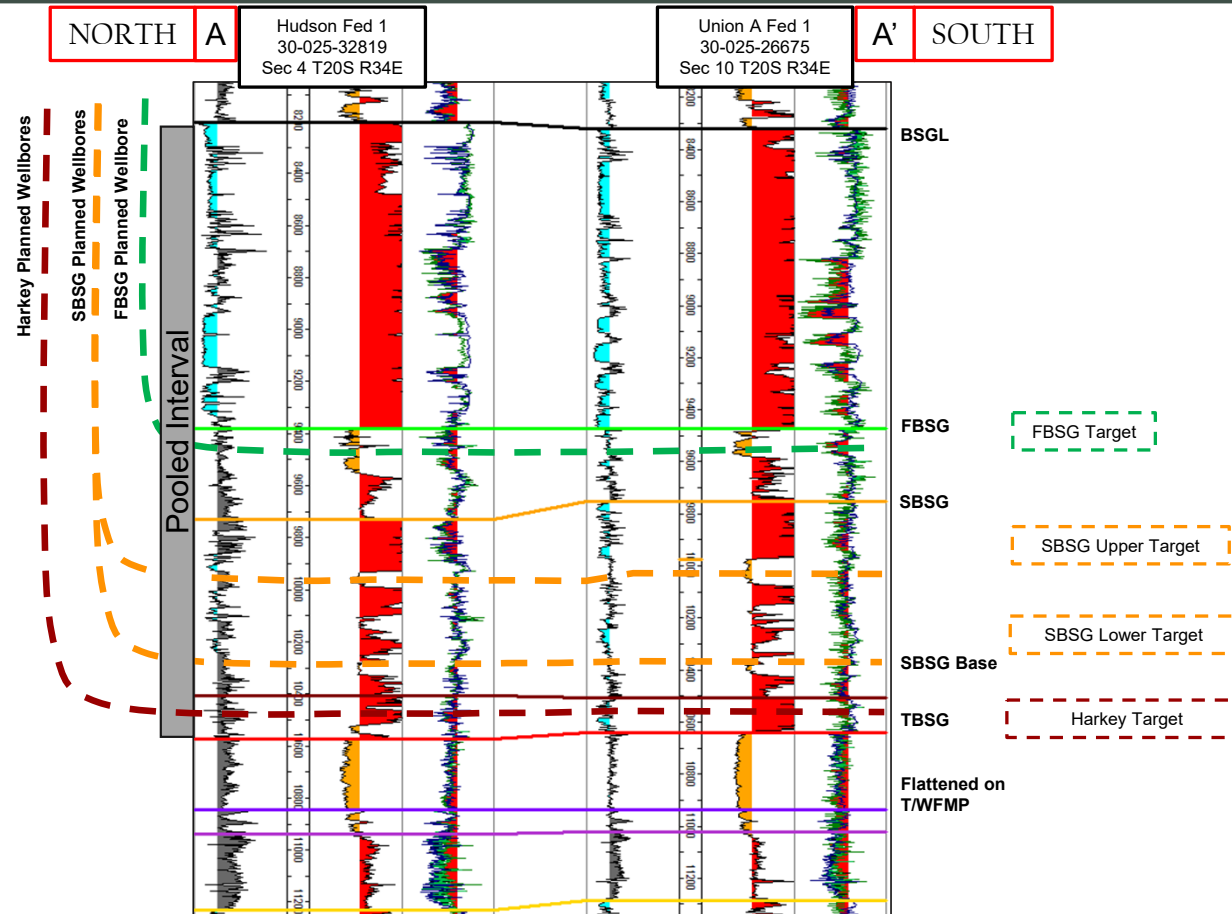

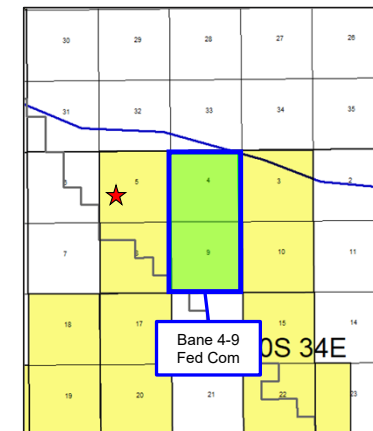


# Stratigraphic Cross-Section A-A'

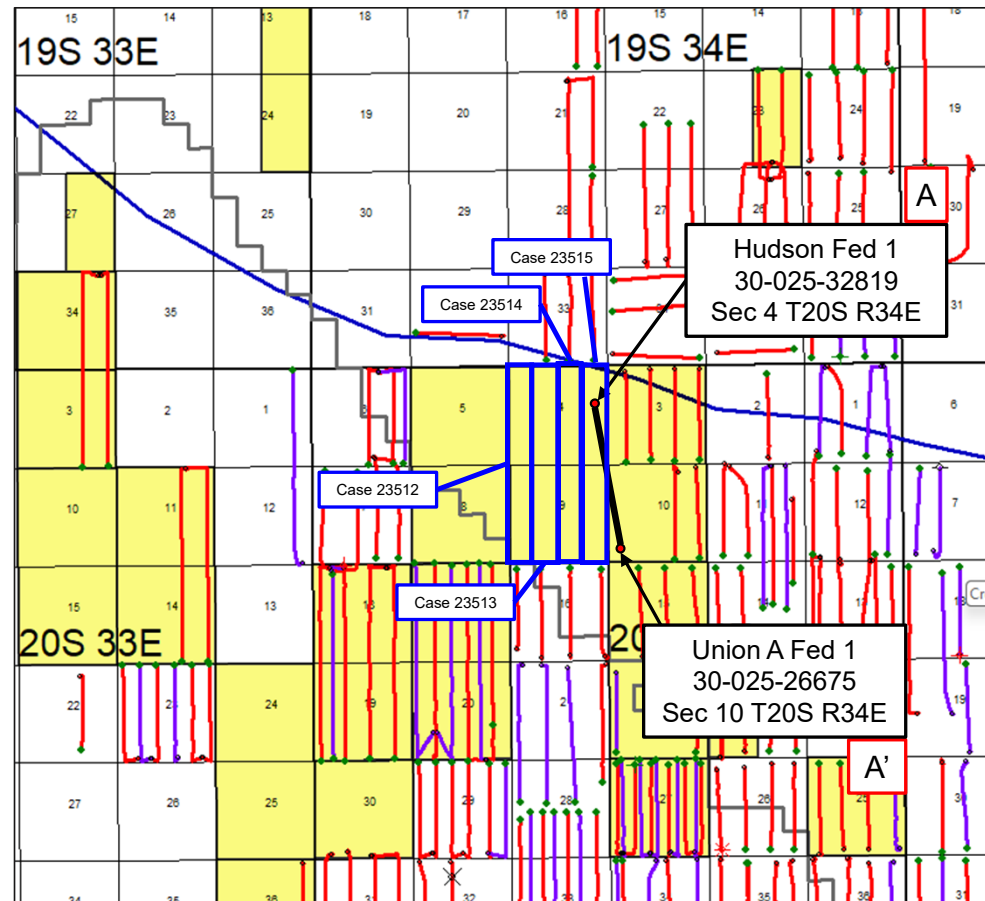

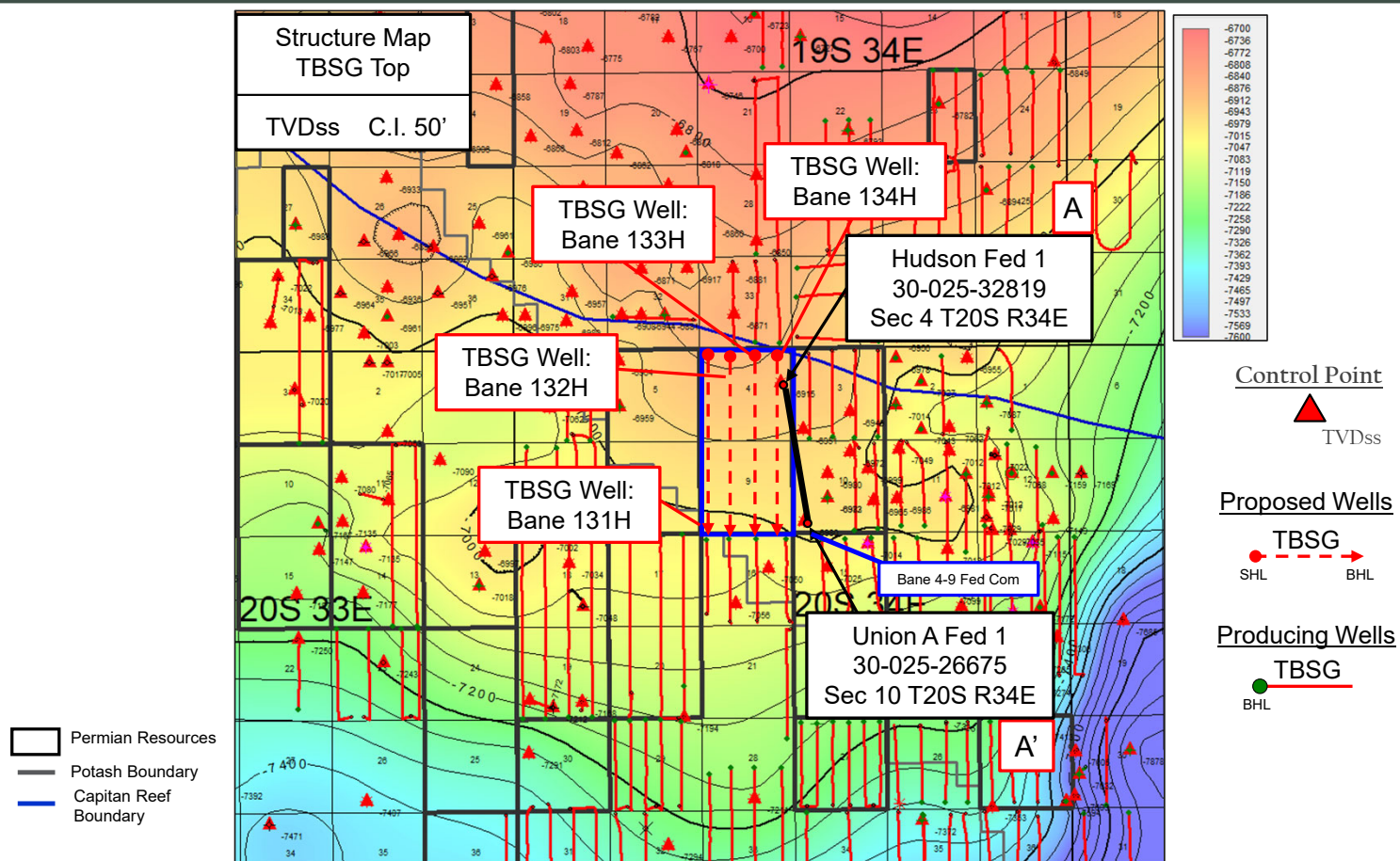




# Third Bone Spring – Structure Map

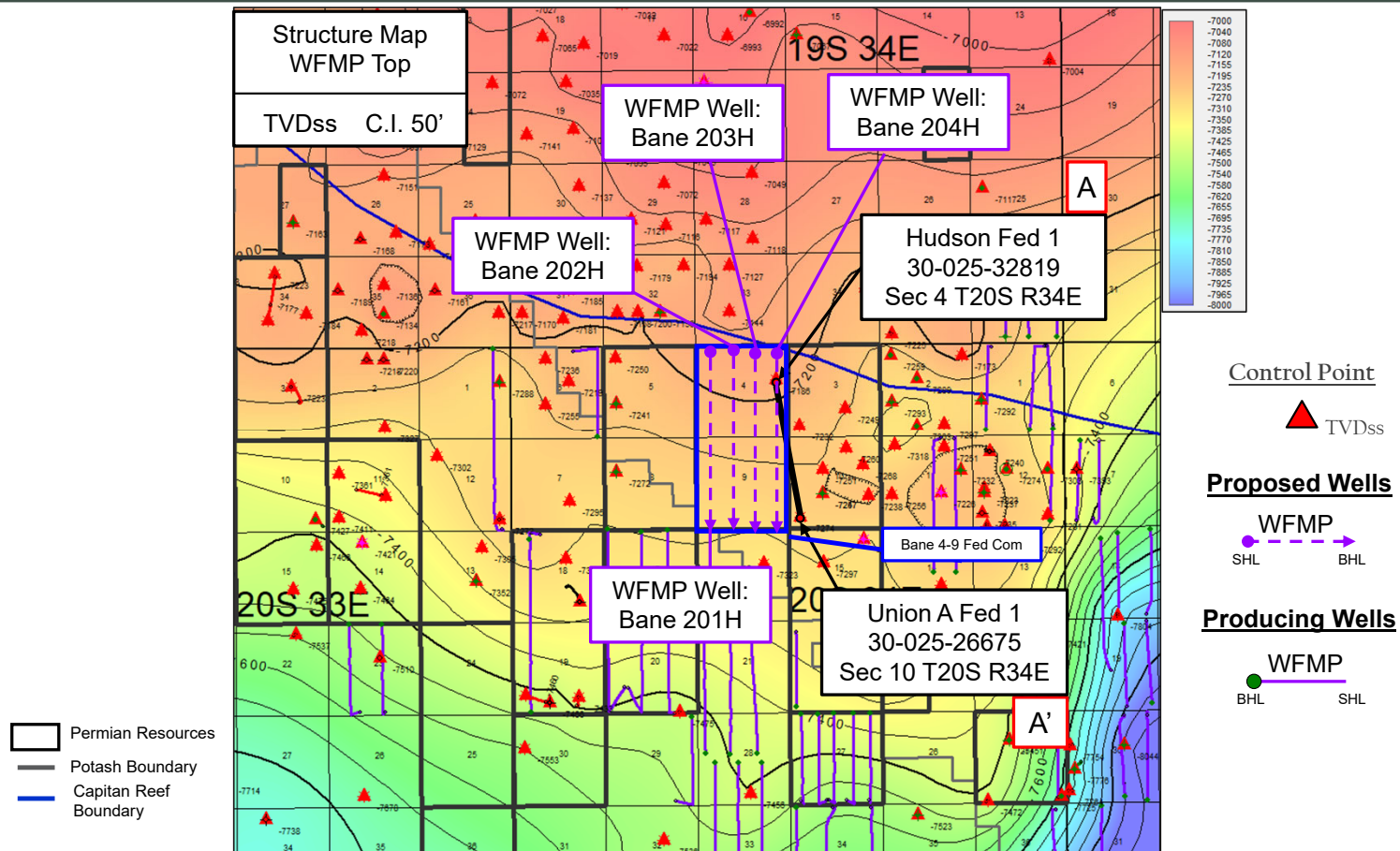

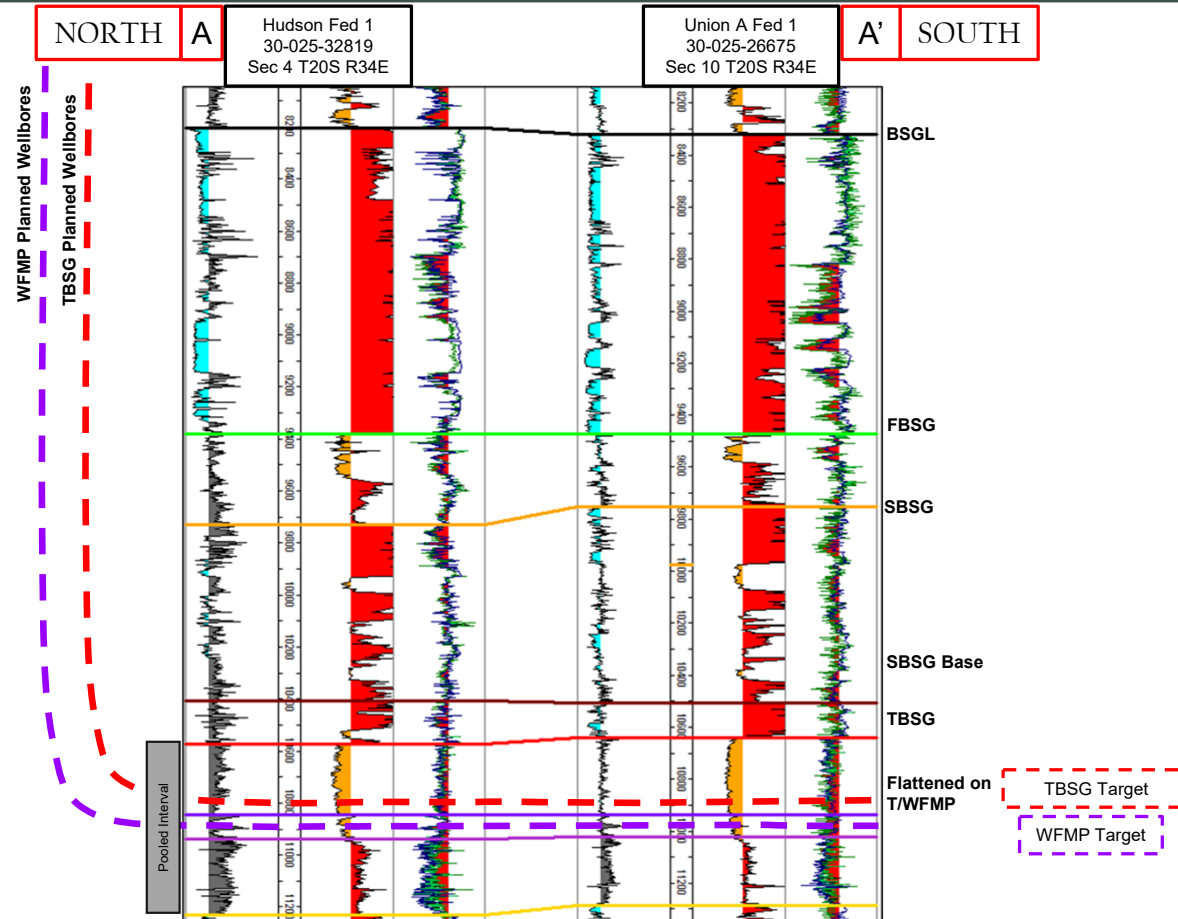




# Stratigraphic Cross-Section A-A'

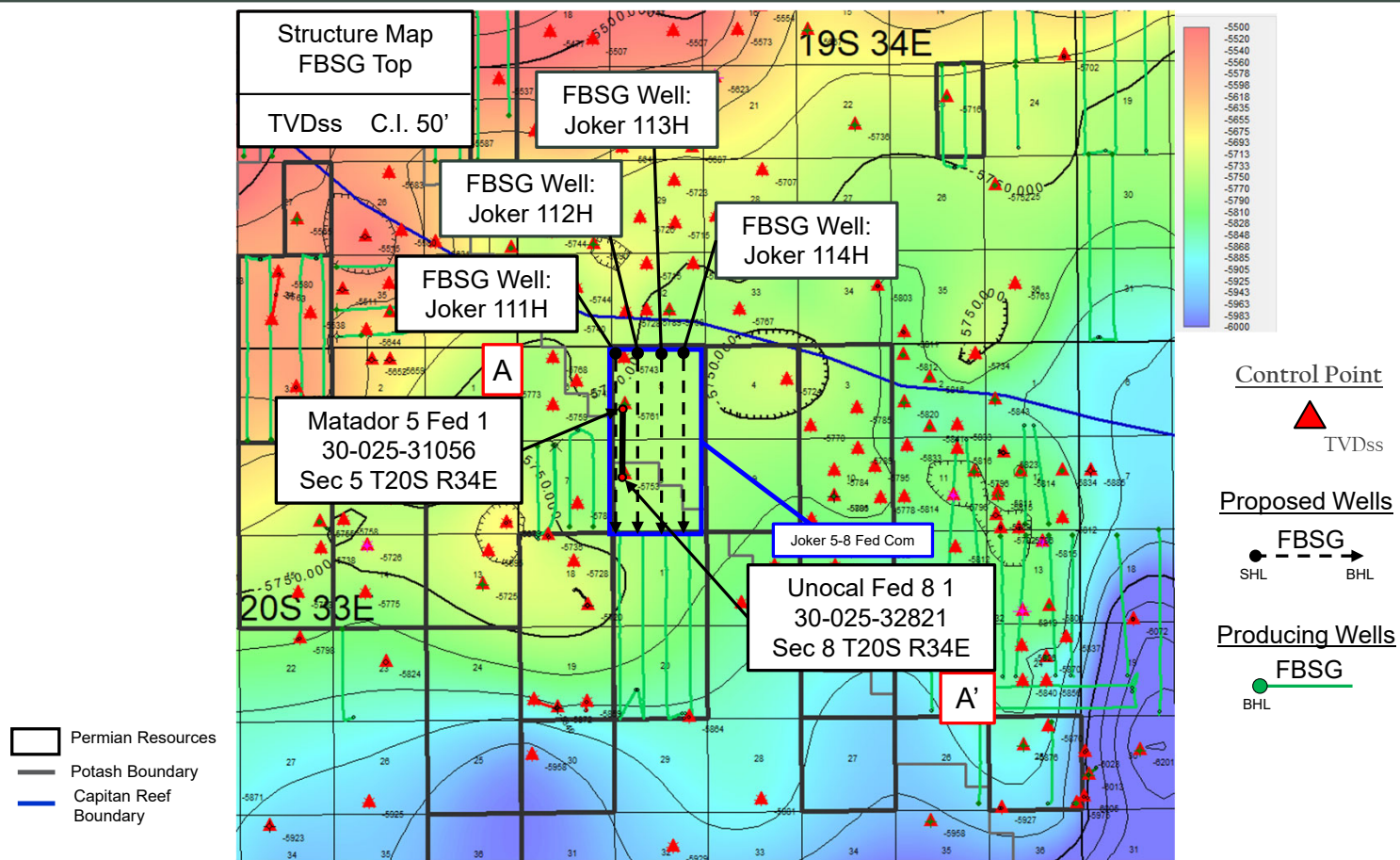




# First Bone Spring – Structure Map

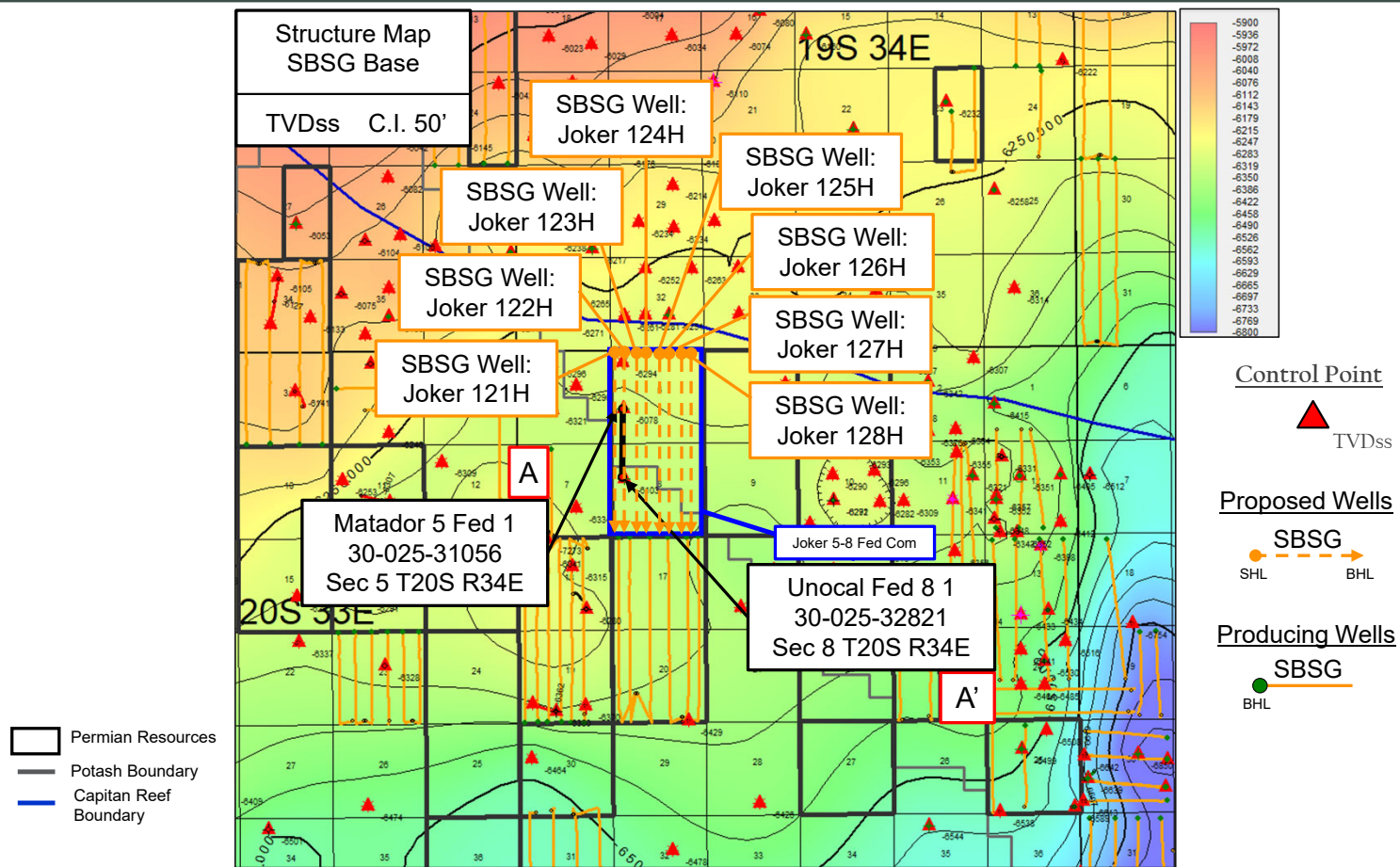




# Second Bone Spring – Structure Map
