COMPLIANCE AND ENFORCEMENT BUREAU FOR A COMPLIANCE
ORDER AGAINST CANO PETRO OF NEW MEXICO, INC., FOR WELLS
OPERATED IN CHAVES AND ROOSEVELT COUNTIES, NEW MEXICO.**

ORDER OF THE COMMISSION

THIS MATTER came before the New Mexico Oil Conservation Commission ("Commission") on two consolidated applications. In the first application for Case 16040, Cano Petro of New Mexico Inc. ("Cano") applied for a *de novo* review of a compliance order, Order No. R-14663, issued by the Oil Conservation Division after a hearing. In the second application, the Oil Conservation Division of the Energy, Minerals and Natural Resources Department Compliance and Enforcement Bureau ("OCD") applied for a hearing to obtain a compliance order against Cano for violations of 19.15.8, 19.15.17, 19.15.29, and 19.15.36 NMAC in Case 16359. Upon request by the OCD, the Commission Chair, noting the similar subject matter against the same operator, directed Case 16359 to be heard by the Commission and joined the two cases.

The Commission, having conducted a public hearing on August 20, 2018, and having considered the testimony and the record in this case, and being otherwise fully advised, enters the following findings, conclusions and order:

THE COMMISSION FINDS THAT:

1. Notice has been given of *de novo* hearing in Case 16040 and the Commission has jurisdiction over the parties and the subject matter herein.
2. Notice has been given of Case 16359 hearing as required by 19.15.4 NMAC and the Commission has jurisdiction over the parties and the subject matter herein.
3. In Case 16040, OCD seeks an order finding Cano in violation of the provisions of 19.15.5.9(A)(4) and 19.15.25.8 NMAC, directing Cano to return to compliance with 19.15.5.9(A)(4) and 19.15.25.8 NMAC within forty-five (45) days, and in the event of non-compliance, declaring the wells abandoned and authorizing OCD to plug the violating wells in accordance with a Division-approved plugging program to restore and remediate the location, recover costs from Cano's financial assurance as

permitted by 19.15.8.13 NMAC, and seek indemnification and costs as permitted by NMSA 1978, § 70-2-14(E).

4. In Case 16359, OCD seeks an order finding Cano in violation of the provisions of 19.15.8, 19.15.17, 19.15.29, and 19.15.36 NMAC, and directing Cano to return to compliance with 19.15.8, 19.15.17, 19.15.29, and 19.15.36 NMAC by a date certain.

5. Cano is a foreign profit corporation that operates three hundred twenty-three (323) wells in Chaves and Roosevelt Counties, New Mexico, under OGRID No. 248802. Cano is registered with the New Mexico Secretary of State under entity number 2851087. OCD identified Richard Nichols, President, Orville Nichols, Secretary, Phillip Burch, Chief Financial Officer, and John Archer, President, as officers of record. Rick Harris, E&P Director, is listed as the point of contact in internal OCD records.

6. U.S. Specialty Insurance, which is a surety on bonds held by Cano, was notified of the proceeding in Case 16040 as required by 19.15.8.13(A) NMAC and entered an appearance but did not appear at the August 20, 2018 Commission hearing. U.S. Specialty Insurance requested a continuance on behalf of Cano, which was opposed by OCD, and the Commission declined to grant the request.

7. OCD presented testimony on violations of 19.15.5.9(A)(4), 19.15.25.8, and 19.15.8 NMAC from OCD Compliance and Enforcement Manager, Daniel Sanchez, who had personally reviewed relevant Division records and visited numerous Cano sites, most recently on July 9, 2018. Mr. Sanchez testified that:

- a. Cano currently has two hundred ninety-one (291) wells out of compliance with 19.15.25.8 NMAC, which requires wells to be properly plugged and abandoned within ninety (90) days after a period of one year in which a well has been continually inactive. *See Exhibit 1: Inactive Well List;*
- b. As an operator of three hundred twenty-three (323) wells, Cano is permitted to have no more than five (5) wells out of compliance with 19.15.25.8 NMAC to remain in compliance with 19.15.5.9 NMAC;
- c. On June 20, 2017, OCD sent Cano notice that it was out of compliance with 19.15.5.9 NMAC and that OCD would seek formal compliance proceedings in accordance with the notice provisions of 19.15.5.9(B) NMAC;
- d. Cano's inactive well total has steadily increased since 2012, including increasing from two hundred sixty-nine (269) to two hundred ninety-one (291) between April 5, 2018 and August 20, 2018;

- e. During his site visit on July 9, 2018, Mr. Sanchez visited twenty-one (21) well sites and noted only one (1) had equipment that would make it capable of production;
- f. Cano has furnished OCD with eighty (80) single well bonds on file with OCD for a total amount of \$688,617.00 and one blanket bond filed with OCD, bond no. B003422, for the amount of \$50,000.00, from U.S. Specialty Insurance. *See Exhibit 2: Cano Bonding Status;* and
- g. Cano requires additional financial assurance for fourteen (14) wells, requiring a total of \$120,200.00.

8. The Commission took administrative notice of Commission Order No. R-9210, where the Commission adopted the current rule on plugging and abandonment. In Order No. R-9210 finding paragraph 5, the Commission found that “[t]he proposed rules on abandonment will prevent migration of fluids, prevent waste, protect correlative rights and protect fresh water.”

9. OCD presented testimony on violations of 19.15.17, 19.15.29, and 19.15.36 NMAC from its Environmental Bureau Chief, Jim Griswold, who reviewed Division records and visited numerous Cano sites, most recently on July 9, 2018. Mr. Griswold testified that:

- a. Cano had eight (8) open remediation permits as follows:

- b. Upon personal inspection, the Cato #6 Tank battery has multiple reported and un-reported releases that were existing and on-going at the site and required immediate corrective action because groundwater

- was within one hundred (100) feet below ground surface, and given the volume and duration of the releases, could be impacted;
- c. To address the release at the Cato #6 Tank Battery, Cano will need to perform the following actions based on 19.15.29 NMAC and best management practices in the field:
- i. Drain and properly dispose of all liquids from the tanks;
 - ii. Remove and relocate the tanks, piping, and other infrastructure;
 - iii. Remove and properly dispose all liner(s);
 - iv. Investigate the vadose zone beneath the battery for adsorbed contamination by crude oil and produced water;
 - v. If the soils beneath the battery are contaminated, excavate and backfill with clean soils; and
 - vi. If soil contamination has impacted groundwater, perform a hydrogeologic investigation of the extents of that contamination and develop an appropriate abatement program;
- d. Upon review of aerial photographs, there are eight (8) open pits that exist on sites operated by Cano. Mr. Griswold was able to visit four (4) but did not have sufficient time to visit all of Cano's sites;
- e. To address the unclosed pits, Cano will need to perform the follow actions based on 19.15.17 NMAC and best management practices in the field:
- i. Remove and properly dispose pit contents;
 - ii. Remove and properly dispose pit liners;
 - iii. Sample and analyze soils beneath the pit for concentrations of adsorbed chloride, total petroleum hydrocarbons, benzene, toluene, ethylbenzene, and total xylenes;
 - iv. If the soils are found to be contaminated in excess of the pertinent standards, the extents of the soil contamination must be determined and contaminated soil must be excavated;
 - v. Properly backfill the pit area, even if the soils are not adversely impacted; and

- vi. If soil contamination has impacted groundwater, perform a hydrogeologic investigation of the extents of that contamination so an appropriate abatement program can be developed;
- f. Upon inspection, Mr. Griswold identified two (2) stockpiles of contaminated soil on sites operated by Cano. The stockpiles were in violation of the provisions of 19.15.36 NMAC governing the operation of surface waste management facilities;
- g. To address the stockpiles of waste, Cano will need to perform the following actions based on 19.15.36 NMAC and best management practices in the field:
 - i. Remove and properly dispose contaminated soil;
 - ii. Remove and properly dispose any liners;
 - iii. Investigate the vadose zone beneath the stockpiles for adsorbed contamination by crude oil and produced water;
 - iv. If the soils beneath the stockpiles are contaminated, excavate and backfill with clean soils; and
 - v. If soil contamination has impacted groundwater, perform a hydrogeologic investigation of the extents of that contamination so an appropriate abatement program can be developed;

10. The Commission adopted the closure requirements, as well as the other requirements of 19.15.17 NMAC (commonly known as the "pit rule") to ensure that the design, operation, closure, and revegetation standards for pits are protective of groundwater, public health, and the environment. OCC Order No. R-13506-D pg. 44, para. S. Pits that are not in compliance with 19.15.17 NMAC pose a threat to groundwater.

11. OCD presented testimony from the New Mexico State Land Office Units and Commingle Manager, Marilyn Gruebel, who presented the unit agreement between Cano, the State Land Office, and the Bureau of Land Management for operations on the Cato Unit. The Cato Unit is comprised of a large number of Cano's wells. The unit agreement contains provisions requiring the operator to submit a plan of development, which Cano has not submitted to the State Land Office. The unit agreement also contains language relating to how the operations in the field must eliminate waste. The State Land Office does not believe Cano is operating within the parameters of the unit agreement.

THE COMMISSION CONCLUDES THAT:

1. Based on the evidence presented, the Commission finds that Cano is in violation of:
 - a. 19.15.25 NMAC (failure to properly plug and abandon two hundred ninety-one (291) wells);
 - b. 19.15.5.9 NMAC (having too many wells that are out of compliance with 19.15.25.8 NMAC);
 - c. 19.15.8 NMAC (not providing the Division with adequate financial assurance);
 - d. 19.15.17 NMAC (having eight (8) pits that are not closed);
 - e. 19.15.29 NMAC (having major releases of oil, produced water, and other oilfield waste that are not reported, nor cleaned up pursuant to a Division-approved remediation or abatement plan); and
 - f. 19.15.36 (having stockpiles of waste improperly stored in an unpermitted surface waste management facility).
2. The violations threaten public safety, the environment, and fresh water.
3. The violations, particularly the environmental violations that were reported years ago and not remediated, are knowing and willful.

IT IS THEREFORE ORDERED THAT:

1. Cano has forty-five (45) days to resolve its violations of 19.15.25.8 and 19.15.5.9 NMAC. Compliance can include entering into an agreed compliance order that includes a schedule to return to compliance and a plan of development.
2. Cano has forty-five (45) days to provide the division with the requisite financial assurance as required by 19.15.8 NMAC.
3. Cano has forty-five (45) days to submit a delineation plan for environmental contamination at the Cato #6 Tank Battery and associated well sites.
4. Cano has forty-five (45) days to submit delineation plans, including a schedule for remediation, for the following sites with reported releases:

5. Cano has forty-five (45) days to resolve its violations of 19.15.17 NMAC regarding the eight (8) unclosed pits identified by OCD.

6. Cano has forty-five (45) days to resolve its violations of 19.15.36 NMAC regarding the two (2) stockpiles of contaminated soil identified by OCD.

7. Cano has forty-five (45) days to assess all remaining sites for other releases, and if discovered, perform remedial actions as required by 19.15.29 and 19.15.30 NMAC.

8. If after forty-five (45) days, Cano has not performed the work described in Ordering Paragraph (1), Cano shall be in violation of this Order and the Commission authorizes the Division to:

- a. plug and abandon the well or wells operated by Cano that are out of compliance with Commission rules in accordance with Division-approved plugging programs;
- b. restore and remediate the well locations;
- c. direct forfeiture of the applicable financial assurance of Cano;
- d. recover plugging, restoration, and remediation costs from Cano's financial assurance as permitted by 19.15.8.13 NMAC; and
- e. seek indemnification and costs from Cano as provided in Subsection E of NMSA 1978, § 70-2-14 if there are not sufficient funds recovered from financial assurance to cover all costs the Division incurs while plugging and abandoning the wells and restoring and remediating the well locations.

9. If after forty-five (45) days, Cano has not performed the work described in Ordering Paragraph (2)-(7), Cano shall be in violation of this Order and the Commission shall authorize the Division to pursue its own cleanup in accordance with 19.15.29 and 19.15.30 NMAC and seek to recoup expenses from a court of competent jurisdiction.

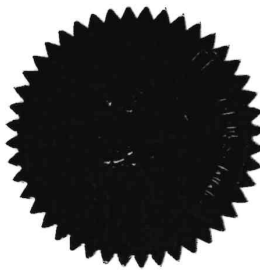

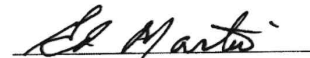
11. Jurisdiction of this case is retained for the entry of such further orders as the Commission may deem necessary.

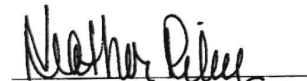
