Devon Energy Production Company, L.P. ("Devon"), OGRID No. 6137, through its undersigned attorneys, hereby files this Application with the Oil Conservation Division ("Division") pursuant to the provisions of NMSA 1978, § 70-2-17, for an order pooling all uncommitted mineral interests in the Bone Spring formation, designated as an oil pool, underlying a standard 640-acre, more or less, spacing unit comprised of the S/2 of Sections 15 and 16, all in Township 21 South, Range 27 East, NMPM, Eddy County, New Mexico. In support of its Application, Devon states the following:

- 1. Devon is a working interest owner in the proposed horizontal spacing unit ("HSU") and has a right to drill a well thereon.
- Devon proposes and dedicates to the HSU the Cedar Hills 15-16 State Com 335H
 Well, as the initial well, to be drilled to a sufficient depth to test the Bone Spring formation.
- 3. Devon proposes the Cedar Hills 15-16 State Com 335H Well, an oil well, to be horizontally drilled from a surface location in the SW/4 SW/4 (Unit M) of Section 14 to a bottom hole location in the NW/4 SW/4 (Unit L) of Section 16. The Cedar Hills 15-16 State Com 335H Well, is the proximity well, positioned so the unit can include proximity tracts, thereby incorporating the S/2 S/2 of Sections 15 and 16.

- 4. The well proposed herein is orthodox in its location; the take points and completed intervals will comply with setback requirements under statewide rules.
- 5. Devon has sought in good faith, but has been unable to obtain voluntary agreement from all interest owners to participate in the drilling of the wells or in the commitment of their interests to the wells for their development within the proposed HSU.
- The pooling of all interests in the Bone Spring formation within the proposed HSU
 will avoid the drilling of unnecessary wells, prevent waste and protect correlative rights.
- 7. In order to provide for its just and fair share of the oil and gas underlying the subject lands, Devon requests that all uncommitted interests in this HSU be pooled and that Devon be designated the operator of the proposed horizontal well and HSU.

WHEREFORE, Devon requests that this Application be set for hearing on September 11, 2025, before an Examiner of the Oil Conservation Division, and after notice and hearing as required by law, the Division enter an order:

- A. Pooling all uncommitted mineral interests in the Bone Spring formation, designated as an oil pool, underlying a standard 640-acre, more or less, spacing unit comprised of the S/2 of Sections 15 and 16, all in Township 21 South, Range 27 East, NMPM, Eddy County, New Mexico.
 - B. Approving the Cedar Hills 15-16 State Com 335H Well, as the well for the HSU.
- C. Designating Devon as operator of this HSU and the horizontal well to be drilled thereon;
- D. Authorizing Devon to recover its costs of drilling, equipping, and completing the well;

- E. Approving actual operating charges and costs of supervision, to the maximum extent allowable, while drilling and after completion, together with a provision adjusting the rates pursuant to the COPAS accounting procedures; and
- F. Setting a 200% charge for the risk assumed by Devon in drilling and completing the well in the event a working interest owner elects not to participate in the wells.

SELF-AFFIRMED STATEMENT OF JAKE NOURSE

I, Jake Nourse, state and affirm the following:

- I am over the age of eighteen years and have the capacity to execute this Self-Affirmed Statement, which is based on my personal knowledge.
- I am employed as a Staff Landman with Devon Energy Production Company, L.P.
 ("Devon"), and I am familiar with the subject application and the lands involved.
- 3. I have previously testified before the New Mexico Oil Conservation Division ("Division") as an expert witness in petroleum land matters and my credentials have been accepted by the Division and made a matter of record.
- 4. This affidavit is submitted in connection with Devon's filing of the abovereferenced spacing and compulsory pooling applications pursuant to 19.15.4.12.A(1).
- 5. Devon seeks an order pooling all uncommitted mineral interests in the Bone Spring formation (Carlsbad, Bone Spring, East [96144]), designated as an oil pool, underlying a standard 640-acre, more or less, spacing unit comprised of the S/2 of Sections 15 and 16, all in Township 21 South, Range 27 East, NMPM, Eddy County, New Mexico.
 - Under <u>Case No. 25527</u>, Devon seeks to dedicate to the unit as an initial well the <u>Cedar Hills 15-16 State Com 335H Well</u> (API PENDING) to be horizontally drilled from a



surface location in the SW/4 SW/4 (Unit M) of Section 14 to a bottom hole location in the NW/4 SW/4 (Unit L) of Section 16; approximate TVD of 8,715'; approximate TMD of 19,168'; FTP in Section 15: 1,422' FSL, 100' FEL; LTP in Section 16: 1,422' FSL, 100' FWL. The **Cedar Hills 15-16 State Com 335H Well**, is the proximity well, positioned so the unit can include proximity tracts, thereby incorporating the S/2 S/2 of Sections 15 and 16.

- 6. **Devon Exhibit A-1** contains the proposed C-102 for the one (1) well.
- 7. **Devon Exhibit A-2** contains a general location plat and a plat outlining the unit being pooled, which shows the location of the proposed well within the unit. The well proposed herein is orthodox in its location; the take points and completed intervals will comply with setback requirements under statewide rules. **Devon Exhibit A-2** also includes the parties being pooled, the nature of their interests, and information regarding the working interest owners, overriding royalty interest owners, and record title owners to be pooled.
 - 8. There are no depth severances in the Bone Spring formation in this acreage.
 - 9. A good faith review of records did not reveal any overlapping units.
- 10. **Devon Exhibit A-2** also contains a list of names and addresses for the uncommitted interest owners I provided to the law firm of Abadie & Schill P.C. In compiling these addresses, I conducted a diligent search of the public records in Eddy County, New Mexico, where the well is located, and of phone directories and did computer searches to locate the contact information for parties entitled to notification. All Working Interest Owners were locatable and notice letters were mailed. All letters are listed as delivered except those letters to Red Sands Resources LLC, Keith Williams, Alpha Energy Partners II, LLC, Calmetto Energy, and Explorers Petroleum Corporation which are listed as Mailed In-Transit or Mailed-Available for Pickup. Devon published notice in the Carlsbad Current-Argus, a newspaper of general circulation in Eddy

County, New Mexico, to account for any unlocatable parties and cover any contingencies regarding notice.

- 11. **Devon Exhibit A-3** is a sample proposal letter and the AFEs for the proposed well. The estimated cost of the well set forth in the AFEs is fair, reasonable, and comparable to the costs of other wells of similar depths and lengths drilled in this area of New Mexico.
- 12. The interest owners being pooled have been contacted regarding the proposed well but have failed or refused to voluntarily commit their interest in the well. However, Devon has been in ongoing discussions with some of the interest owners to voluntarily enter into a Joint Operating Agreement. If a mutually agreeable Joint Operating Agreement is reached between Devon and another interest owner or owners, Devon requests that the voluntary agreement become operative and supersede the Division's order for said parties, except to the extent the Division deems it necessary to maintain spacing criteria for the purpose of conservation, the prevention of waste, and protection of correlative rights.
- 13. **Devon Exhibit A-4** provides a chronology and history of contacts with the owners. Devon has made a good faith effort to negotiate with the interest owners but has been unable to obtain a voluntary agreement from all interest owners to participate in the drilling of the well or in the commitment of their interests to the well for its development within the proposed horizontal spacing unit.
- 14. Devon asks that any unleased mineral be pooled pursuant to the statutory royalty rate of one-eighth (1/8).
- 15. Devon requests overhead and administrative rates of \$10,000/month for drilling each well and \$1,000/month for producing each well. These rates are fair and comparable to the rates charged by other operators for wells of this type in this area of southeastern New Mexico.

Devon requests that these rates be adjusted periodically as provided in the COPAS Accounting Procedure.

- 16. Devon requests the maximum cost, plus 200% risk charge be assessed against non-consenting working interest owners to the extent needed.
 - 17. Devon requests that it be designated operator of the unit and well.
- 18. The Exhibits to this Statement were prepared by me or compiled from Devon's company business records under my direct supervision.
- 19. The granting of this Application is in the best interests of conservation, the prevention of waste, and the protection of correlative rights, and will avoid the drilling of unnecessary wells.
 - 20. The foregoing is correct and complete to the best of my knowledge and belief.



SELF-AFFIRMED STATEMENT OF JOE DIXON

I, Joe Dixon, affirm and state the following:

- 1. I am over the age of 18, and I have personal knowledge of the matters stated herein.
- I am employed as a petroleum geologist for Devon Energy Production Company, L.P.
 ("Devon"), and I am familiar with the subject application and the geology involved.
- 3. I have testified previously by affidavit before the Oil Conservation Division ("Division") as an expert petroleum geologist; my credentials have been made a matter of record, and I have been qualified as an expert by the Division.
 - a. I have a Bachelor of Science Degree in Geology from Purdue University and a
 Master of Science Degree in Geology from Oklahoma State University.
 - b. I have worked on New Mexico Oil and Gas matters since November 2020.
- 4. This affidavit is submitted in connection with the filing by Devon of the above-referenced compulsory pooling application pursuant to 19.15.4.12.A(1) NMAC.
- 5. **Devon Exhibit B-1** is an area map showing the location of Devon's proposed spacing units outlined in red with arrows depicting the orientation and general location of the initial wells targeting the 3rd Bone Spring Sandstone. This map also shows the existing wells in the surrounding sections that are completed in the 3rd Bone Spring Sandstone (depicted in red).



- 6. The initial target for the proposed wells is the 3rd Bone Spring Sandstone of the Third Bone Spring formation.
- 7. **Devon Exhibit B-2** is a subsea structure map that I prepared for the Wolfcamp formation with contour intervals of 50 feet. The top of the Wolfcamp represents the base of the target. Devon's proposed spacing units are outlined in red. This exhibit demonstrates that the structure in the Wolfcamp formation is consistent across the proposed spacing unit and dips gently to the east. I do not observe any faulting, pinch outs, or other geologic impediments to developing the 3rd Bone Spring Sandstone in this area with horizontal wells.
- 8. **Devon Exhibit B-2** also depicts a line of cross section through Devon's proposed horizontal spacing unit from A to A'. I chose the logs from these wells to create the cross section because they penetrate the targeted interval and are of good quality. In my opinion, these well logs are representative of the geology in the subject area.
- 9. **Devon Exhibit B-3** is a stratigraphic cross section that I prepared using the logs from the representative wells shown on Exhibit D-2. It is hung on top of Wolfcamp. Each well on the cross-section contains gamma ray, resistivity, and porosity logs. The target interval for the initial wells is identified on the exhibit with well numbers. The cross-section demonstrates that the targeted interval is continuous and relatively uniform across the proposed spacing unit.
 - 10. Additional exhibits for the benefit of the Division's review include
 - **Devon Exhibit B-4** a gross isochore of the 3rd Bone Spring Sandstone
 - **Devon Exhibit B-5** is a gun barrel representation of the unit
 - Devon Exhibit B-6 is a structural cross section built along the wellbore trajectories.
- 11. My geologic study indicates the 3rd Bone Spring Sandstone underlying the subject area is suitable for development by horizontal wells and the acreage comprising the proposed horizontal spacing unit will be productive and contribute proportionately to the production from the well.

- 12. As reflected in **Devon Exhibit B-1**, the primary orientation for the existing wells targeting the 3rd Bone Spring Sandstone in this area laydown. In my opinion, laydown orientation of Devon's proposed wells is consistent with existing development and appropriate for the stress orientation in the 3rd Bone Spring Sandstone in this area.
 - 13. I conclude from the attached exhibits that:
 - a. The horizontal spacing and proration unit is justified from a geologic standpoint.
 - b. There are no structural impediments or faulting that will interfere with horizontal development.
 - c. Each quarter section in the unit will contribute more or less equally to production.
- 14. The preferred well orientation in this area is East-West so that the wells run subperpendicular to the inferred orientation of the maximum horizontal stress.
- 15. The Exhibits to this Affidavit were prepared by me or compiled from Devon's company business records under my direct supervision.
- 16. The granting of this Application is in the interests of conservation, the prevention of waste and the drilling of unnecessary wells, and the protection of correlative rights.
 - 17. The foregoing is correct and complete to the best of my knowledge and belief.






Top of Wolfcamp Formation Structure Map





