STATEMENT OF THE CASE

Eddy County, New Mexico (“Unit”); (2) dedicated the Unit to the **Eskey 17 Fed Com 121H** well (“Well”); and (3) designated Permian Resources Operating, LLC (OGRID No. 372165) (“Permian Resources”) as operator of the Unit and Well.

A one-year extension of time to commence drilling the Wells has been requested because the spud date has been delayed so that Colgate can obtain drilling results from offset drilling operations and determine optimal well spacing in this area. Therefore, good cause exists for the requested extension.
