ORDER ON EMERGENCY POST-HEARING MOTIONS

THIS MATTER came before the New Mexico Oil Conservation Commission ("Commission") upon Goodnight Midstream Permian, LLC's ("Goodnight") Emergency Motion to Partially Stay Order R-24004 filed on September 21, 2025, and upon Empire NM LLC's ("Empire") Emergency Motion to Enforce Order R-24004 filed on September 23, 2025. In order to manage the docket in an orderly fashion, the Director of the Oil Conservation Division and Chair of the Oil Conservation Commission ("Director") hereby FINDS as follows:

1. On September 12, 2025, the Commission issued Order R-24004.

- 2. On September 21, 2025, Goodnight filed an Emergency Motion to Partially Stay Order R-24004.
- 3. Goodnight's Motion stated: "Given the nature of the relief requested, Empire is presumed to oppose the Motion." Goodnight's Motion, p.3.
- 4. On September 22, 2025, Empire represented to the Commission Clerk via email that it would like to have until October 3, 2025, to respond to Goodnight's Motion.
- 5. On September 23, 2025, Empire filed its own Emergency Motion to Enforce Order R-24004.
- 6. Empire's Motion stated: "Due to the nature of this Motion, it is presumed that Goodnight opposes the relief sought." Empire's Motion p. 5.
- 7. Goodnight's Motion included the assertion that: "Goodnight intends to file an Application for Rehearing pursuant to 19.15.4.25 NMAC." Goodnight's Motion, p.4.
- 8. As of September 26, 2025, no party has yet filed an application for rehearing in this case.
- 9. The Commission takes administrative notice of NMAC 19.15.4.25, which specifies that for this case, the deadline for filing an application for rehearing will expire on October 2, 2025.
- 10. NMAC 19.15.4.25 also specifies that the Commission is required to grant or refuse an application for rehearing in whole or in part within 10 business days of filing. Therefore, in this case, the Commission will have clarity on whether or not this matter might be set for rehearing, in whole or in part, by no later than October 17, 2025.
- 11. Rule 19.15.4.24 NMAC does not expressly contemplate a post-hearing motion practice, however, the Director may take administrative steps to manage the docket. *See e.g.* Rule 19.15.4.14-.16, -.23 NMAC.

12. The Director "may grant a stay pursuant to a motion for stay or upon the director's own

initiative, after according parties who have appeared in the case notice and an opportunity to

respond...." 19.15.4.23B NMAC. "A director's order staying a commission order shall be

effective only until the commission acts on the motion for stay." Id.

13. All Parties who have appeared in the case have had actual notice of both motions at issue.

14. The disposition of Empire's Motion may be contingent upon, or informed by, the

disposition of Goodnight's Motion, and/or clarity as to whether there will be an application for

rehearing.

THEREFORE, based on the above findings, and to maintain an orderly docket, the Director

hereby ORDERS as follows:

1. Parties who have appeared in this case, except Goodnight, are hereby given an opportunity

to file responses to Goodnight's Emergency Motion to Partially Stay Order R-24004 by NOON on

October 3, 2025. Parties that do not timely file responses will be deemed to have waived their

opportunity to respond. No Reply to Responses will be allowed.

2. Empire's Emergency Motion to Enforce Order R-24004 is held in abeyance until October

17, 2025.
