APPLICANT'S STATEMENT OF THE CASE

In these consolidated cases, Matador seeks to amend previously entered orders to add additional interest owners to the pooling orders for the referenced acreage, all in Township 24

South, Range 28 East, NMPM, Eddy County, in the Bone Spring formation (Culebra Bluff; Bone Spring, South [15011]) as follows:

- Under **Case No. 25583**, the Division issued Order R-22944 on October 31, 2023 in Case No. 23671, which pooled the uncommitted interest owners in a standard 240-acre overlapping horizontal well spacing unit underlying the S/2 S/2 of Section 1 and the S/2 SE/4 of Section 2, and is currently dedicated to the drilled and producing **Drew Dix Federal Com 114H** (API No. 30-015-54513) and **Drew Dix Federal Com 134H** (API No. 30-015-54551) wells; and
- Under **Case No. 25584**, the Division issued Order R-22860 on September 11, 2023 in Case No. 23672, which pooled the uncommitted interest owners in a standard 240-acre overlapping horizontal well spacing unit underlying the N/2 N/2 of Section 1 and the N/2 NE/4 of Section 2, and is currently dedicated to the drilled and producing **C Sweeney State Com 111H** (API No. 30-015-54331), **C Sweeney State Com 121H** (API No. 30-015-54333), and **C Sweeney State Com 131H** (API No. 30-015-54332) wells.

Applicant has discovered additional interest owners in the pooled acreage that were not subject to the pooling proceedings giving rise to Order R-22944 and Order R-22860. Applicant has sought and been unable to obtain voluntary agreement for the development of these lands from these additional interest owners.
