APPLICANT'S STATEMENT OF CASE

Under these consolidated cases, EOG seeks orders pooling for the referenced acreage, all in Township 20 South, Range 32 East, NMPM, Lea County, New Mexico, as follows:

Under Case No. 25627, EOG seeks to pool the uncommitted interests in a portion of the Bone Spring formation (Salt Lake; Bone Spring [53560]) underlying a non-standard 1,280-acre, more or less, horizontal well spacing unit comprised of All of Sections 12 and 13, and initially dedicate the unit to the proposed Margie 24 Federal Com 501H and Margie 24 Federal Com 511H wells, both to be horizontally drilled from surface locations in the NW/4 NW/4 (Unit D) of Section 24, and bottom hole locations in the NW/4 NW/4 (Unit D) of Section 12; Margie 24 Federal Com 502H well, to be horizontally drilled from a surface location in the NE/4 NW/4 (Unit C) of Section 24, and a bottom hole location in the NW/4 NW/4 (Unit D) of Section 12; Margie 24 Federal Com 503H well, to be horizontally drilled from a surface location in the NE/4 NW/4 (Unit C) of Section 24, and a bottom hole location in the NE/4 NW/4 (Unit C) of Section 12; Margie 24 Federal Com 504H well, to be horizontally drilled from a surface location in the NE/4 NW/4 (Unit C) of Section 24, and a bottom hole location in the NW/4 NE/4 (Unit B) of Section 12; Margie 24 Federal Com 505H, Margie 24 Federal Com 506H and Margie 24 Federal Com 515H wells, all to be horizontally drilled from surface locations in the NE/4 NE/4 (Unit A) of Section 24, and bottom hole locations in the NE/4 NE/4 (Unit A) of Section 12; Margie 24 Federal Com 512H well, to be horizontally drilled from a surface location in the NW/4 NW/4 (Unit D) of Section 24, and a bottom hole location in the NE/4 NW/4 (Unit C) of Section 12; Margie 24 Federal Com 513H well, to be horizontally drilled from a surface location

in the NW/4 NE/4 (Unit B) of Section 24, and a bottom hole location in the NE/4 NW/4 (Unit C) of Section 12; and **Margie 24 Federal Com 514H** well, to be horizontally drilled from a surface location in the NW/4 NE/4 (Unit B) of Section 24, and a bottom hole location in the NW/4 NE/4 (Unit B) of Section 12.

• Under Case No. 25628, EOG seeks to pool the uncommitted interests in a portion of the Wolfcamp formation (Hat Mesa; Wolfcamp [96438]) underlying a non-standard 1,280-acre, more or less, horizontal well spacing unit comprised of All of Sections 12 and 13, and initially dedicate the unit to the proposed Margie 24 Federal Com 701H well, to be horizontally drilled from a surface location in the NW/4 NE/4 (Unit B) of Section 24, and a bottom hole location in the NW/4 NW/4 (Unit D) of Section 12; Margie 24 Federal Com 702H and Margie 24 Federal Com 703H wells, both to be horizontally drilled from surface locations in the NW/4 NE/4 (Unit B) of Section 24, and bottom hole locations in the NE/4 NW/4 (Unit C) of Section 12; Margie 24 Federal Com 704H well, to be horizontally drilled from a surface location in the NE/4 NE/4 (Unit A) of Section 24, and a bottom hole location in the NW/4 NE/4 (Unit B) of Section 12; and Margie 24 Federal Com 705H well, to be horizontally drilled from a surface location in the NE/4 NE/4 (Unit A) of Section 24, and a bottom hole location in the NE/4 NE/4 (Unit A) of Section 12.

The completed interval for each well is expected to comply with the setback requirements for the governing pools. Applicant plans to file separate administrative applications for approval of the non-standard spacing units.

Applicant has sought and been unable to obtain voluntary agreement for the development of these lands from all mineral interest owners in the proposed spacing units. The pooling of

interests will avoid the drilling of unnecessary wells, will prevent waste, will protect correlative rights, and allow Applicant to obtain a just and fair share of the oil and gas underlying the subject lands.
