#### STATEMENT OF THE CASE

In this case, Applicant in the above-styled cause seeks an order from the Division pooling all uncommitted mineral interests in the Yeso formation (Empire; Glorieta-Yeso [96210]) in a standard ~640-acre, more or less, horizontal spacing and proration unit ("HSU"), with proximity tracts, comprised of the North Half of Section 24, Township 17 South, Range 27 East and the North Half of Section 19, Township 17 South, Range 28 East in Eddy County, New Mexico. Applicant proposes to drill the following wells:

- Bonzo 1924 Fed Com ABX 001H well, to be horizontally drilled from a surface hole location approximately 1,375' FNL & 620' FWL of Section 20-17S-28E and a bottomhole location approximately 370' FNL and 20' FWL of Section 24-17S-27E;
- Bonzo 1924 Fed Com ABX 002H well, to be horizontally drilled from a surface hole location approximately 1,395' FNL & 620' FWL of Section 20-17S-28E and a bottomhole location approximately 820' FNL and 20' FWL of Section 24-17S-27E;
- Bonzo 1924 Fed Com ABX 003H well, to be horizontally drilled from a surface hole location approximately 1,415' FNL & 620' FWL of Section 20-17S-28E and a bottomhole location approximately 1270' FNL and 20' FWL of Section 24-17S-27E;
- Bonzo 1924 Fed Com ABX 004H well, to be horizontally drilled from a surface hole location approximately 1,435' FNL & 620' FWL of Section 20-17S-28E and a bottomhole location approximately 1721' FNL and 20' FWL of Section 24-17S-27E;
- Bonzo 1924 Fed Com ABX 005H well, to be horizontally drilled from a surface hole location approximately 1,455' FNL & 620' FWL of Section 20-17S-28E and a bottomhole location approximately 2170' FNL and 20' FWL of Section 24-17S-27E.

The Bonzo 1924 Fed Com ABX 003H well is a proximity well. With the proximity tracts, the completed intervals of all wells will meet standard setback requirements. The first and last take points meet the standard setback requirements set forth in the statewide rules for horizontal oil wells. Also to be considered will be the cost of drilling and completing the well and the allocation of the costs, the designation of Applicant as Operator of the wells, and a 200% charge for the risk involved in drilling and completing the well. The wells and lands are located approximately 9 miles East of Artesia, New Mexico. The application was filed September 9, 2025.
