APPLICANT'S STATEMENT OF THE CASE

Under these consolidated cases, Mewbourne seeks to amend the pooling orders for the referenced acreages as follows:

- Under **Case No. 25648**, Mewbourne seeks an order to amend Order No. R-23835 (“Order”) to pool additional mineral interest owners under the pooled acreage. Division Order No. R-23835 was issued in Case No. 25109 and pooled uncommitted mineral interest owners in the Bone Spring formation (Pearl; Bone Spring, East [49690]) underlying a non-standard 1,572.79-acre, more or less, horizontal well spacing unit underlying Lots 3-4, E/2 SW/4, and SE/4 (S/2 equivalent) of irregular Section 7, Lots 1-4, E/2 W/2, and E/2 (entire Section equivalent) of irregular Sections 18 and 19, Township 19 South, Range 36 East, NMPM, Lea County, New Mexico (the “Unit”). The Unit is currently dedicated to the **Black Pearl 7/19 Federal Com 526H** (API No. 30-025-54128) and **Black Pearl 7/19 Federal Com 528H** (API No. 30-025-54129) wells;
- Under **Case No. 25649**, Mewbourne seeks an order to amend Order No. R-23837 (“Order”) to pool additional mineral interest owners under the pooled acreage. Division Order No. R-23837 was issued in Case No. 25111 and pooled uncommitted mineral

interest owners in the Bone Spring formation (Benson; Bone Spring [5200] and Hackberry; Bone Spring, North [97056]) underlying a standard 633.44-acre, more or less, overlapping horizontal well spacing unit underlying the N/2 of Section 12, Township 19 South, Range 30 East, and Lots 1-2, E/2 NW/4, and NE/4 (N/2 equivalent) of irregular Section 7, Township 19 South, Range 31 East, NMPM, Eddy County, New Mexico (the “Unit”). The Unit is currently dedicated to the **Zeke 12/7 Federal Com 611H** (API No. 30-015-56331) and **Zeke 12/7 Federal Com 613H** (API No. 30-015-56332) wells; and

- Under **Case No. 25650**, Mewbourne seeks an order to amend Order No. R-23877 (“Order”) to pool additional mineral interest owners under the pooled acreage. Division Order No. R-23877 was issued in Case No. 25288 and pooled uncommitted mineral interest owners in the Bone Spring formation (Pearl; Bone Spring, East [49690]) underlying a non-standard 1,920-acre, more or less, horizontal well spacing unit underlying All of Sections 8, 17 and 20, Township 19 South, Range 36 East, NMPM, Lea County, New Mexico (the “Unit”). The Unit is currently dedicated to the **High Sea 8/20 State Com 522H** (API No. 30-025-54716), **High Sea 8/20 State Com 524H** (API No. PENDING), **High Sea 8/20 State Com 526H** (API No. PENDING), and **High Sea 8/20 State Com 528H** (API No. PENDING) wells.

The completed interval for the wells will comply with statewide setbacks for oil wells. Mewbourne has discovered additional mineral interest owners in the pooled acreage that were not subject to the pooling proceedings giving rise to the referenced Orders.
