APPLICATION

Riley Permian Operating Company, LLC (OGRID No. 372290) ("Riley" or "Applicant"), through its undersigned attorneys, hereby files this Application with the Oil Conservation Division ("Division") pursuant to the provisions of NMSA 1978, § 70-2-17, for an order (1) approving a 160.43-acre, more or less, standard horizontal spacing unit ("HSU") composed of the S/2 of the S/2 of Section 6, Township 18 South, Range 27 East, N.M.P.M., Eddy County, New Mexico (the "Application Lands"), and (2) pooling all uncommitted mineral interests in the Red Lake; Glorieta Yeso Pool [51120] ("Yeso Pool"), designated as an oil pool, underlying said HSU.

In support of its Application, Riley states the following:

1. Riley and/or its affiliates are working interest owners in the Application Lands and have the right to drill wells thereon as the designated Operator of the Application Lands.
2. Riley seeks to dedicate all of the Application Lands to form a 160.43-acre, more or less, HSU.
3. Riley seeks to dedicate the above-referenced HSU to the following proposed wells:
 - A. **Malco B 6 Fed Com 7H** (API No. 30-015-49914), which is an oil well that will be horizontally drilled from a surface location in the SW/4 SW/4 (Lot M) of Section

5, Township 18 South, Range 27 East, to a bottom hole location in the Yeso Pool in the SW/4 SW/4 (Lot 7) of Section 6, Township 18 South, Range 27 East;

B. **Malco B 6 Fed Com 8H** (API No. 30-015-*Pending*), which is an oil well that will be horizontally drilled from a surface location in the SW/4 SW/4 (Unit M) of Section 5, Township 18 South, Range 27 East, to a bottom hole location in the Yeso Pool in the SW/4 SW/4 (Lot 7) of Section 6, Township 18 South, Range 27 East;

4. The wells are orthodox in their location as defined by 19.15.16.15(C) NMAC, and the take points and laterals comply with Statewide Rules for setbacks under 19.15.16.15(C) NMAC.

5. Riley has made good faith efforts to obtain voluntary agreement from all interest owners in the Yeso Pool underlying the proposed spacing unit, but has been unable to secure agreement from all parties to participate in the drilling of the well or otherwise commit their interests.

6. The pooling of all interests in the Yeso Pool within the proposed unit will avoid the drilling of unnecessary wells, prevent waste, and protect correlative rights.

7. To provide for its just and fair share of the oil and gas underlying the Application Lands, Riley requests that all uncommitted interests in this HSU be pooled and that Riley be designated as the operator of the proposed horizontal wells and HSU.

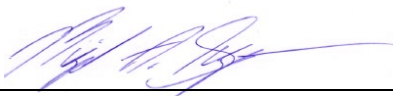
WHEREFORE, Riley requests this Application be set for hearing on November 13, 2025, before an Examiner of the Oil Conservation Division, and after notice and hearing as required by law, the Division enter an order:

A. Approving the horizontal well spacing unit and pooling all uncommitted interests in the Yeso Pool underlying the HSU within the Application Lands;

- B. Approving the **Malco B 6 Fed Com 7H** and **Malco B 6 Fed Com 8H** as the initial wells for the HSU;
- C. Designating Riley as operator of the HSU and the horizontal wells to be drilled thereon;
- D. Authorizing Riley to recover its costs of drilling, completing, and equipping the wells;
- E. Approving the actual operating charges and costs of supervision while drilling and after completion, together with a provision adjusting the rates pursuant to the COPAS accounting procedures; and
- F. Imposing a 200% charge for the risk assumed by Riley in drilling and completing the wells against any working interest owner who does not voluntarily participate in the drilling of the wells.

Applicant in the above-styled cause seeks an order from the Division: (1) approving a 160.43-acre, more or less, standard horizontal spacing and proration unit composed of the S/2 of the S/2 of Section 6, Township 18 South, Range 27 East, N.M.P.M., Eddy County, New Mexico, and (2) pooling all uncommitted mineral interests in the Yeso Pool, designated as an oil pool, underlying said unit. The proposed wells to be dedicated to the horizontal spacing unit are: **Malco B 6 Fed Com 7H** (API No. 30-015-49914), which is an oil well that will be horizontally drilled from a surface location in the SW/4 SW/4 (Lot M) of Section 5, Township 18 South, Range 27 East, to a bottom hole location in the Yeso Pool in the SW/4 SW/4 (Lot 7) of Section 6, Township 18 South, Range 27 East; **Malco B 6 Fed Com 8H** (API No. 30-015-Pending), which is an oil well that will be horizontally drilled from a surface location in the SW/4 SW/4 (Unit M) of Section 5, Township 18 South, Range 27 East, to a bottom hole location in the Yeso Pool in the SW/4 SW/4 (Lot 7) of Section 6, Township 18 South, Range 27 East. The wells are orthodox in location, and the take points and laterals comply with Statewide Rules for setbacks. The wells and lands are located approximately 5.5 miles east of Atoka, New Mexico.

AFFIDAVIT OF MARK SMITH

Mark Smith, being first duly sworn upon oath, deposes and states as follows:

1. My name is Mark Smith, and I am employed by Riley Permian Operating Company, LLC ("Riley") as a Senior Landman.

2. I have previously testified before the New Mexico Oil Conservation Division ("Division"), and my qualifications as an expert in petroleum land matters were accepted and made a matter of record. I have several years of experience in petroleum land matters, and I have worked directly or in a supervisory role with the properties that are the subject of this matter.

3. I am familiar with the application filed by Riley in the above-referenced case and the status of the lands in the subject lands.

4. I am submitting this affidavit in support of Riley's application in the above-referenced case, as required by the Pre-Hearing Order issued by the Division. I intend to present this case by affidavit pursuant to 19.15.4.12.(A)(1) NMAC.

5. Under Case No. 25683, Riley seeks an order (1) approving a 160.43-acre, more or less, standard horizontal spacing unit ("HSU") underlying the Application Lands, and (2) pooling all uncommitted mineral interests in the Red Lake; Glorieta Yeso Pool [51120], designated as an oil pool, underlying said HSU.

6. **Riley Exhibit C-1** is a general location map showing the proposed Yeso formation spacing unit. The acreage subject to the applications are federal and state lands.

7. **Riley Exhibit C-2** contains the Form C-102s reflecting that the proposed Yeso wells to be drilled and completed in the subject unit. The location of each well is orthodox and meets the Division's offset requirements.

8. A review of the Yeso formation underlying the subject lands indicated that there are no overlapping spacing units in this formation.

9. **Riley Exhibit C-3** contains a plat identifying ownership by tract in the HSU.

10. **Riley Exhibit C-4** sets forth the ownership of the parties being pooled in the Yeso Formation and the nature of their interests. This exhibit identifies the tract number and working interest percentages for each owner.

11. **Riley Exhibit C-5** contains a sample well proposal letter sent in August and September of 2025 to each mineral interest owner and/or working interest owner, which included AFEs for each proposed well. The estimated costs of the wells set forth in the AFEs are fair, reasonable, and comparable with the costs of other wells of similar depths and lateral lengths drilled in this area of New Mexico.

12. Riley requests overhead and administrative rates of \$8,000/month for drilling each well and \$800/month for producing each well. These rates are fair and comparable to the rates charged by other operators for wells of this type in this area of New Mexico. Riley respectfully requests that these administrative and overhead costs be incorporated into any orders entered by the Division in these cases.

13. Riley requests the maximum cost, plus 200% risk charge be assessed against nonconsenting working interest owners.

14. **Riley Exhibit C-6** sets forth a chronology of the contacts with owners. Riley has made a good faith effort to obtain voluntary joinder of the interest owners in the proposed wells.

In compiling these addresses, I conducted a diligent search of the public records in Eddy County, New Mexico, where the wells are located, and of phone directories and did computer searches to locate the contact information for parties entitled to notification. All interest owners were locatable and noticed, and there are no unleased mineral interest owners. Riley caused notice to be published in the Carlsbad-Current Argus, a newspaper of general circulation in Eddy County, New Mexico. I provided the law firm of Beatty & Wozniak, P.C., with the names and addresses for these mineral owners and instructed that each owner be provided notice of the hearing in these matters.

15. Riley requests that it be designated operator of the unit and wells.

16. **Exhibit C-1** through **Exhibit C-6** were either prepared by me or compiled from Riley's company business records under my direction and supervision.

17. The granting of this application for compulsory pooling and approval of non-standard spacing unit is in the best interest of conservation, the prevention of waste, and the protection of correlative rights, and will avoid the drilling of unnecessary wells.

18. I hereby swear that to the best of my knowledge and belief, all of the matters set forth herein and in the exhibits are true, correct, and accurate.

AFFIDAVIT OF DOUG STANDART

Doug Standart, being first duly sworn upon oath, deposes and states as follows:

1. My name is Doug Standart, and I am employed by Riley Permian Operating Company, LLC ("Riley") as a Senior Geologist.
2. I have testified before the New Mexico Oil Conservation Division ("Division"), and my qualifications as an expert in petroleum geology were accepted and made a matter of record. I have several years of experience in petroleum geological matters, and I have worked directly or in a supervisory role with the properties that are the subject of this matter.
3. I am familiar with the applications filed by Riley in this case and the geology involved.
4. I am submitting this affidavit in support of Riley's application in the above-referenced case, as required by the Pre-Hearing Order issued by the Division. I intend to present this case by affidavit pursuant to 19.15.4.12.(A)(1) NMAC.
5. **Riley Exhibit D-1** includes a base map of the lands showing the proposed Yeso formation spacing unit and the proposed well development plan.
6. **Riley Exhibit D-2** is a subsea structure map showing the depth to the top of the Yeso formation, a marker that defines the top of the target interval for the proposed wells. The contour interval used in this exhibit is 20'. The unit being pooled is outlined in green, and the

proposed wells are identified by red dashed lines. The structure map shows regional down-dip to the east. I do not observe any faulting, pinchouts, or other geologic impediments to developing this target interval.

7. **Riley Exhibit D-3** includes stratigraphic cross-section flattened on the top of the proposed Yeso formation. Each well in the cross-section contains a gamma ray, resistivity, and porosity log. The cross-sections demonstrate continuity and consistent thickness across the target zone, and the well logs on the cross-section give a representative sample of the targeted interval. The landing zone is highlighted on the exhibit.

8. **Riley Exhibit D-3** also provides a cross-section locator map that identifies wells penetrating the targeted interval used to construct a structural cross-section from A to A'. These wells penetrate the targeted interval, are of good quality, and are representative of the geology in the area.

9. **Riley Exhibit D-4** shows the Gunbarrel Diagram within the Yeso formation in the vicinity of the proposed unit.

10. **Riley Exhibit D-5** includes the gross isopach map. The Yeso wells are indicated by red dashed lines. The proposed horizontal spacing unit is outlined in green. The contour interval used in this exhibit is 50'.

11. Based on the attached exhibits, I hereby conclude as follows:

a. The target formation is present and continuous throughout the lands subject to the applications.

b. The standard horizontal spacing and proration unit is justified from a geologic standpoint.

c. There are no structural impediments or faulting that will interfere with horizontal development.

d. Each quarter-quarter section in the unit will contribute more or less equally to production, and I can confirm each quarter section along the lateral will also contribute more or less equally to production.

e. The preferred well orientation in this area is East-West so that the wells run sub-perpendicular to the inferred orientation of the maximum horizontal stress. The standup orientation will efficiently and effectively develop the subject acreage.

12. **Exhibit D-1** through **Exhibit D-5** were prepared by me or compiled from Riley's company business records under my direct supervision.

13. The granting of these applications is in the best interest of conservation, the prevention of waste, the protection of correlative rights, and will avoid the drilling of unnecessary wells.

14. I hereby swear that to the best of my knowledge and belief, all of the matters set forth herein and in the exhibits are true, correct, and accurate.

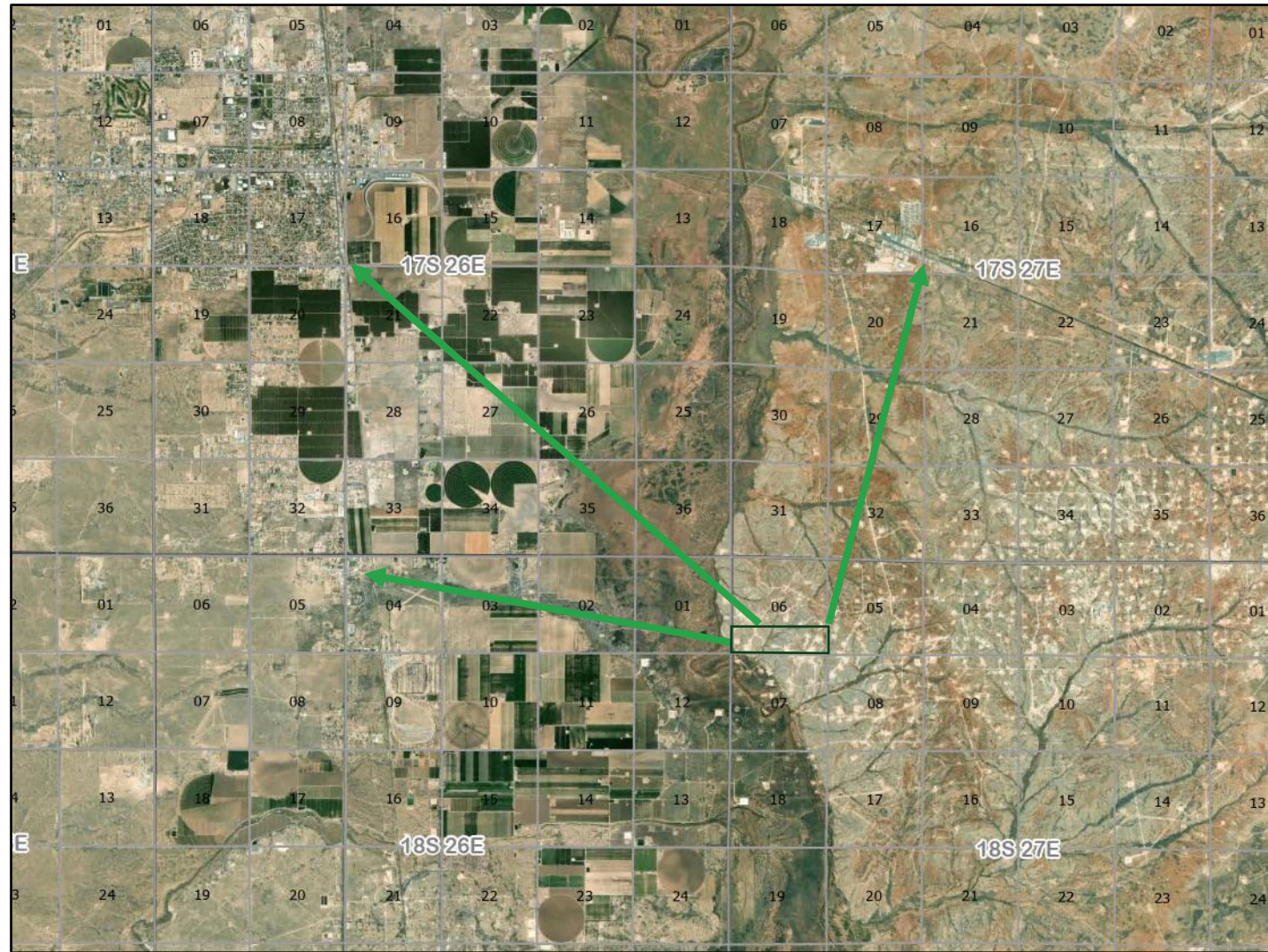

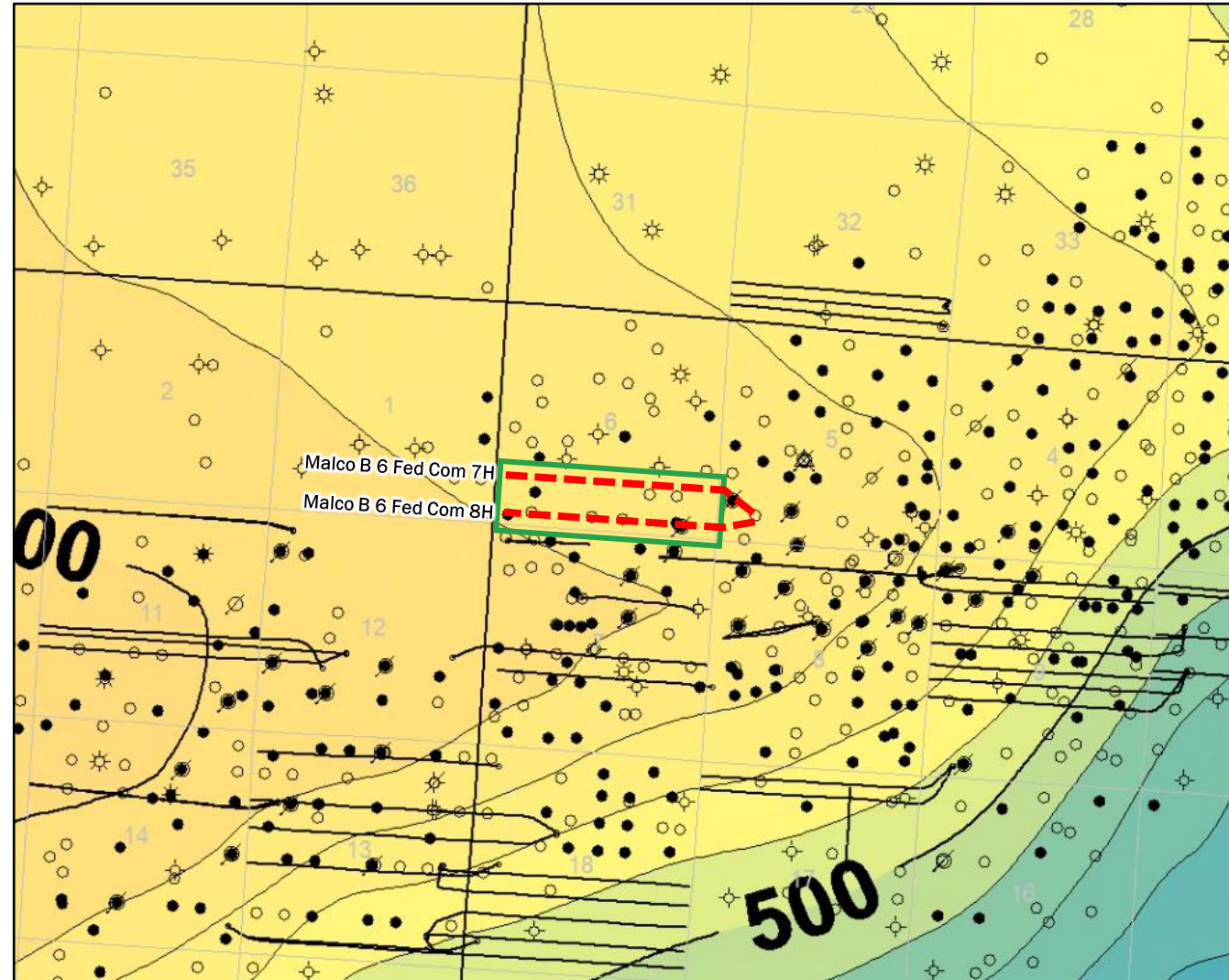

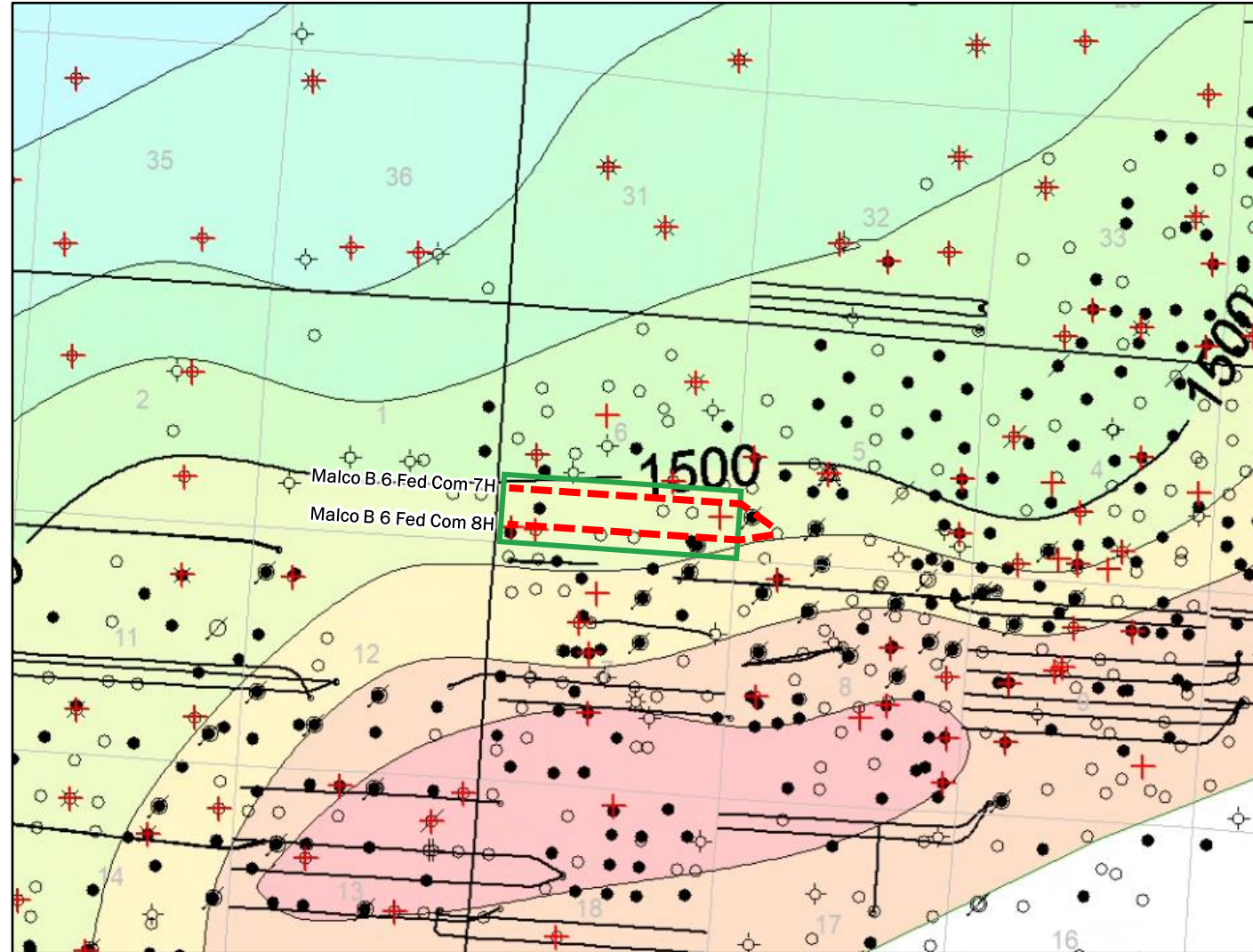
