In **Case No. 25686**, Applicant seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 480-acre, more or less, standard, horizontal spacing unit comprised

of the N/2 N/2 of Section 7, Township 19 South, Range 28 East, and the N/2 N/2 of Sections 11 and 12, Township 19 South, Range 27 East, Eddy County, New Mexico. The Unit will be dedicated to the **Alpine Eagle 7-11 State Com 131H** well, which will produce from a first take point located in the NE/4 NE/4 (Unit A) of Section 7, Township 19 South, Range 28 East, to a last take point located in the NW/4 NW/4 (Unit D) of Section 11, Township 19 South, Range 27 East.

In **Case No. 25688**, Applicant seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 480-acre, more or less, standard, horizontal spacing unit comprised of the N/2 S/2 of Section 7, Township 19 South, Range 28 East, and the N/2 S/2 of Sections 11 and 12, Township 19 South, Range 27 East, Eddy County, New Mexico. The Unit will be dedicated to the **Alpine Eagle 7-11 State Com 133H** well, which will produce from a first take point located in the NE/4 SE/4 (Unit I) of Section 7, Township 19 South, Range 28 East, to a last take point located in the NW/4 SW/4 (Unit L) of Section 11, Township 19 South, Range 27 East.

In **Case No. 25689**, Applicant seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 480-acre, more or less, standard, horizontal spacing unit comprised of the S/2 S/2 of Section 7, Township 19 South, Range 28 East, and the S/2 S/2 of Sections 11 and 12, Township 19 South, Range 27 East, Eddy County, New Mexico. The Unit will be dedicated to the **Alpine Eagle 7-11 State Com 134H** well, which will produce from a first take point located in the SE/4 SE/4 (Unit P) of Section 7, Township 19 South, Range 28 East, to a last take point located in the SW/4 SW/4 (Unit M) of Section 11, Township 19 South, Range 27 East.

In **Case No. 25691**, Applicant seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 480-acre, more or less, standard, horizontal spacing unit comprised of the S/2 N/2 of Section 7, Township 19 South, Range 28 East, and the S/2 N/2 of Sections 11 and 12, Township 19 South, Range 27 East, Eddy County, New Mexico. The Unit will

be dedicated to the **Alpine Eagle 7-11 State Com 202H** well, which will produce from a first take point located in the SE/4 NE/4 (Unit H) of Section 7, Township 19 South, Range 28 East, to a last take point located in the SW/4 NW/4 (Unit E) of Section 11, Township 19 South, Range 27 East.

The completed intervals of the Alpine Eagle Wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells, the allocation of the costs, the designation of Applicant as operator of the Units and the wells, and a 200% charge for the risk involved in drilling and completing the wells.
