STATEMENT OF THE CASES

In **Case No. 25762**, Permian Resources requests a one-year extension of time, until December 12, 2026, to commence drilling the wells authorized by Order No. R-23572. The Division entered Order No. R-23572 in Case No. 24958 on December 12, 2024, pooling all uncommitted interests in the Bone Spring formation underlying an 800-acre, more or less, standard horizontal spacing unit, comprised of the W/2 of Sections 9 and 16, and the NW/4 of Section 21, Township 19 South, Range 30 East, Eddy County, New Mexico. Order No. R-23572 further dedicated the unit to the Star Fox 9 Fed Com 121H and Star Fox 9 Fed Com 122H wells and designated Applicant as operator of the unit and wells.

In **Case No. 25763**, Permian Resources requests a one-year extension of time, until December 12, 2026, to commence drilling the wells authorized by Order No. R-23571. The Division entered Order No. R-23571 in Case No. 24957 on December 12, 2024, pooling all uncommitted interests in the Bone Spring formation underlying an 800-acre, more or less, standard horizontal spacing unit, comprised of the E/2 of Sections 9 and 16, and the NE/4 of Section 21, Township 19 South, Range 30 East, Eddy County, New Mexico. Order No. R-23571 further dedicated the unit to the Star Fox 9 Fed Com 123H and Star Fox 9 Fed Com 124H wells and designated Applicant as operator of the unit and wells.

Permian Resources' ability to commence drilling the wells has been delayed due to limited rig availability. Permian Resources also requires additional time to evaluate offset drilling results and determine well spacing in this area. Therefore, good cause exists for the requested extensions.
