**STATEMENT OF THE CASE**

Applicant is seeking to pool additional uncommitted leased mineral interests under the terms of Division Order No. R-23654 (“Order”) to satisfy a contractual lease provision. The Division issued the Order in Case No. 24993 on January 15, 2025. The Order: (1) pooled uncommitted interests in the Wolfcamp formation, underlying a 1,269.92-acre, more or less, non-standard horizontal spacing unit comprised of Sections 19 and 20, Township 21 South, Range 27

East, Eddy County, New Mexico (“Unit”); (2) dedicated the Unit to the **Canal 20/19 Fed Com #712H, Canal 20/19 Fed Com #714H, Canal 20/19 Fed Com #716H, and Canal 20/19 Fed Com #718H** wells (“Wells”); and (3) designated Applicant as operator of the Unit and Wells.

Since the Order was entered, Mewbourne has identified additional interests in the Unit that should be pooled under the terms of the Order to allow Mewbourne to obtain its just and fair share of the oil and gas underlying the subject lands. All working interests were previously pooled, and Mewbourne is only seeking to pool leased mineral interests to satisfy contractual provisions.
