### **STATEMENT OF THE CASE**

Applicant seeks an order pooling all uncommitted interests in the Yeso formation underlying a 320.79-acre, more or less, standard, overlapping horizontal spacing unit comprised of the E/2 of Section 2, Township 18 South, Range 27 East, Eddy County, New Mexico ("Unit"). The Unit to the following wells ("Wells"): Cheshire Cat State Com 1H, Cheshire Cat State Com 20H, and Cheshire Cat State Com 50H, to be drilled from a surface hole location in NE/4 NE/4 (Unit A) of Section 11 to a bottom hole location in Lot 2 (NW/4 NE/4 equivalent) of Section

2; and Cheshire Cat State Com 21H and Cheshire Cat State Com 51H, to be drilled from a surface hole location in NE/4 NE/4 (Unit A) of Section 11 to a bottom hole location in Lot 1 (NE/4 NE/4 equivalent) of Section 2. The completed intervals of the Wells will be orthodox. The completed interval of the Cheshire Cat State Com 1H well will be located within 330' of the quarter-quarter section line separating the W/2 E/2 and E/2 E/2 of Section 2 to allow for the creation of a 320.79-acre standard horizontal spacing unit.

The spacing unit for the Wells partially overlaps with the spacing units for the following wells, which produce from the Red Lake; Glorieta-Yeso, Northeast Pool (Code 96836):

- a. State H #002 (API No. 30-015-35814) located in the SE/4 NE/4 (Unit H) of Section 2, Township 18 South, Range 27 East; and
- SCBP STATE #001 (API No. 30-015-32946) located in the NW/4 SE/4 (Unit J) of Section 2, Township 18 South, Range 27 East.

Also to be considered will be the cost of drilling and completing the Wells, the allocation of the costs, the designation of Applicant as operator of the Wells and the Unit, and a 200% charge for the risk involved in drilling and completing the Wells.
