**STATEMENT OF THE CASES**

In **Case No. 25773**, Permian Resources seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 1,923.55-acre, more or less, standard horizontal spacing unit comprised of all of Sections 19, 20 and 21, Township 21 South, Range 26 East, Eddy County, New Mexico. The unit will be dedicated to the **Solstice Fed Com 212H** well, which will produce from a first take point in Lot 2 (SW/4 NW/4 equivalent) of Section 19 to a last take point in the SE/4 NE/4 (Unit H) of Section 21. The completed interval of the **Solstice Fed Com 212H** well

will be located within 330' of the half-section line separating the N/2 and S/2 of Sections 19, 20, and 21 to allow for the creation of a 1,923.55-acre standard, horizontal spacing unit.

**In Case No. 25774**, Permian Resources seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 963.58-acre, more or less, standard horizontal spacing unit comprised of S/2 of Sections 19, 20 and 21, Township 21 South, Range 26 East, Eddy County, New Mexico. The unit will be dedicated to the **Solstice Fed Com 134H** well, which will produce from a first take point in Lot 4 (SW/4 SW/4 equivalent) of Section 19 to a last take point in the SE/4 SE/4 (Unit P) of Section 21. The completed interval of the Solstice Fed Com 134H well will be located within 330' of the quarter-quarter section line separating the N/2 S/2 and S/2 S/2 of Sections 19, 20, and 21 to allow for the creation of a 963.58-acre standard, horizontal spacing unit.

**In Case No. 25775**, Permian Resources seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 959.97-acre, more or less, standard horizontal spacing unit comprised of the N/2 of Sections 19, 20 and 21, Township 21 South, Range 26 East, Eddy County, New Mexico. The unit will be dedicated to the **Solstice Fed Com 132H** well, which will produce from a first take point in Lot 2 (SW/4 NW/4 equivalent) of Section 19 to a last take point in the SE/4 NE/4 (Unit H) of Section 21. The completed interval of the Solstice Fed Com 132H well will be located within 330' of the quarter-quarter section line separating the S/2 N/2 and N/2 N/2 of Sections 19, 20, and 21 to allow for the creation of a 959.97-acre standard, horizontal spacing unit.

The completed intervals of the Solstice wells will be orthodox. Also to be considered will be the cost of drilling and completing the Solstice wells, the allocation of the costs, the designation of Applicant as operator of the units and the Solstice wells, and a 200% charge for the risk involved in drilling and completing the Solstice wells.
