STATEMENT OF THE CASE

Applicant seeks an order pooling additional uncommitted interests under the terms of Division Order No. R-23889 (“Order”). The Order pooled uncommitted interests in the San Andres formation underlying a 160-acre, more or less, standard horizontal spacing unit comprised of the S/2 S/2 of Section 32, Township 17 South, Range 27 East, Eddy County, New Mexico (“Unit”).

The Order dedicated the Unit to the Red Lake State Com 112H well (“Well”) and designated Applicant as operator of the Unit and Well.

Since the Order was entered, Applicant has identified additional interests in the Unit that should be pooled under the terms of the Order to allow Applicant to obtain its just and fair share of the oil and gas underlying the subject lands.
