APPLICANT'S STATEMENT OF THE CASES

Under these consolidated cases, Catamount seeks orders extending the deadlines to drill the proposed wells, all located within Township 32 North, Range 6 West, NMPM, San Juan and Rio Arriba Counties, New Mexico:

- Under **Case No. 25764**, Catamount seeks an order to amend Order No. R-23651 (“Pooling Order”) to allow for an extension of time for drilling the proposed initial well under the Order. Division Order No. R-23651, entered on January 15, 2025, in Case No. 24987 approved a non-standard 1,440-acre, more or less, horizontal spacing unit in the Mancos formation (Basin Mancos (Gas) [97232]) comprised of the N/2 and the N/2 S/2 of Sections 13, 14 and 15, Township 32 North, Range 6 West, NMPM, San Juan and Rio Arriba Counties, New Mexico (the “Unit”), and pooled the uncommitted interests therein. Catamount is the designated operator under the Pooling Order and the pooled spacing unit is initially dedicated to the proposed **NLS 32-6-15 3H** (API No. Pending), **NLS 32-6-15 4H** (API No. Pending), and **NLS 32-6-15 5H** (API No. Pending).
- Under **Case No. 25765**, Catamount seeks an order to amend Order No. R-23613 (“Pooling Order”) to allow for an extension of time for drilling the proposed initial well under the Order. Division Order No. R-23613, entered on January 15, 2025, in Case No. 24830, approved a non-standard 1,941.18-acre, more or less, horizontal spacing unit in the Mancos formation (Basin Mancos (Gas) [97232]) comprised of the Lots 1-4, S/2 N/2 and SE/4 of irregular Section 9, Lots 1-4, S/2 N/2 and S/2 of irregular Sections 10 and 11, and Lots 1-4, S/2 N/2, SW/4 and the NW/4 SE/4 of irregular Section 12, Township 32 North, Range 6 West, NMPM, San Juan and Rio

Arriba Counties, New Mexico (the “Unit”), and pooled the uncommitted interests therein. Catamount is the designated operator under the Pooling Order and the pooled spacing unit is initially dedicated to the **Miller Mesa 32-6-10 1H** (API No. Pending), **Miller Mesa 32-6-11 1H** (API No. Pending), and **NLN 32-6-9 2H** (API No. Pending).
