APPLICANT'S STATEMENT OF THE CASES

MRC seeks an order to amend Order No. R-23647 ("Pooling Order") to allow for an extension of time for drilling the proposed initial wells under the Order. Division Order No. R-23647, entered on January 15, 2025, in Case No. 25036, approved a standard 800.29-acre, more or less, horizontal well spacing unit in the Wolfcamp (oil) formation (Hat Mesa; Wolfcamp [96438]) comprised of the W/2 of irregular Section 3 and Section 10, Township 21 South, Range 32 East, NMPM, Lea County, New Mexico (the "Unit") and pooled the uncommitted mineral

interests therein. Matador Production Company (OGRID No. 228937) is the operator under the Pooling Order and the pooled spacing unit is initially dedicated to the proposed **Electra Special 0310 Fed Com 202H** well.

There is good cause for Applicant's request for an extension of time to drill.
