APPLICANT’S STATEMENT OF THE CASES

Under these consolidated cases, MRC seeks orders pooling all uncommitted interests in the following proposed horizontal well spacing units, all within Township 25 South, Range 36 East, NMPM, Lea County, New Mexico:

- Under **Case No. 26191**, MRC seeks an order MRC seeks an order pooling the uncommitted interest owners in a standard 480-acre, more or less, horizontal well spacing unit in the Bone Spring formation (WC-025 G-08 S263620C; Lwr Bone Spring [98150]) underlying the W/2 W/2 of Sections 10, 15 and 22. MRC seeks to dedicate this horizontal spacing unit

to the proposed **Raes Creek Fed Com 81H** well, to be drilled from a surface hole location in the S/2 SW/4 of Section 22, with a first take point in the SW/4 SW/4 (Unit M) of Section 22, and a last take point in the NW/4 NW/4 (Unit D) of Section 10.

- Under **Case No. 26192**, MRC seeks an order pooling the uncommitted interest owners in a standard 480-acre, more or less, horizontal well spacing unit in the Bone Spring formation (WC-025 G-08 S263620C; Lwr Bone Spring [98150]) underlying the E/2 W/2 of Sections 10, 15 and 22. MRC seeks to dedicate this horizontal spacing unit to the proposed **Raes Creek Fed Com 91H** well, to be drilled from a surface hole location in the S/2 SW/4 of Section 22, with a first take point in the SE/4 SW/4 (Unit N) of Section 22, and a last take point in the NE/4 NW/4 (Unit C) of Section 10.
- Under **Case No. 26193**, MRC seeks an order pooling the uncommitted interest owners in a standard 480-acre, more or less, horizontal well spacing unit in the Wolfcamp formation (Jal; Wolfcamp, West [33813]) underlying the W/2 W/2 of Sections 10, 15 and 22. MRC seeks to dedicate this horizontal spacing unit to the proposed **Raes Creek Fed Com 111H** well, to be drilled from a surface hole location in the S/2 SW/4 of Section 22, with a first take point in the SW/4 SW/4 (Unit M) of Section 22, and a last take point in the NW/4 NW/4 (Unit D) of Section 10.

The completed interval for the wells will comply with statewide setbacks for oil. MRC has sought and been unable to obtain voluntary agreement for the development of these lands from all interest owners in the subject acreage.
