**APPLICANT’S STATEMENT OF THE CASES**

Under these consolidated cases, Mewbourne seeks orders pooling in the Bone Spring formation (Bilbrey Basin; Bone Spring [5695]) for the referenced acreage, all in Township 21 South, Range 31 East, NMPM, Eddy County, New Mexico, as follows:

- Under **Case No. 26153**, Mewbourne seeks to pool the uncommitted interest owners in a standard 480-acre, more or less, well spacing unit underlying the E/2 SE/4 of Section 16, E/2 E/2 of Sections 21 and 28, and E/2 NE/4 of Section 33, to be initially dedicated to the proposed **Cousin Eddy Federal Unit Com 78H** well, to be drilled from a surface

- hole location in the SE/4 NE/4 (Unit H) of Section 33, a first take point in the SE/4 NE/4 (Unit H) of Section 33, and a last take point in the NE/4 SE/4 (Unit I) of Section 16.
- Under **Case No. 26154**, Mewbourne seeks to pool the uncommitted interest owners in a standard 480-acre, more or less, well spacing unit underlying the W/2 SE/4 of Section 16, W/2 E/2 of Sections 21 and 28, and W/2 NE/4 of Section 33, to be initially dedicated to the proposed **Cousin Eddy Federal Unit Com 79H** well, to be drilled from a surface hole location in the SE/4 NE/4 (Unit H) of Section 33, a first take point in the SW/4 NE/4 (Unit G) of Section 33, to a last take point in the NW/4 SE/4 (Unit J) of Section 16.
  - Under **Case No. 26155**, Mewbourne seeks to pool the uncommitted interest owners in a standard 480-acre, more or less, well spacing unit underlying the E/2 SW/4 of Section 16, E/2 W/2 of Sections 21 and 28, and E/2 NW/4 of Section 33, to be initially dedicated to the proposed **Cousin Eddy Federal Unit Com 90H** well, to be drilled from a surface hole location in the SE/4 NW/4 (Unit F) of Section 33, a first take point in the SE/4 NW/4 (Unit F) of Section 33, and a last take point in the NE/4 SW/4 (Unit K) of Section 16.
  - Under **Case No. 26156**, Mewbourne seeks to pool the uncommitted interest owners in a standard 480-acre, more or less, well spacing unit underlying the W/2 SW/4 of Section 16, W/2 W/2 of Sections 21 and 28, and W/2 NW/4 of Section 33, to be initially dedicated to the proposed **Cousin Eddy Federal Unit Com 91H** well, to be drilled from a surface hole location in the SE/4 NW/4 (Unit F) of Section 33, a first take point

in the SW/4 NW/4 (Unit E) of Section 33, and a last take point in the NW/4 SW/4 (Unit L) of Section 16.

The completed interval for the wells will comply with statewide setbacks for oil wells. Mewbourne has sought but been unable to obtain voluntary agreement for the development of these lands from all interest owners in the subject spacing units.
