JOINT NOTICE OF DISMISSAL OF APPLICATIONS

COG Operating LLC (“COG”) and MRC Hat Mesa, LLC (“MRC”), by and through undersigned counsel, hereby provide notice that they are dismissing Case Nos. 26000, 26001, 26002, and 26368. In support of this Notice, COG and MRC state as follows.

1. MRC filed Case Nos. 26000, 26001, and 26002 (“MRC B Byerley Cases”) on February 23, 2026.
2. COG filed its notice of objection to the MRC B Byerley Cases on May 26, 2026.
3. The Oil Conservation Division (“Division”) set the MRC B Byerley Cases for a contested hearing on August 25, 2026 pursuant to a Pre-Hearing Order issued on June 18, 2026.
4. COG then filed Case No. 26368 (“COG Corazon Case”) on July 7, 2026.
5. On July 14, 2026, the Division issued an order adding COG’s Corazon Case to the Pre-Hearing Order for the contested hearing on August 25, 2026.
6. The parties have subsequently engaged in productive negotiations and have reached an agreement to dismiss their respective cases.

WHEREFORE, COG and MRC respectfully provide notice that they are dismissing Case Nos. 26000, 26001, 26002, and 26368, without prejudice.
