In Section (e), the Grayburg-Jackson Pool, I recommend that an additional quarter section be included in the Grayburg-Jackson Pool other than the quarter section advertised. That is the quarter section advertised, was the northwest of 9, Township 17 South, Range 31 East. There has been another completion in the southwest quarter of Section 1 since that application was made for the extension of the northwest quarter of 9, and I recommend that both of these quarter sections be included in the Grayburg-Jackson Pool as shown by the green hatched area in this plat.

In the case of Section (h), the proposed West Dollarhide-Devonian Pool, I recommend that in addition to the advertised area that the northwest quarter and Lot 1 and 2 of Section 4, Township 25 South, Range 38 East, in the northwest quarter and the southwest quarter, and Lots 1, 2, 3, and 4 of Section 33, Township 24 South, Range 38 East, and the southwest quarter of Section 28 and Lots 3 and 4 in Section 28, Township 24 South, Range 38 East, be included in the proposed West Dollarhide-Devonian Pool in addition to that area advertised.
