ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9:00 a.m. June 19, 1952, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 16 day of July, 1952, the Commission, a quorum being present, having considered the testimony adduced and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That a new pool should be created, classified as an oil pool, and designated as the SandHills pool, described as:

T. 20 S, R. 39 E, NMPM, Lea County, N. M.
SW/4, Lots 3 and 4 of section 32

T. 21 S, R. 38 E, NMPM, Lea County, N. M.
Lots 1 and 2, section 4; Lots 1 and 2 section 5

(3) That a new pool should be created, classified as an oil pool, and designated as the Townsend-Wolfcamp pool, described as:

T. 16 S, R. 35 E NMPM, Lea County, N. M.
S/2 section 3, S/2 section 4, N/2 section 9,
N/2 section 10

(4) That a new pool should be created, classified as an oil pool, and designated as the West Dollarhide-Queen pool, described as:

T. 25 S R. 38 E, NMPM, Lea County, N. M.
NE/4 section 6

(5) That the Hare pool, Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include:

T. 21 S, R. 37 E, NMPM
Lot 9 section 3, E/2 section 16

(6) That the Garrett pool, Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include:

T. 16 S, R. 38 E, NMPM
SW/4 section 22

(7) That the Brunson pool, Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include:

T. 21 S, R. 37 E, NMPM
NE/4 section 11, NW/4 section 12

(8) That the Bowers pool, Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include:

T. 19 S, R. 38 E, NMPM
NE/4 SE/4 section 5

(9) That the Malaga pool, Eddy County, New Mexico, as heretofore classified, defined and described, should be extended to include:

T. 24 S, R. 28 E, NMPM
SE/4, E/2 SW/4 section 12;
NE/4, E/2 NW/4 section 13

IT IS THEREFORE ORDERED:

That the application of the Oil Conservation Commission, be, and the same hereby is approved, as follows:

(1) That a new pool, be, and the same hereby is created, designated for oil production, denominated the Sand Hills pool, and described as follows:

T. 20 S, R. 39 E, NMFM, Lea County, N. M.
SW/4 and Lots 3 and 4 of section 32

T. 21 S, R. 38 E, NMPM, Lea County, N. M.
Lots 1 and 2 section 4;
Lots 1 and 2 section 5

(2) That a new pool, be, and the same hereby is created, designated for oil production, denominated the Townsend-Wolfcamp pool, and described as follows:

T. 16 S, R. 35 E, NMPM, Lea County, N. M.
S/2 section 3, S/2 section 4, N/2 section 9,
N/2 section 10

(3) That a new pool, be, and the same hereby is created, designated for oil production, denominated the West Dollarhide-Queen pool, and described as follows:

T. 25 S, R. 38 E, NMPM, Lea County, N. M.
NE/4 section 6

(4) That the boundaries of the Hare pool, Lea County, New Mexico, be, and the same hereby are extended to include:

T. 21 S, R. 37 E, NMPM, Lea County, N. M.
Lot 9 section 3, E/2 section 16

(5) That the boundaries of the Garrett pool, Lea County, New Mexico, be, and the same hereby are extended to include:

T. 16 S, R. 38 E, NMPM
SW/4 section 22

(6) That the boundaries of the Brunson pool, Lea County, New Mexico, be, and the same hereby are extended to include:

T. 21 S, R. 37 E, NMPM
NE/4 section 11, NW/4 section 12

(7) That the boundaries of the Bowers pool, Lea County, New Mexico, be, and the same hereby are extended to include:

T. 19 S, R. 38 E, NMPM
NE/4 SE/4 section 5

(8) That the boundaries of the Malaga pool, Eddy County, New Mexico, be, and the same hereby are extended to include:

DIRECT EXAMINATION

Q State your name and position, please.

A R. S. Blymm, engineer Oil Conservation Commission.

Q Have you had occasion to make a study of the proposed extension of the existing pools recited in the publication in Case No. 378?

A Yes.

Q Report your studies and give your conclusions and recommendations.

A I recommend that all the corrections and all of the extensions be accepted as advertised, with but one exception and

that exception in Section D in the case of the Hare Pool, that in addition to the southeast quarter of Section 16, Township 21 South, Range 37 East, which was advertised in addition to that, that Lot 9 of Section 3, Township 21 South, Range 37 East also be included in the Hare Pool at this time.

MR. SPURRIER: Is there any objection or comment to Mr. Blumm's recommendation?

MR. MCPHERON, Gulf Oil Corporation: We would like also to have included in the Hare Pool the northeast quarter of Section 16. At the present time we are starting drilling operations in the southeast of the northeast of that section. Offsetting two producing wells in the McKee. We have insufficient information to know or to believe that we will get a producer there and we would like to have the pool extended at this time.

MR. WHITE: That would be within the same reservoir common source of supply?

MR. MCPHERON: Yes.

MR. SPURRIER: Any other additions or deletions?

MR. BLYMM: Maybe the record should show that I have prepared exhibits in support of each individual section of Case 378.

MR. SPURRIER: You would like to offer those in evidence?

MR. BLYMM: Yes.

MR. SPURRIER: Without objection they will be received. If no further comment on Case 378 we will take the case under advisement and that completes the docket for today and the meeting is adjourned.
