MR. PORTER: Gentlemen, the Hearing will come to order. The record will show that present for this Hearing are Chairman Trujillo and Secretary-Director A.L. Porter. We are going to near one short case here, which is Case 5369, and for the other case, Case 5377, we're going to move to the Capitol Building, better known as the Round House in local circles, to Room 336, which is on the third floor of the building. This case that we've got now should take about perhaps 10 or 15 minutes, and the ones who are interested only in Case 5377 I would suggest that you go ahead and proceed over to the Capitol Building and find Room 326.

Case 5369.

MR. DERRYBERRY: Case 5369. Application of Texas Pacific Oil Company, Incorporated, for an unorthodox location, Eddy County, New Mexico.

MR. RUSSELL: I'm John F. Russell, representing the Applicant, and I have one witness.

MR. PORTER: Are there any other appearances in this Case, anyone else desiring to make a case in 5369? You may proceed Mr. Russell.

(Witness sworn.)

WILLIAM C. YOUNG, III

called as a witness, having been first duly sworn, was examined and testified as follows:

DIRECT EXAMINATION

BY MR. RUSSELL:

- Q Will you please state your name, your residence, name of your employer, and the capacity in which you are employed?
- A My name is William C. Young, III, I live in Midland, Texas, am employed by Texas Pacific Oil Company as Development Engineering Supervisor.
- Q You have previously qualified to give expert testimony before this Commission, have you not?
 - A That is correct.
- Q Are you familiar with the Application in Case No. 5369?
 - A I am.

- Q Will you please explain what you are asking by this Application?
- A Texas Pacific seeks approval to drill our Tidwel
 No. 1 at a location 660 feet from the East line and 990
 feet from the South line, Section 22, Township 17 South,
 Range 26 East, Eddy County, New Mexico.

- Q In connection with this Application have you prepared some exhibits?
 - A Yes, I have three exhibits.
- Q I refer you to what has been marked as Applicant's Exhibit No. 1 and ask you to explain that Exhibit.
- A Exhibit No. 1 is a map showing the proposed location, proposed proration unit to be dedicated to the proposed well, ownership of offset acreage and wells which have been drilled through the Morrow sand.
 - Q Will you give the key of the various wells?
- A The red circles represent producing wells, the green dry holes, and the blue is a well in progress now; the depth yesterday morning was 2085 foot and drilling.
- Q And there are dry holes to the south and to the west and to the north, are there not?
 - A That is correct.

- Q And to what formation do you intend drilling this well?
 - A To the top of the Chester formation.
- Q Now, referring you to what has been marked as Applicant's Exhibit No. 2, would you explain that Exhibit?
 - A Item 2 is a base map with the same well notations,

the green for dry holes, red for producing wells, blue for wells not completed, and it is a structure map with contours, 100-foot intervals, based on the top of the Chester line.

- Q Now Exhibit No. 2 and Exhibit No. 3 are the same Exhibits which were used in Case No. 5330, which is an unorthodox location for the drilling well, by Order No. R-4881, is that correct?
 - A That is correct.
- Q Now referring you to what has been marked as Applicant's Exhibit No. 3, I'll ask you to explain what that Exhibit represents.

A Exhibit 3 is a net sand isopachus of the Morrow A sand which we call the Big Buck Ponds Morrow sand.

It's based on a porosity cut-off of 5 percent and our proposed location is picked to try to hit the center of the strand.

- Q The data, where did it come from?
- A The data came from what limited well control we have in the area.
 - Q Are there one or two wells?
- A Well, there is one well approximately a mile from the proposed location and there is another one

roughly a mile and a half and then other wells scattered several miles away.

- Q You do have a lease expiration date where this proposed location will be?
- A That is correct. We have a lease expiring in the Southease quarter, Section 22, on December 26th, and the mineral owner has refused to renegotiate this lease in any form or fashion.
- Q In your opinion, if this unorthodox location was not approved, you would not drill a well at a different location?
- A At the present time we would not drill a well at a different location.
- Q In your opinion, would a well at the proposed location better enable you to produce the gas underlying the proration unit?
 - A That is correct.
 - Q And what is the proration unit?
 - A The East half of Section 22.
- Q In your opinion, will approval of the Application give you the opportunity to produce your just and equitable share of the gas in the pool, will prevent the economic loss caused by the drilling of an unnecessary

well, avoid the augmentation of risk arising from drilling of an excessive number of wells, and will otherwise prevent waste and protect correlative rights?

It will.


