MR. STAMETS: The Hearing will please come to order. We'll call the next case, Case 5387.

MR. CAR<sup>n</sup>: Case 1387. Application of HNG Oil Company for an unorthodox gas well location, Lea County, New Mexico.

MR. JENNINGS: James T. Jennings of Jennings, Christy & Copple, appearing for HNG Oil Company, and I have one witness, Mr. Charles Tierce.

MR. STAMETS: Are there any other appearances in this Case? The Witness will stand and be sworn, please.

(Witness sworn.)

## CHARLES TIERCE

called as a witness, having been first duly sworn, was examined and testified as follows:

## DIRECT EXAMINATION

#### BY MR. JENNINGS:

- Q Would you state your name and occupation, please, sir?
  - A Charles Tierce, Geologist, HNG Oil Company.
- Q Mr. Tierce, have you appeared and testified before this Commission many times in the past?
  - A Yes, I have.
  - Q Have your qualifications been accepted?

MR. STAMETS: Where are you located, Mr. Tierce?

MR. TIERCE: Midland, Texas.

MR. STAMETS: Thank you. Yes, the Witness is qualified.

## BY MR. JENNINGS:

Q Mr. Tierce, HNG Oil Company has made an application of unorthodox location in the Dogie Draw Unit.

Are you familiar with this Application?

- A Yes, I am.
- Q Basically, was is the reason for this request for an unorthodox location?

A Our big objection to a 198660 location would be that a deviation of 1.8 degrees from the surface to 22,000 foot would put us across the lease line and we think it would be a lot cheaper in the drilling of this hole to move it back 1325 from the south and west. Economics is the big reason.

- Q What is the actual location of this well?
- A 1325 from the south and west.
- Q Have you drilled other wells in the Dogie Draw Unit?
  - A We are currently trying to complete the Dogie

Draw No. 1 in Section 8, 1980 from the south and west location. This morning we were jetting water, which was load water out of the Devonian. We expect to make it a Devonian gas well.

- Q What is your objective depth in this well?
- A 22.000 feet to the Ellenburger.
- Q Do you anticipate the possibility of the problem of getting beyond the lease lines if you use the normal gas well spacing location?

A If the hole should deviate toward the lease line
I think it would be almost impossible to keep it from it.
It would be very expensive at the least.

Q Referring to what has been marked as Exhibit 1, Mr. Tierce, where is this well located with reference to the outside boundaries of the unit?

A Section 5 is the northeasternmost section, so we would be about three-quarters of a mile from the east line and the same from the north line.

- Q And those are the closest offset operators?
- A Yes
- Q Do you feel that this will in any way impair the correlative rights of any of the offset operators?

A No, sir.

- Q Would this be in the interests of conservation and prevent waste?
  - A Yes, sir.
- Q Was Exhibit No. 1 prepared by you or under your supervision?
  - A Yes, it was.

MR. JENNINGS: We have nothing further and we would offer it to the Commission.

MR. STAMETS: Exhibit No. 1 will be admitted.

(Whereupon, HNG's Exhibit

No. 1 was admitted into evidence.)

## CROSS EXAMINATION

#### BY MR. STAMETS:

- Q Mr. Tierce, talking about this well potentially getting off the lease are you talking about the lease that's located on Section 5 or the Dogie Draw Unit?
  - A No, the lease in Section 5.
- Q So what you're worried about would be drifting off into Section 6 or 7 or down into 8?
- A Yes, sir. Primarily in 6 or 8 if we went standard locations.
- Q And you don't wish to locate it at a standard gas location, say 1980 from the south and west, because

that would tend to out you off structure?

A It would put us off somewhat. Our biggest concern would be the fault that we show on the east side.

We think it does hade and it is a reverse fault; hades back to the west. If this were the case, by the time we get to the Ellenburger we could cut that fault and go on the down side.

Q I expect Devonian gas, and we expect Ellenburger gas as well?

A We did test Ellenburger in the No. 1. We recovered nothing really; it was just tight, so we would like to drill another well to that formation.

Q At that depth the normal expectation would be gas?

A Yes, it would. We think also by moving to the west that we have a better chance in the Devonian. We think the Devonian porosity is getting better to the west, but primarily it's the fault that concerns us.

# REDIFECT EXAMINATION

BY MR. JENNINGS:

Q What acreage are you going to dedicate to this proposed well, Mr. Tierce?

A Section 5.

- Q The South half of Section 5?
- A All of it.
- q I think you have to dedicate the South half at this time; we don't have special pool rules.
  - A I'm sorry. Yes, it would be the South half.

MR. STAMETS: I assume if you get a well you will be in here for 640-acre spacing.

Any other questions of this Witness? He may be excused. Anything further in this Case?

MR. JENNINGS: We have nothing further.

MR. STAMETS: We will take the Case under advisement.
