MR. TUCKER: I'm Steven Tucker, Post Office Box 1537, Santa Fe, New Mexico, appearing on behalf of David C. Collier, and I have one witness to be sworn. MR. STAMETS: He will stand and be sworn, please.

(Witness sworn.)

# N. RAYMOND LAMB

called as a witness, having been first duly sworn, was examined and testified as follows:

# DIRECT EXAMINATION

- Would you please state your name, where you are BY MR. TUCKER: Q employed, and in what capacity?
  - N. Raymond Lamb, I'm a consultant in Geological Engineering from Artesia, New Mexico.
  - Have you made a study of and are you familiar with the facts surrounding this particular Application

by David Collier?

A Yes I have.

Q Have you previously testified before the Oil Conservation Commission and had your qualifications as an expert witness accepted and made a matter of record?

A I have.

MR. TUCKER: If the Examiner please, are the Witness qualifications acceptable?

MR. STAMETS: They are.

### BY MR. TUCKER:

Q Would you please state the purpose of this Application?

A The Application is for permission to produce an unorthodox location 2330 feet from the east line and 1980 feet from the south line of Section 33 of 18, 28, Eddy County, New Mexico, so that the well may have an allowable and be produced.

Q Is the proposed location unorthodox because of statewide rules requiring it to be 330 feet from the boundary lines of the tract?

A Yes. The location now is 310 feet from the east line of the 40-acre tract, and the events leading up to this particular situation was that on December the 16th,

Dave Collier spudded the No. 1 Kersey at a legal location 330 feet from the east line and they drilled to about 1250 feet and lost the hole, which required the skidding of the and due to physical circumstances at the rig site the decision was made at the rig to move the location 20 feet east, apparently not knowing that this would make an illegal unorthodox location. The well then was drilled to a total depth of 2820 feet, ran 5-1/2-inch casing, perforated the San Andres Formation, top of the perfs 2654, and the bottom is 2782. Upon application for an allowable it was noticed that this 20 feet set the location as an unorthodox location and could not be produced without approval of the Commission.

- Both of the Exhibits were prepared by one of was that prepared by? the owners of the property and due to serious illness in the family he was called out of town and I was asked to take his place. I have examined the Exhibits and from my own knowledge I know that they are reliable and accurate even though they were prepared by Mr. Gleason. Referring to Exhibit No. 1 can you tell us what
  - information it contains?

Well, it is a contour map showing the structural position of the Queen Formation in this particular area showing small hives and then re-entry from the north, and it shows that it is favorably or relatively close in structure to the east offset, which is the nearest producing well at this time. I could point out at this time that

is the owner of the well to the ease, which is 970 feet away, and I personally have contacted Mr. grumb of Depco in Denver and they verbally gave me the expression that they had no objection and they had full knowledge of the situation and that they would not appear or have any objections.

- Okay. I refer you to Exhibit No. 2. Explain Q what information that contains.
- It is a more detailed footage measurement as to the abandoned location and the location which was drilled, which is now the No. 1-Y Kersey.
- Why does the Applicant want to drill the well at the unorthodox location instead of the standard location?
- Well, the standard location was the normal location, and having lost the hole at the legal location site they skidded the rig and the circumstances, as I have been able to put them together were this: They had instructions

to move the location west by 20 feet, but due to the fact that all rigs put their pits normally on the west side or on the north side, and the fact that they had insufficient physical equipment like trucks to move the rig around the pits, they made the decision on the ground to move it 20 feet to the east, which developed the unorthodox location 310 feet from the line.

- Q In your opinion would approval of this Application be in the best interests of conservation, the prevention of waste and protection of correlative rights of others?
- A It would let Mr. Collier produce oil that would not otherwise be produced; I'm sure that he would not be interested in drilling another well on this same 40-acre tract.
  - Q Do you have anything you would like to add?
- A In view of the fact that the well was perforated on January the 4th of 1975, the operator has been shut-in from lack of allowable because of the unorthodox location. He would appreciate any effort from the Commission to have an early decision in this matter.

MR. TUCKER: We would move at this time admission of Exhibits 1 and 2, and I have no further questions of the Witness.

Mr. Stamets: Without objection Exhibits 1 and 2 will be admitted into evidence.

(Whereupon, Applicant's

Exhibits 1 and 2 were admitted into evidence.)

### CROSS EXAMINATION

### BY MR. STAMETS:

Q Mr. Lamb, would you say that the rig was skidded in this location in error?

A I think that would be a fair statement. I know that Mr. Collier tells me that his instructions were to move it west, but with the physical equipment they had, the moving around the pits they elected on the ground to move it 20 feet to the east and spud and drill the well, and I think that to say it was in error would be correct.

- Q To require Mr. Collier to drill another well at standard location would be rather an expensive proposition?
  - A Yes.
  - Q Would that recover any more oil?
- A It would not recover any more oil, and it is my opinion that the well completed and produced from this 310 feet from line would not be in violation of correlative

rights so far as Depco is concerned because this was their expression to me.

MR. STAMETS: Any other questions of this Witness? He may be excused. Anything further in this Case?

MR. TUCKER: No.

MR. STAMETS: We will take the Case under advisement.

- (2) That the applicant, David C. Collier, seeks approval of an unorthodox oil well location for his Kersey Well No. 1-Y drilled 1980 feet from the South line and 2330 feet from the West line of Section 33, Township 18 South, Range 28 East, NMPM, Artesia Pool, Eddy County, New Mexico.
- (3) That the NE/4 SW/4 of said Section 33 is to be dedicated to the well.




