JOHN SOMERS

called as a witness, having been first duly sworn, was examined and testified as follows:

DIRECT EXAMINATION

BY MR. KELLAHIN:

Q Mr. Somers, would you state your name, by whom you're employed, and in what capacity?

A John Somers. I'm employed by Petro-Lewis
Corporation as the Denver Division Manager.

Q Have you previously testified before this

Commission, and were your qualifications as an expert witness

accepted and made a matter of record.

- A Yes, I have.
- Q Have you made a study of and are you familiar with the facts surrounding this particular Application?

A Yes, I am.

MR. KELLAHIN: Mr. Examiner, please, are the witness' qualifications accepted?

MR. STAMETS: They are.

BY MR. KELLAHIN:

Q Mr. Somers, would you refer to what has been marked as Applicant Exhibit No. 1, identify it and state briefly what Petro-Lewis is seeking?

A Exhibit No. 1 is a map of the southwest Media fields showing the location of Entrada Wells, and other shallower wells in the area. It also shows the proposed unorthodox location in the northeast quarter of section 22, Township 19 North, Range 3 West. That location would be 1980 feet from the east line and 1335 feet from the north line of that section.

Q Has the non-standard proration unit been a subject of a previous hearing before this Commission, and has the Commission entered its Order of Approval?

A Yes, it has.

- Q You are now seeking the unorthodox well location to drill upon this non-standard provation unit?
 - A That's correct.
- Q Please refer to what has been marked as Exhibit No. 2, and identify it?

A This is a structure map on top of the Entrada

Formation, which is the principal producing formation in the southwest Media field where the proposed unorthodox well location is to be, and it shows that the Miller Federal 722, which is the well to be drilled in that non-standard drilling unit, is located at the optimum structural location.

Q Please refer to what has been marked as Exhibit 3, and identify it?

A Exhibit No. 3 is a net-pay isopack of the Entrada sand. This also shows the location of the proposed unorthodox well, it's off a little bit. It should be south of the line, but it's shown as actually a little bit north of the line. It's showing that the location would be at the thickest point in the southwest Media Reservoir.

Q In your opinion, Mr. Somers, will a well drilled at this particular location be the optimum location from which to economically and efficiently drain the proposed unit?

- A Yes, it will.
- Q In your opinion, will the approval of this Application be in the best interests of conservation and prevention of waste and the protection of correlative rights?
 - A Yes, it would be.
- Q Did you prepare or were these prepared under your direction and supervision, Exhibits 1, 2, and 3?
 - A Yes, they were.

MR. KELLAHIN: Mr. Examiner, please, we move the introduction of those exhibits.

MR. STAMETS: Exhibits 1, 2, and 3 will be admitted into evidence.

(Whereupon, Applicant's Exhibits

1, 2, and 3 were admitted into evidence.)
