

I recently learned from your telephone measage to our office that you had completed plugging operations and abandonment on your #1 Button well in the 35 17-298-13%.

On june 29, 1954 I made an inspection trip to this well and from all outward appearances I see no reason why your plugging operation was not satisfactory. However, no form C-103 has been filed indicating that the coment plug was set below the water sand, at which point you were completing the well as a water well. I would like to briefly review the situation concerning the plugging of the above captioned well, and point out to you the necessity of immediately completing the plugging of this well.

In August, 1953, you were notified by R. R. Spurrier, Director of the Oil Conservation Countssion in Senta Fe to immediately take steps to plug this well or the Oil Countssion would take steps to call an open hearing for the purpose of having both you and the banding company show cause why the well should not be plugged. A makine or intention to do this work had been filed with our office on December 22, 1952 by Mr. Sen J. arson, who signed as your agent. The plugging program was approved by this office on December 22, 1952. Finally, late in August, 1953, Mr. Cayeon moved a crew to the rig and coment with which to do the plugging job. I made a personal inspection of the lease at that time and saw that proparations were being made to plug. This 25-each plug was counted in the Pictured Cliffs formation, extending into the production caping. However, this information has never been formally filed with this office. It was plearned by personal inspection and conversation with Mr. Careon. Mr. Careon also stated that he wished to release the well to Kr. Hutton, the landowner, as a water well. This could be done, providing form C-103 was filed abouting that the Pictured Cliffs sandstone was plugged and providing Mr. Batten accepts responsibility for the well in writing. In the event that he will not accept responsibility, then a cement plug must be placed in the surface with heavy mud between plugs and a 4" marker left extending four feet above ground level.

Unless some action is taken within the next 7 days we will take steps to initiate a hearing before the Oil Conservation Commission in Santa Fe to have you and the bonding company show cause why the well should not have the plugging job finished.
