APPLICATION FOR REHEARING

Come now applicants, Schermerhorn Oil Corporation and J. H. Moore, by their attorneys, Campbell & Russell, and apply to the Commission for a rehearing in the above styled matter, and as their reasons therefor state:

1. Applicant Schermerhorn Oil Corporation is the owner and operator of a gas well in the Eumont Gas Pool situated in the SW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 12, Township 21 South, Range 36 East, and is the owner and operator of contiguous acreage consisting of the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of said Section 12. An 80-acre allowable is presently being attributed to its Carter Unit #1 well on such 80-acre tract.

2. Applicant J. H. Moore is the owner of an interest in a well situated in the SW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 7, Township 21 South, Range 36 East, and is also the owner of an interest in the Carter Unit #1 well hereinabove described.

3. Order No. R-622 entered in the above styled matter is erroneous in the following respects:

(a) The order entered is contrary to the purposes and intent of Order No. R-520 as previously entered by the Commission as it affects the Eumont Gas Pool inasmuch as it isolates small tracts within the limits of a standard gas proration unit.

(b) The Texas Company failed to use reasonable efforts to secure approval from royalty interests underlying the proposed unit to the pooling of said royalty interests with the acreage of Schermerhorn and Moore to form a larger gas proration unit, and Finding No. (7) of the Commission is therefore erroneous and unreasonable.

(c) It is practical and equitable to force the pooling of The Texas Company unit acreage with the acreage of Schermerhorn and Moore as above described, and Finding No. (8) is therefore erroneous and unreasonable and arbitrary.

4. Order No. R-622 deprives applicants of their property without due process of law.

WHEREFORE, applicants request a rehearing in Case No. 855 before the Commission.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on March 16, 1955, at Santa Fe, New Mexico, before the Oil Conservation Commission, hereinafter referred to as the "Commission".

NOW, on this 20th day of April, 1955, the Commission, a quorum being present, having considered the records and testimony adduced, and being fully advised in the premises,

FINDS:

(1) That due notice of the time and place of hearing and the purpose thereof having been given as required by law, the Commission has jurisdiction of this case and the subject matter thereof.

(2) That pursuant to the provisions of Rule 5 (a) of Order No. R-520, the Commission has power and authority to permit the formation of a gas proration unit consisting of other than a legal section after notice and hearing by the Commission.

(3) That applicant, The Texas Company, is owner of an oil and gas lease in Lea County, New Mexico, the land consisting of other than a legal section, and described as follows:

TOWNSHIP 21 SOUTH, RANGE 36 EAST, NMPM
E/2 SW/4 and S/2 SE/4 of Section 12

containing 160 acres, more or less.

(4) That applicant, The Texas Company, has a producing gas well on the aforesaid lease, known as the Roy Riddel, Well No. 1, located 660 feet from the south line and 1981 feet from the west line of Section 12, Township 21 South, Range 36 East, NMPM, Lea county, New Mexico.

(5) That the aforesaid well is located and completed within the horizontal and vertical limits of the Eumont Gas Pool.

(6) That Schermerhorn Oil Corporation, the owner of adjoining acreage in the said Section 12, has specifically protested and objected to the proposed proration unit of 160 acres applied for by the applicant.

(7) That the applicant herein, The Texas Company, has attempted to secure approval from the royalty interests in the above-described acreage to pool or communitize the aforesaid acreage with that of the Schermerhorn Oil Corporation, without success, and therefore

(8) That it is impractical to force the pooling of applicant's said lease with adjoining acreage in said Section 12.

(9) That unless a proration unit consisting of applicant's aforesaid acreage is permitted, applicant will be deprived of the opportunity to recover its just and equitable share of the natural gas in the Eumont Gas Pool, and

(10) That creation of a proration unit consisting of the aforesaid acreage will not cause but will prevent waste, and will protect correlative rights.

IT IS THEREFORE ORDERED:

(1) That the application of The Texas Company for approval of a non-standard gas proration unit consisting of the following described acreage:

TOWNSHIP 21 SOUTH, RANGE 36 EAST, NMPM
E/2 SW/4 and S/2 SE/4 of Section 12

be and the same is hereby approved, and a proration unit consisting of the aforesaid acreage is hereby created.

(2) That applicant's well, Roy Riddel Well No. 1, located 660 feet from the south line and 1981 feet from the west line of Section 12, Township 21 South, Range 36 East, NMPM, Lea County, New Mexico, shall be granted an allowable in the proportion that the above described 160-acre unit bears to the standard or orthodox proration unit for said pool, all until further order of the Commission.

Gentlemen:

Reference is made to the application submitted by The Texas Company in their letter dated February 7, 1955 to form a 160 acre non-standard gas proration unit for the above captioned well. In this letter a request was made to Schermerhorn Oil Corporation for a waiver so that the Oil Conservation Commission might grant an administrative non-standard gas proration order on this application.

* Please be advised that Schermerhorn Oil Corporation objects to the formation of the unit as proposed by The Texas Company and requests that an administrative order not be granted in this case. This Company objects to The Texas Company application for the following reasons:

(a) If the unit is allowed for this well as proposed by The Texas Company this will cause a well spacing wherein three wells will be located in the North Half of the Section and only one in the South Half of the Section. This will cause unequal drainage and not protect the correlative rights of the royalty owners.

(b) In case this unit is allowed the Mid-Continent Petroleum Corporation lease comprising the East Half Southwest Quarter will be left isolated so far as combining with acreage in this Section to form larger than an 80 acre unit. This will leave no other alternative than for Mid-Continent to request an order for a unit which will include land outside of the Section in order to form a unit larger than 80 acres.

- 2 - New Mexico Oil Conservation Commission, 2-14-55.

(c) If The Texas Company unit is allowed as proposed the Schermerhorn Oil Corporation Carter Unit comprising the Southwest Quarter Northeast Quarter and Northwest Quarter Southeast Quarter of this Section will be left isolated with no available acreage with which to form a unit larger than 80 acres.

(d) Schermerhorn Oil Corporation has written The Texas Company asking that they combine part of their acreage with the Carter Gas Unit so that a regular spacing gas unit might be formed in the North Half of the section.

(e) Since the allowable is based on acreage with the regular unit allowable being assigned to 160 acres it is not equitable to allow units to be formed in a section which will leave isolated tracts with less than 160 acres available for allowable allocation.

We, therefore, request that you please refuse to grant the non-standard gas proration unit as proposed by The Texas Company for the above reasons.

Gentlemen:

By this letter of application The Texas Company wishes to form a 160-acre non-standard gas proration unit in the Eumont Gas Pool under Rule 5 (b) of Order R-520, and to state the following:


- (a). That The Texas Company's Roy Riddel Well No. 1, located in the center of the SE Quarter SW Quarter of Section 12, T-21-S, R-36-E, Lea County, New Mexico, was completed on January 18, 1953, as a gas well in the Queen pay of the Eumont Gas Pool. The attached gas well plat, Exhibit "A", shows the location of this well on The Texas Company's Roy Riddel Lease and all other gas wells in Sections 12 and 13 of T-21-S, R-36-E, and Sections 7 and 18 of T-21-S, R-37-E.
- (b). That the subject well is completed in the Queen pay, which is within the vertical limits of the Eumont Gas Pool, as designated by Order R-520.
- (c). That this well was drilled as an orthodox location prior to the enactment of Orders R-370 (a) and R-520, and since it was drilled before the effective date of Order R-520 it should be considered as a location in conformance with Rule 2 of Order R-520.

- (d). That the subject well has been assigned an 80-acre gas allowable, which was considered to be the E/2 of the SW/4 of Section 12, T-21-S, R-36-E.
- (e). That the non-standard gas proration unit consists of portions of contiguous quarter quarter sections and that the non-standard gas proration unit lies wholly within a single governmental section.
- (f). That the entire non-standard gas proration unit may be reasonably presumed to be productive of gas from the Eumont Gas Pool. This gas production is shown by other wells in the attached exhibit which are the Dalport McQuatters Well No. 1, the Schermerhorn Carter No. 1, and the Tide Water Marshall "D" Well No. 1.
- (g). That the length or width of the gas proration unit does not exceed 250 feet. That the 160-acre non-standard gas proration unit proposed is wholly contained within extensions previously made in the Eumont Gas Pool.
- (h). That by copy of registered letter, The Texas Company is requesting waivers of Schermerhorn, Dalport and Mid-Continent under Paragraph 5 (a) of Rule 5 (b) of Order R-520 and Continental and Tide Water under Paragraph 5 (b) of Order R-520. These offset operators are being notified and requested to send one executed copy of the waiver to you and to return one copy of the waiver to The Texas Company.

This application is to form a 160-acre non-standard proration unit around The Texas Company's Roy Riddell Well No. 1, to consist of the E/2 SW/4 and S/2 SE/4 of Section 12, T-21-S, R-36-E, Lea County, New Mexico. The Texas Company therefore requests the Oil Conservation Commission to grant an administrative non-standard proration order under Rule 5 (b) of Order R-520, as soon as waivers are received under Paragraph 5 (a) and (b) of Rule 5 (b), from Continental, Tide Water, Schermerhorn, Dalport, and Mid-Continent.


